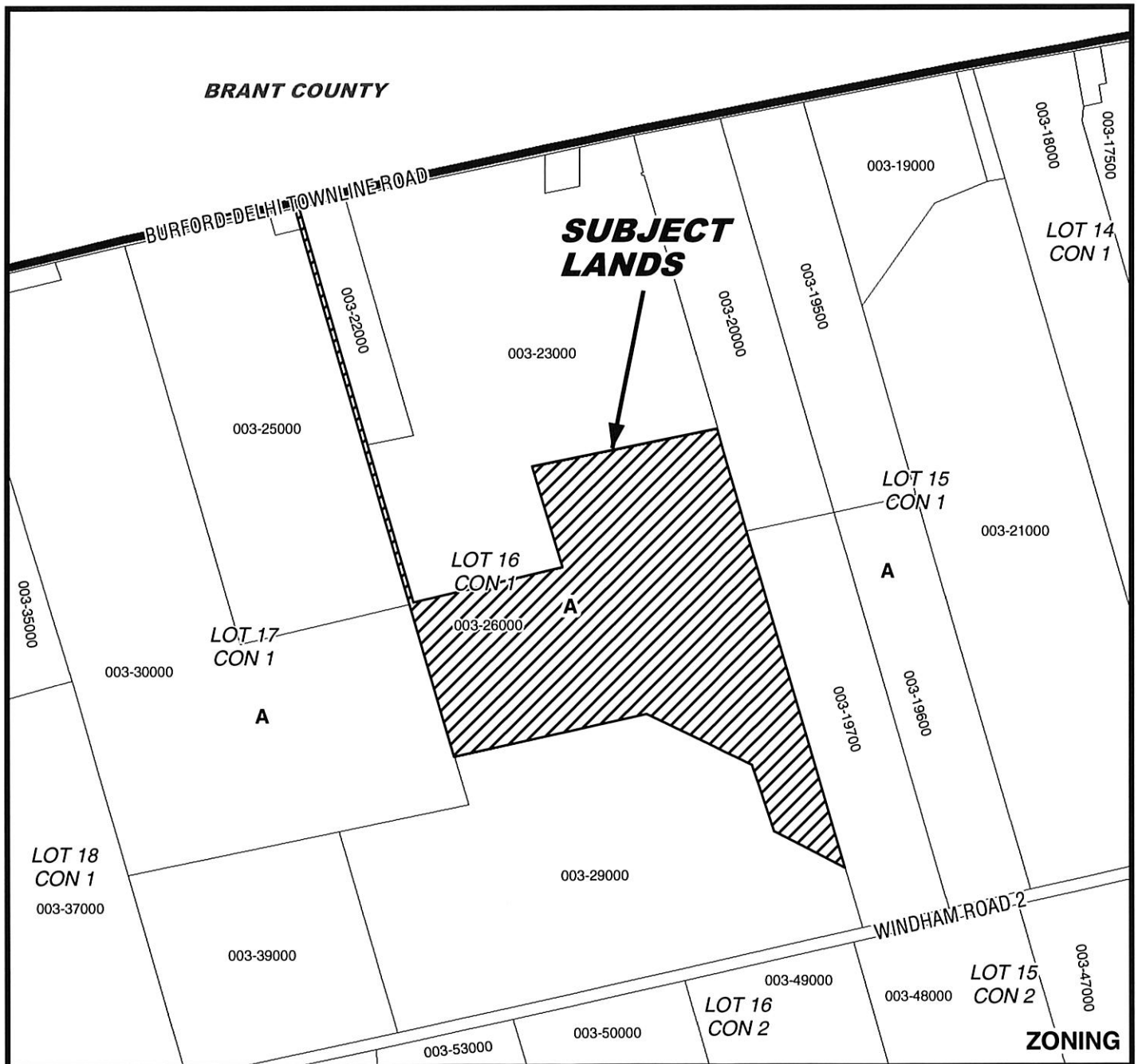

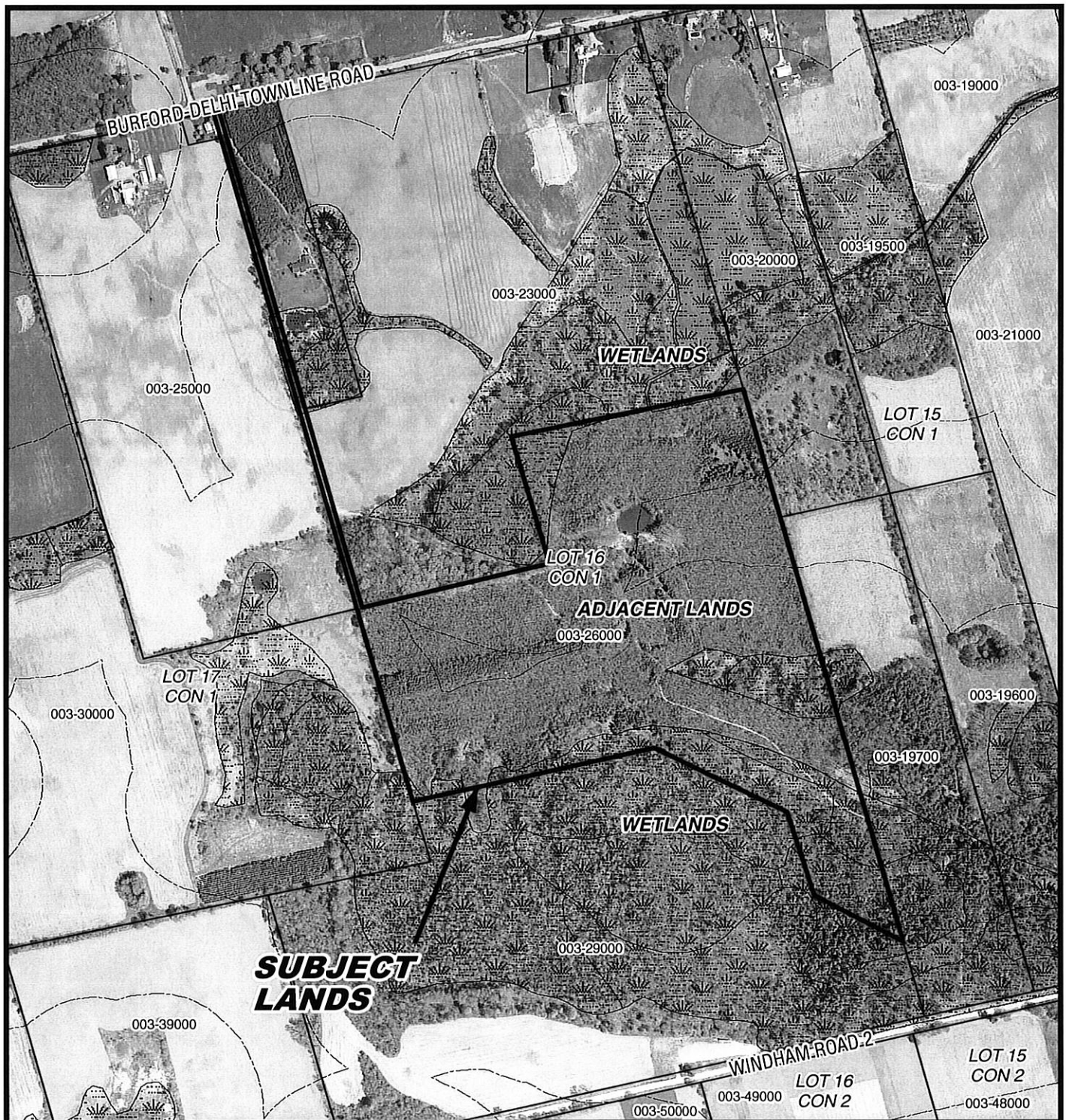

LOCATION OF LANDS AFFECTED

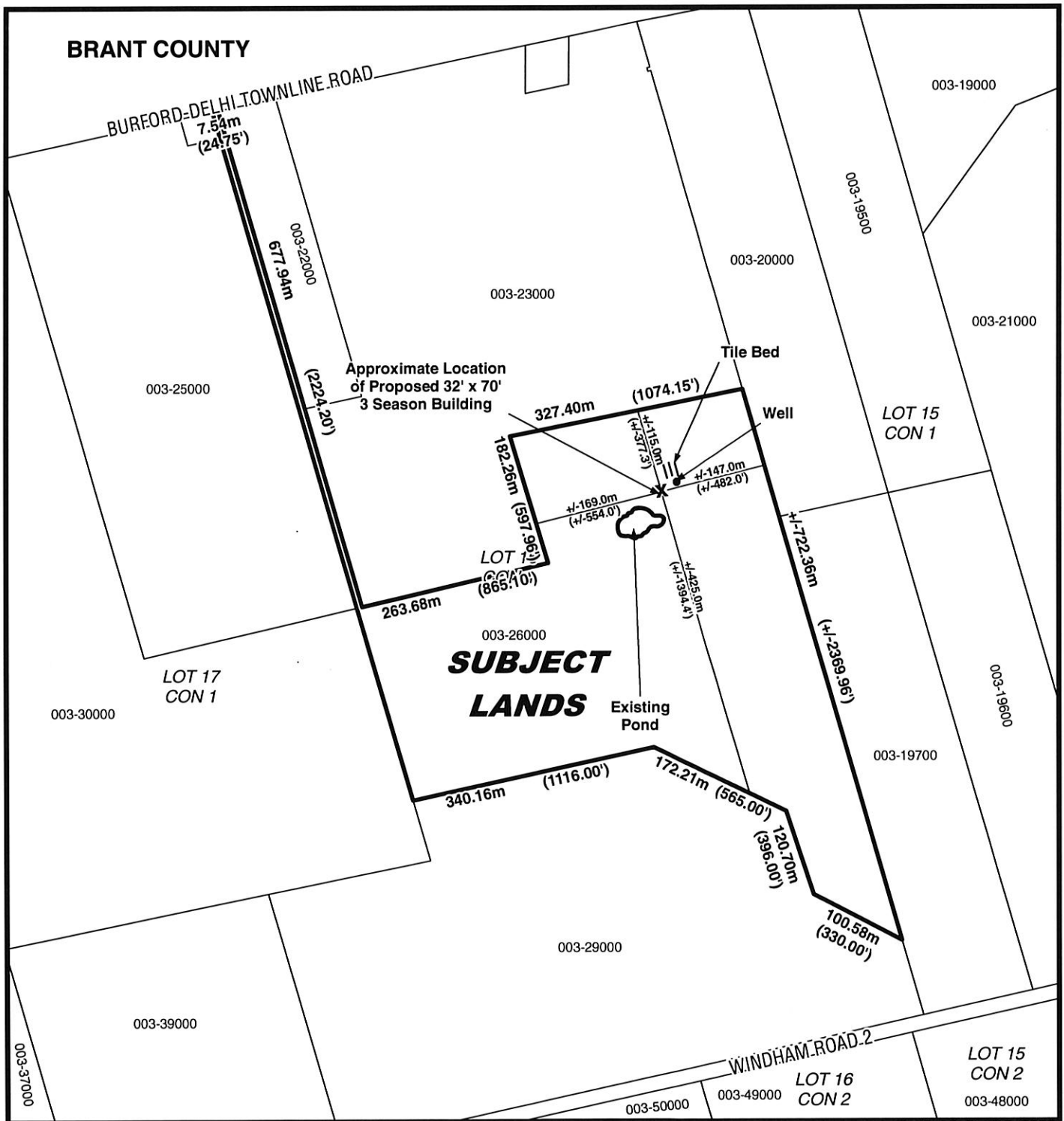
