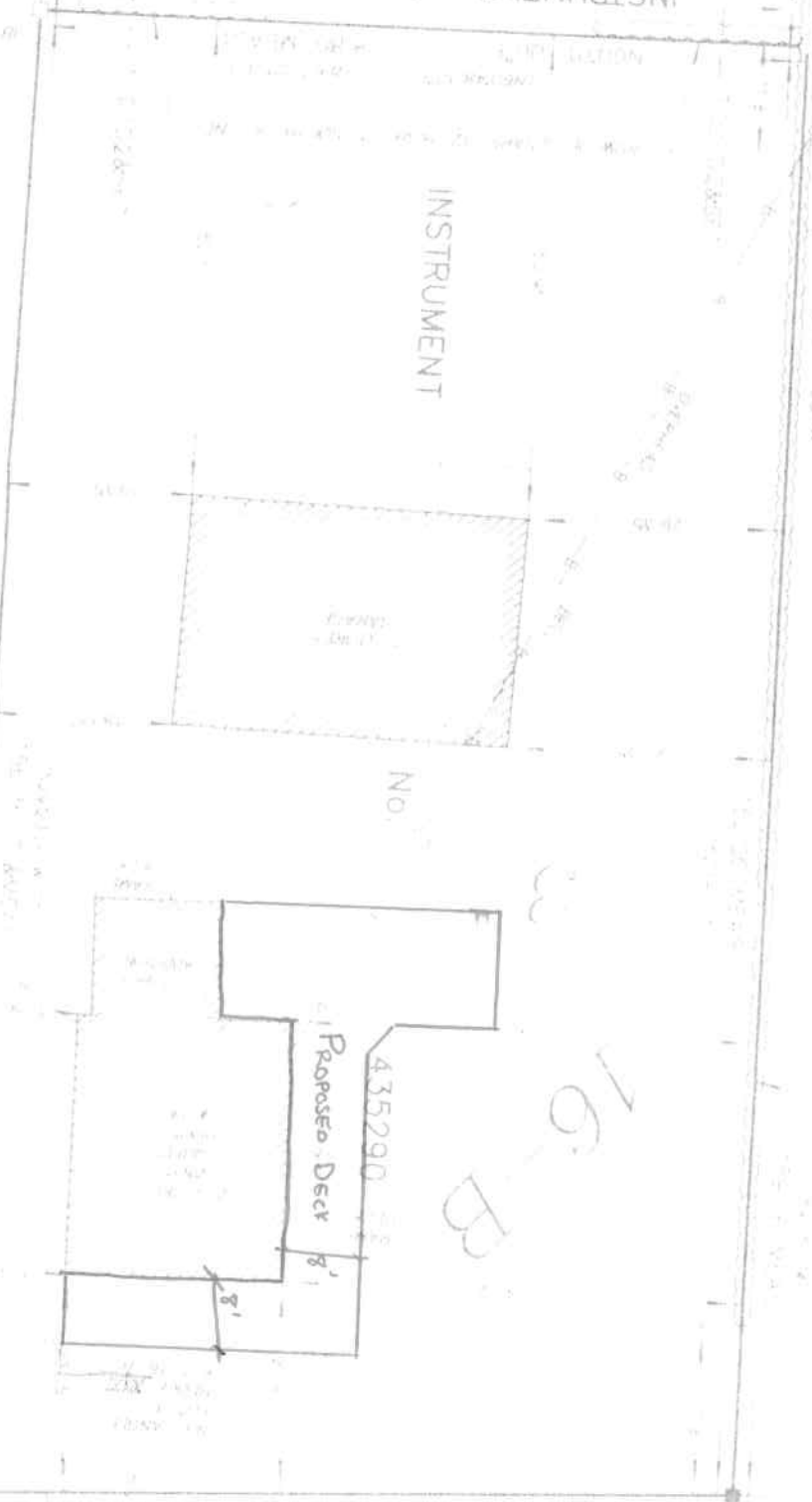

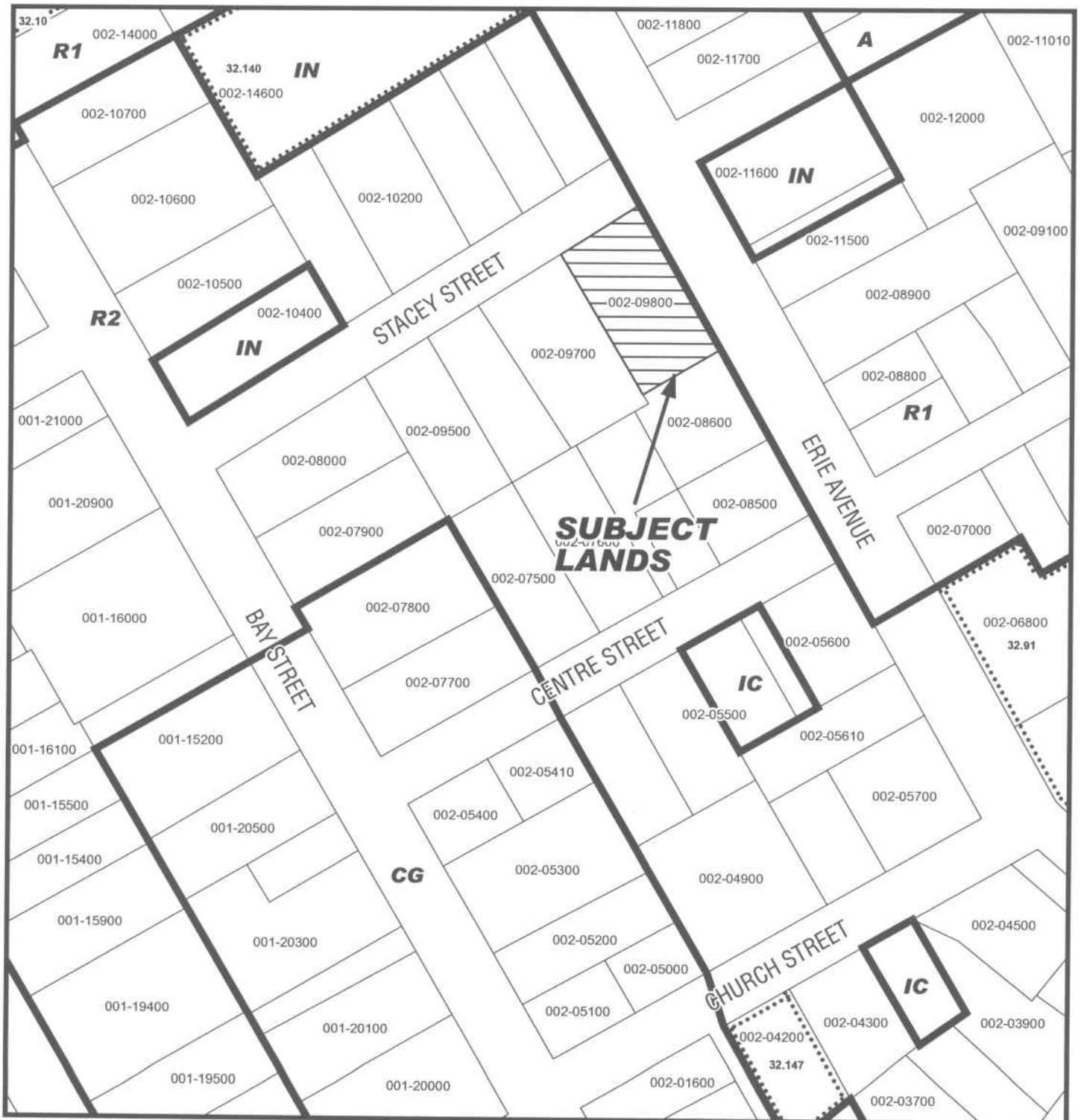
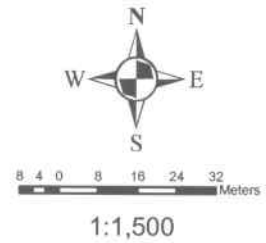
Urban Area of PORT ROWAN

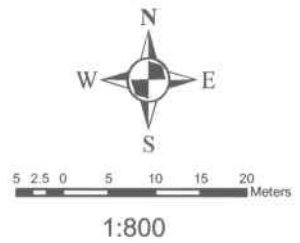
