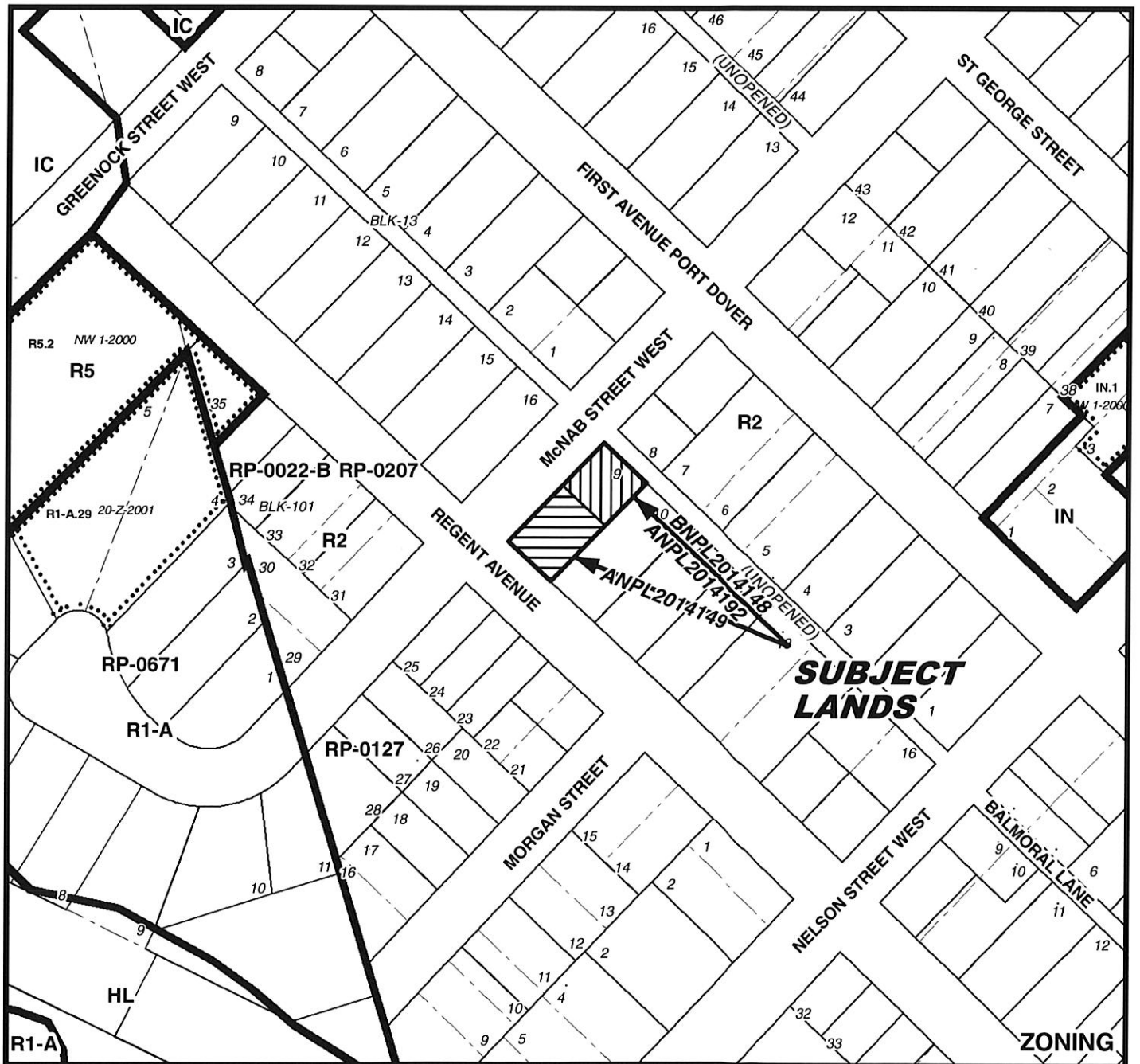

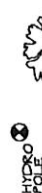

REGISTERED PLAN 207**

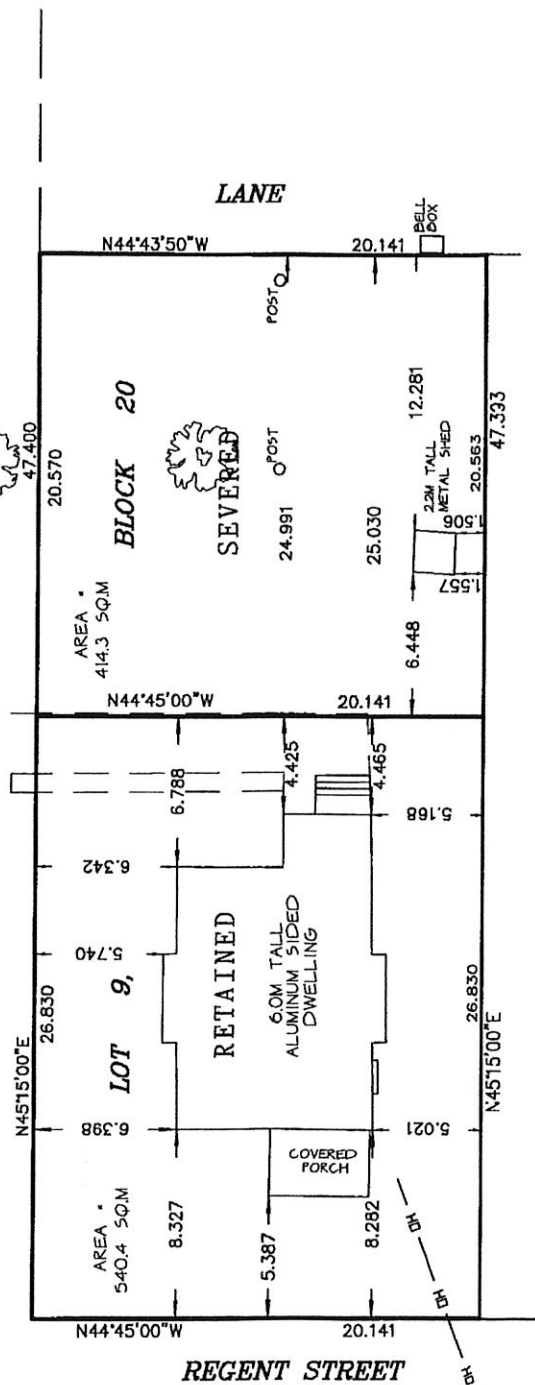
