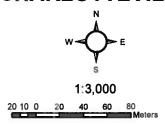

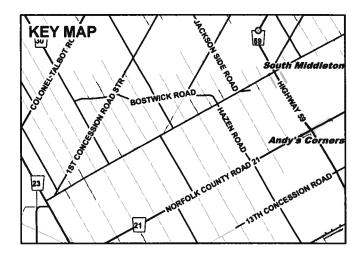
MAP 1

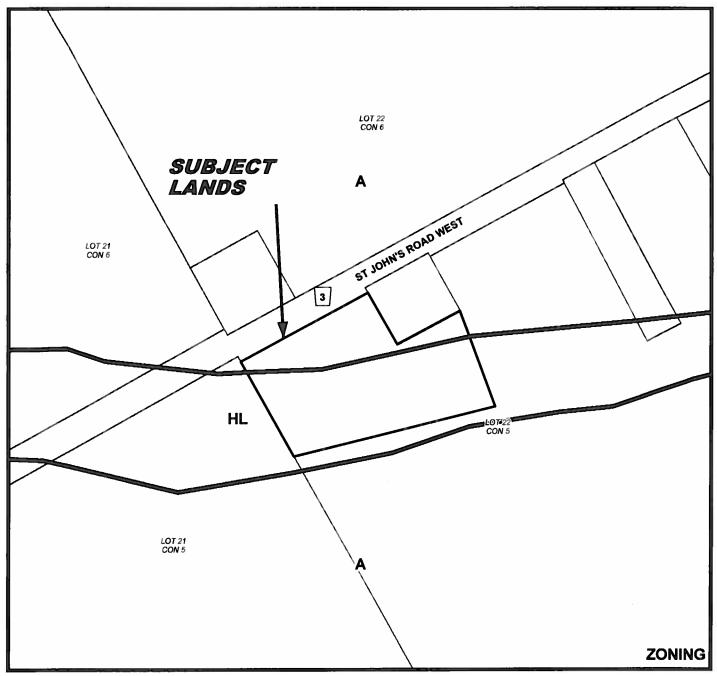
