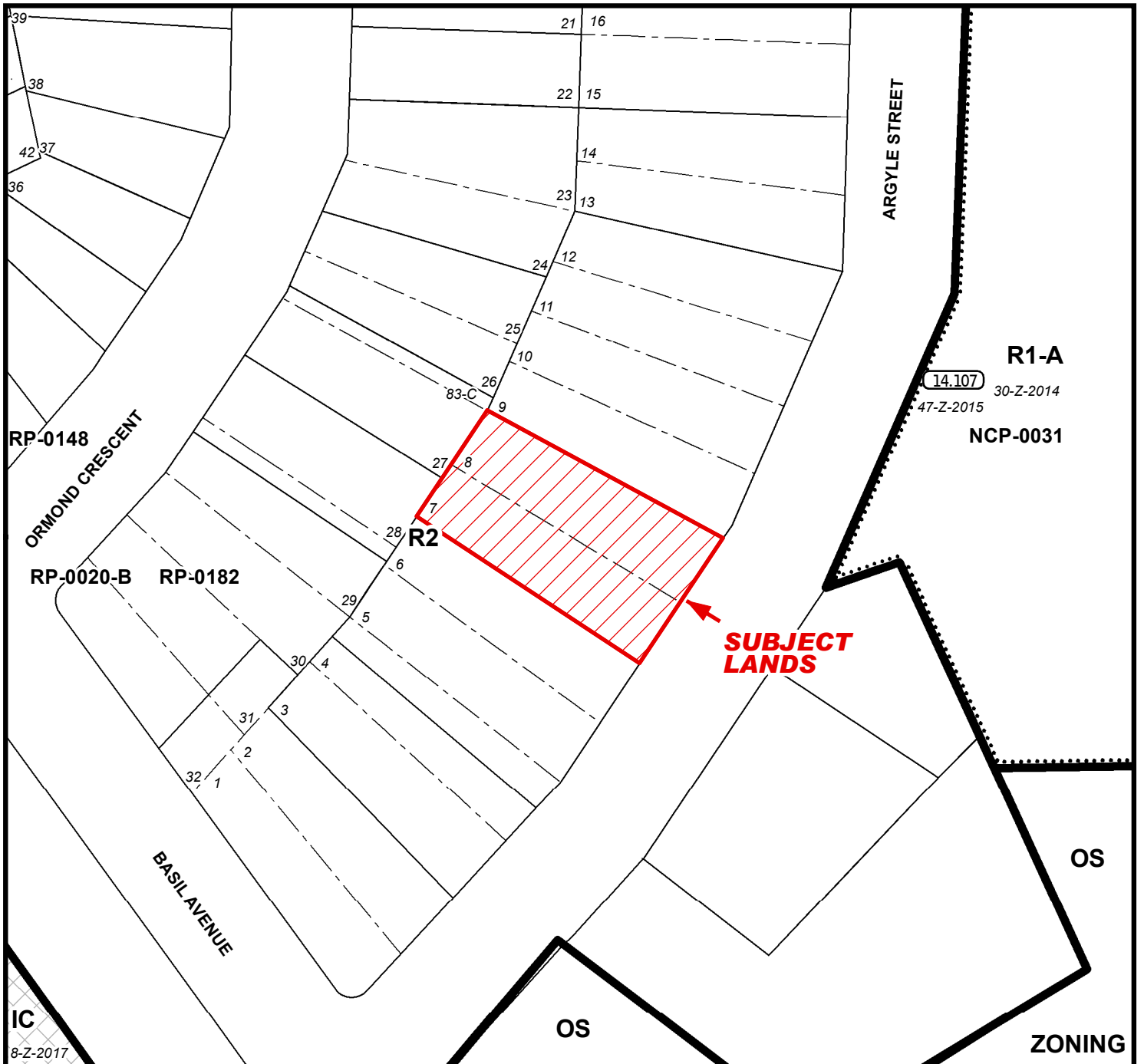

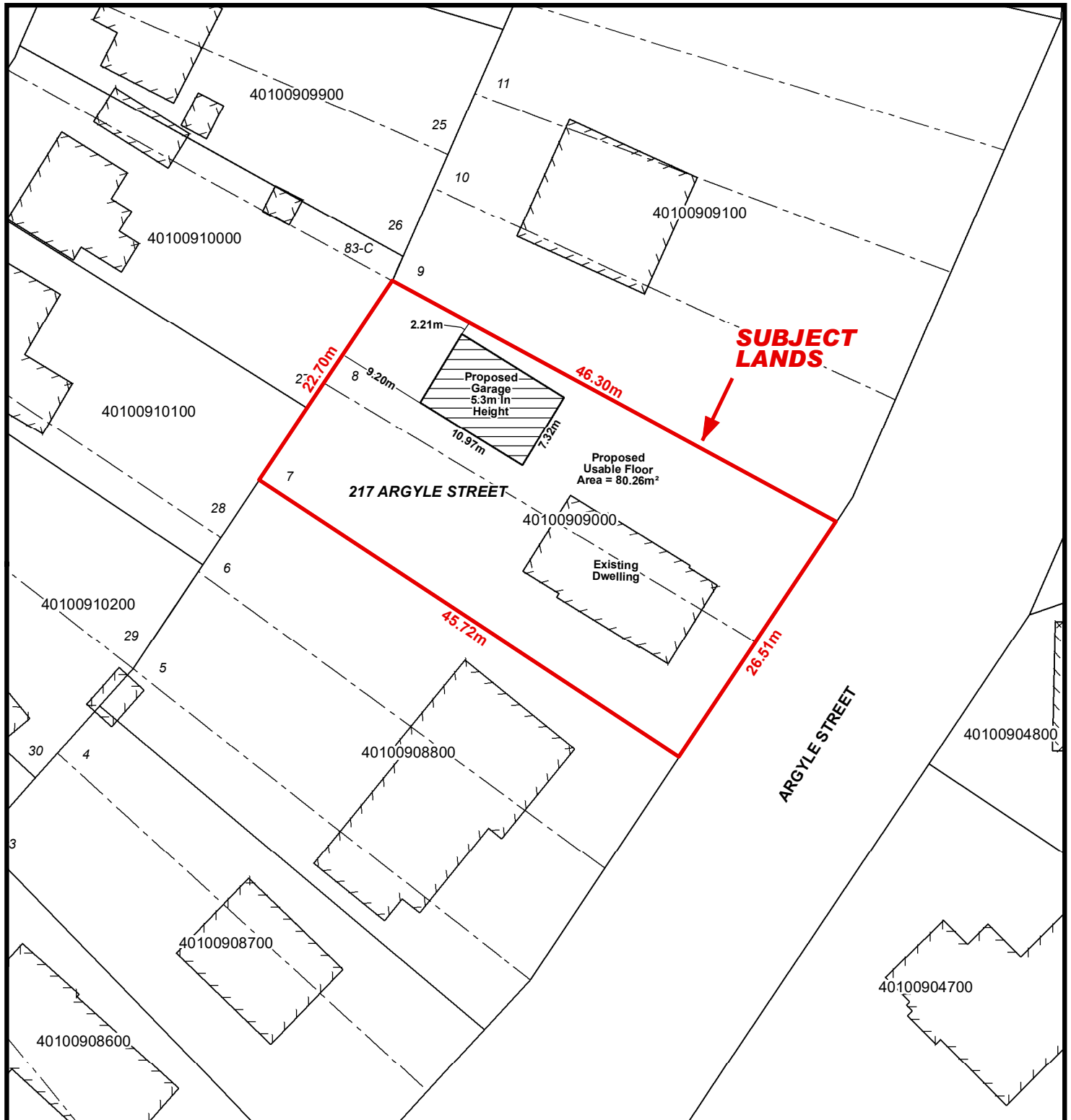
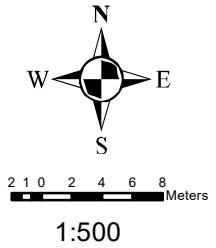
Urban Area of SIMCOE
