

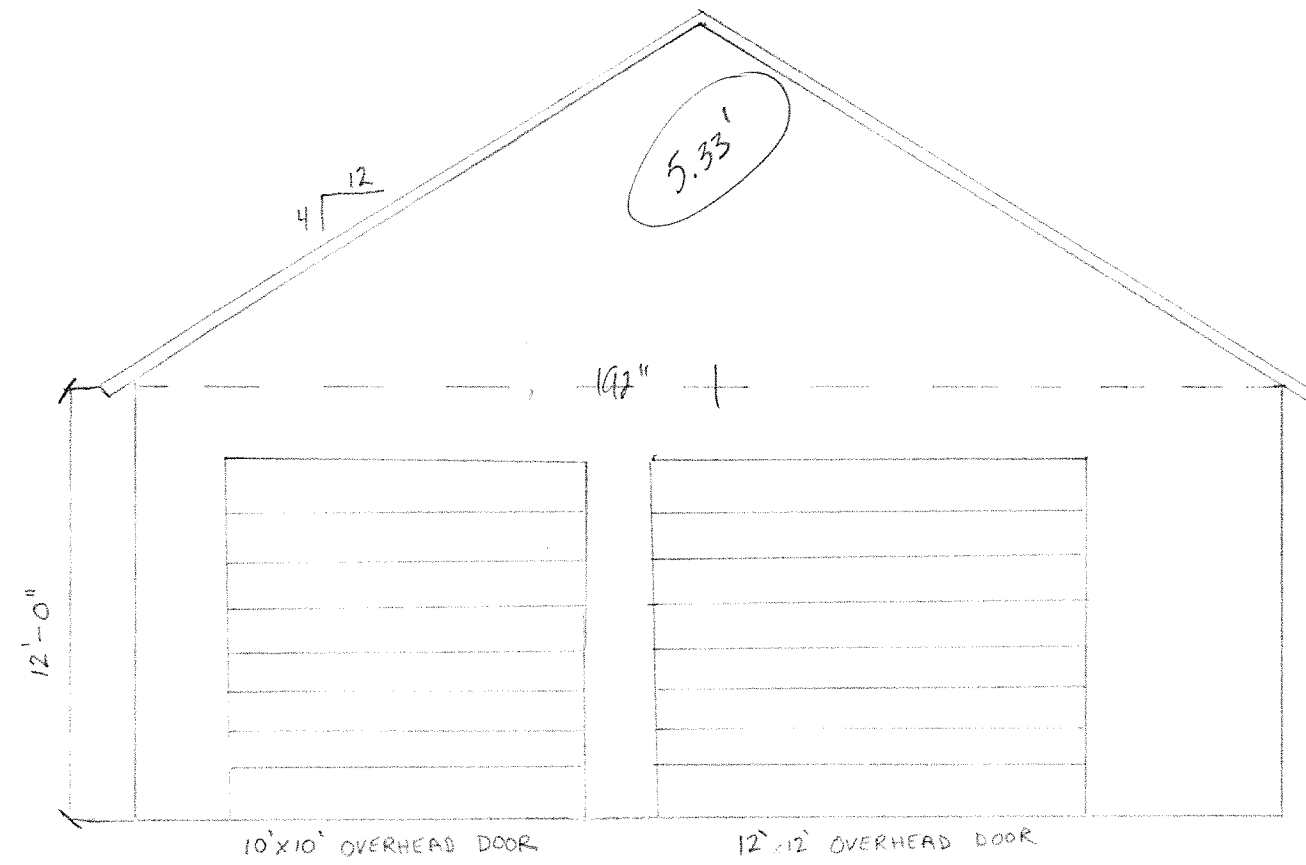

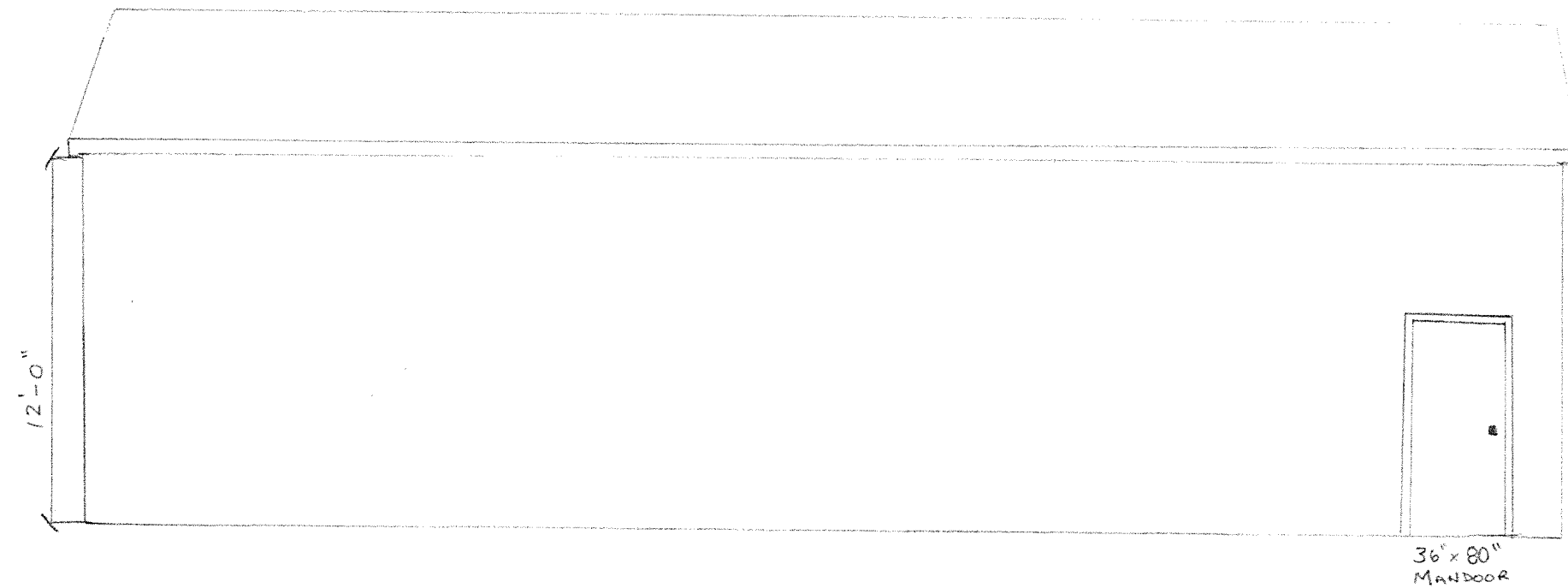
ROOF RIDGE VENTILATION

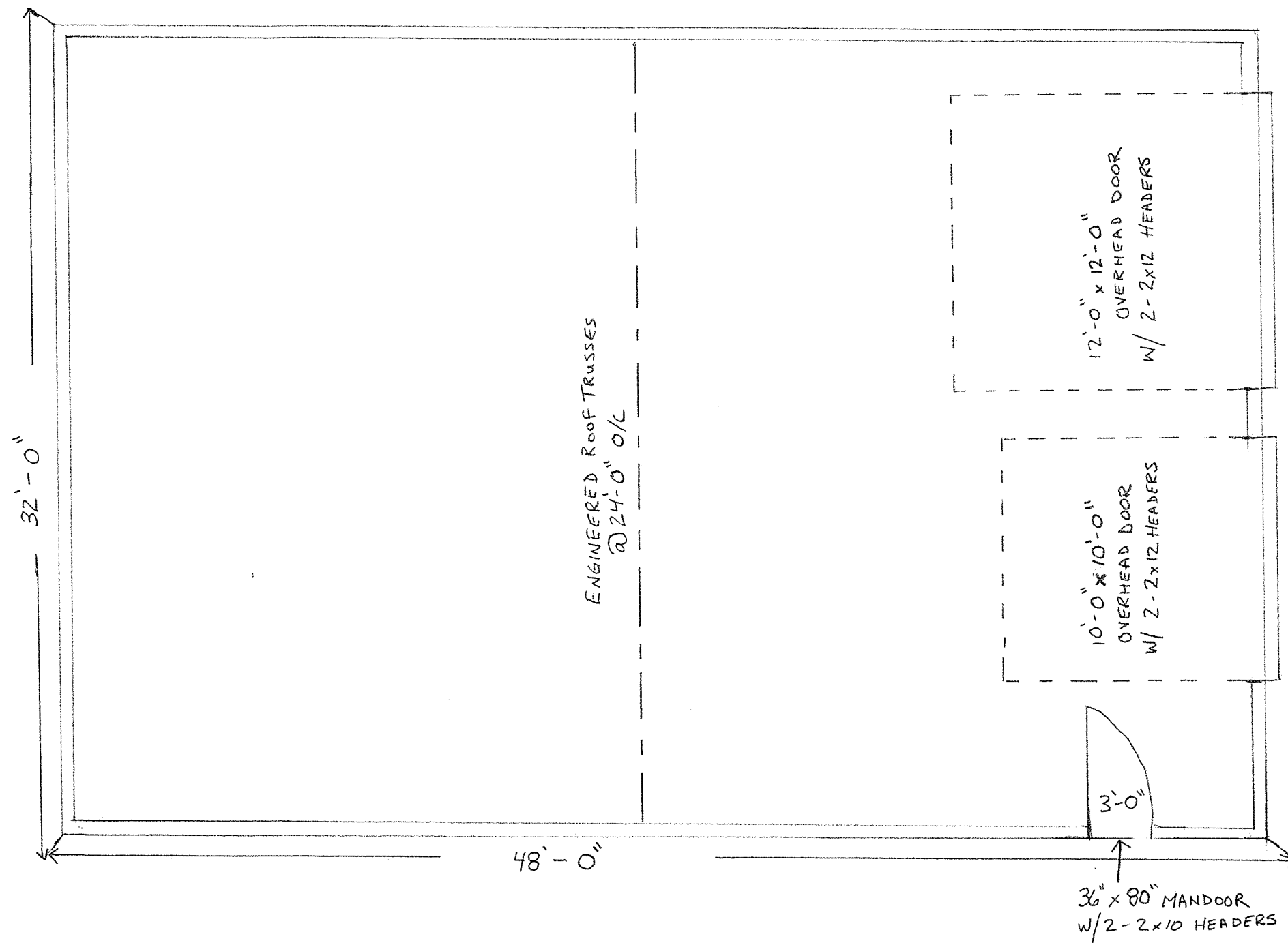

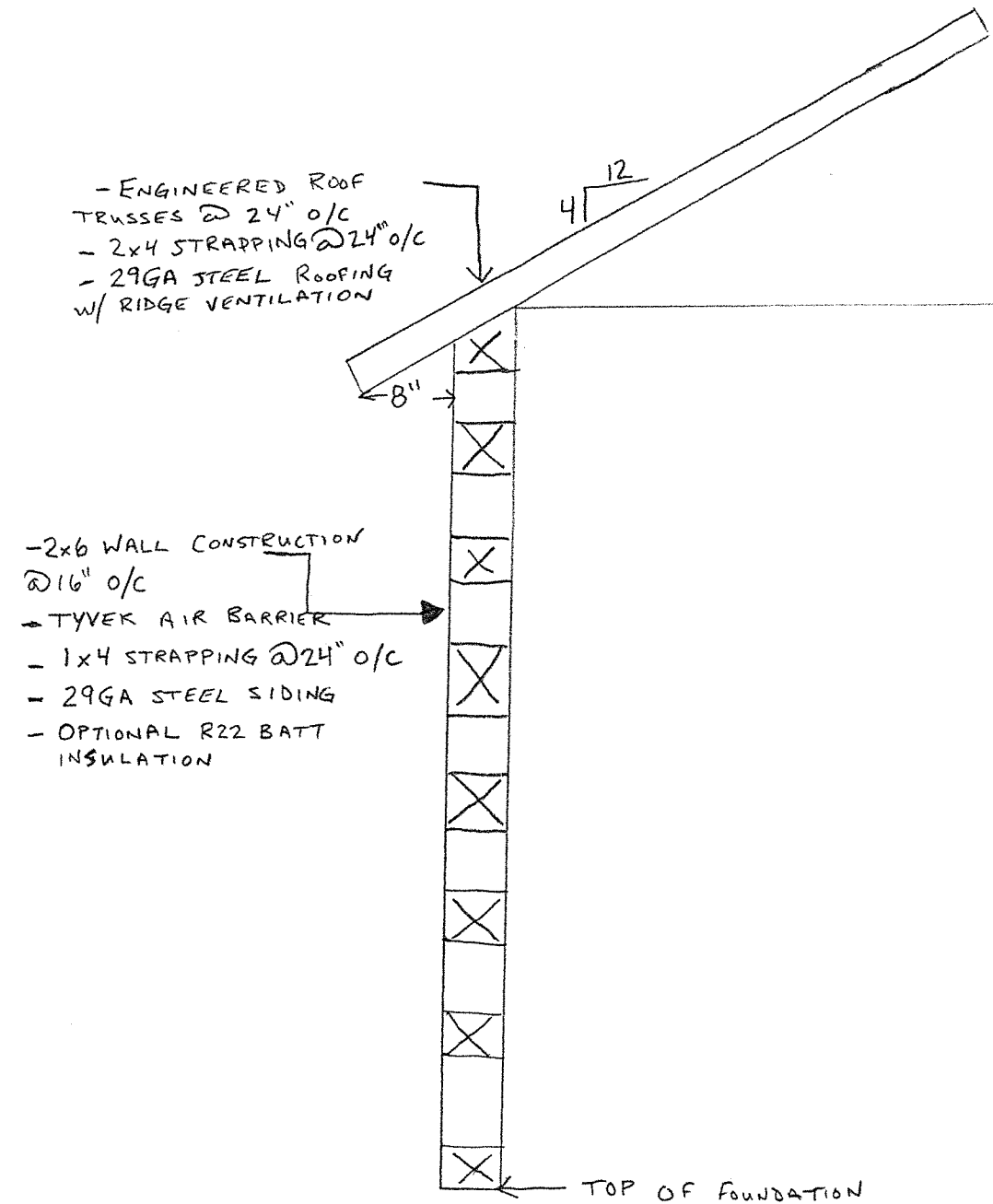

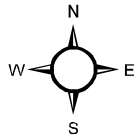

MAP 1

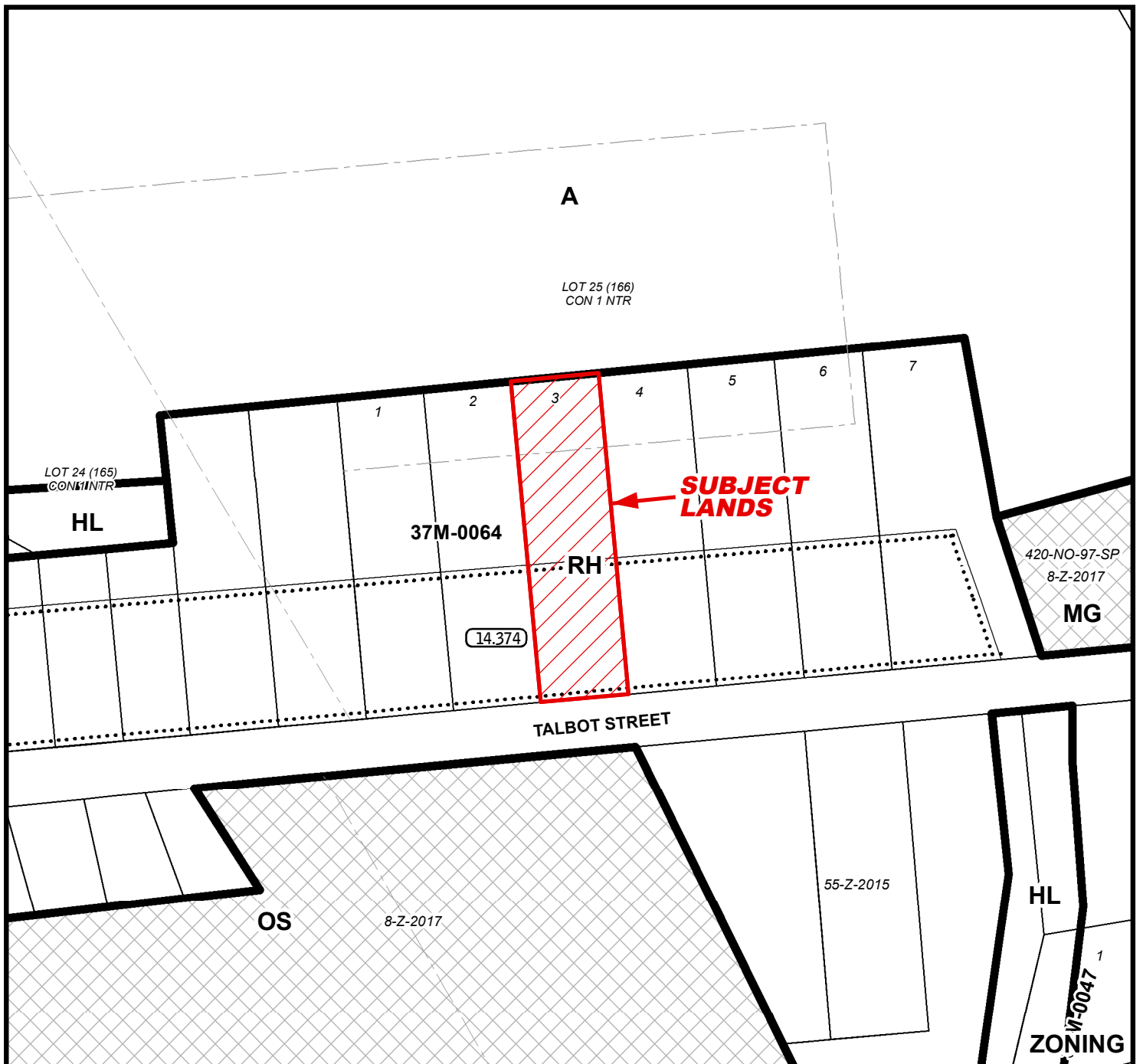
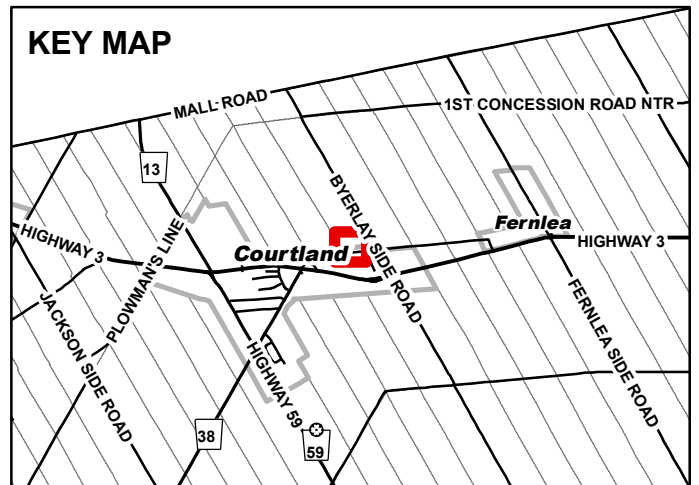

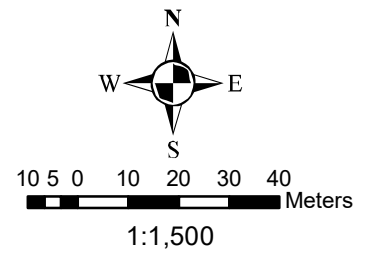
KEY MAP

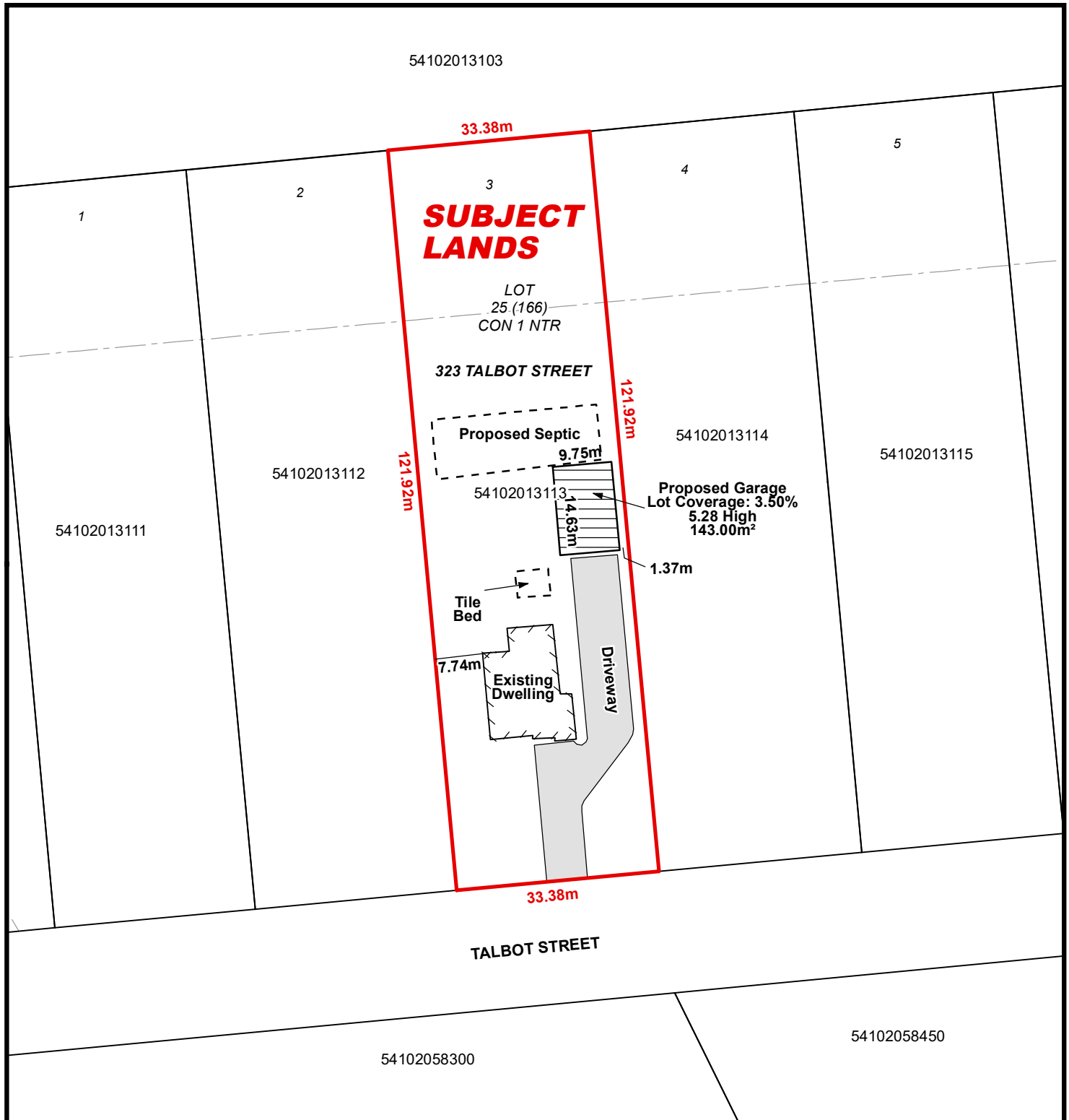
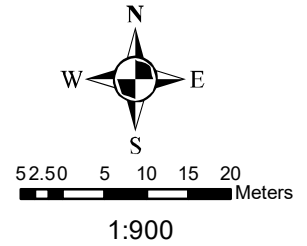
