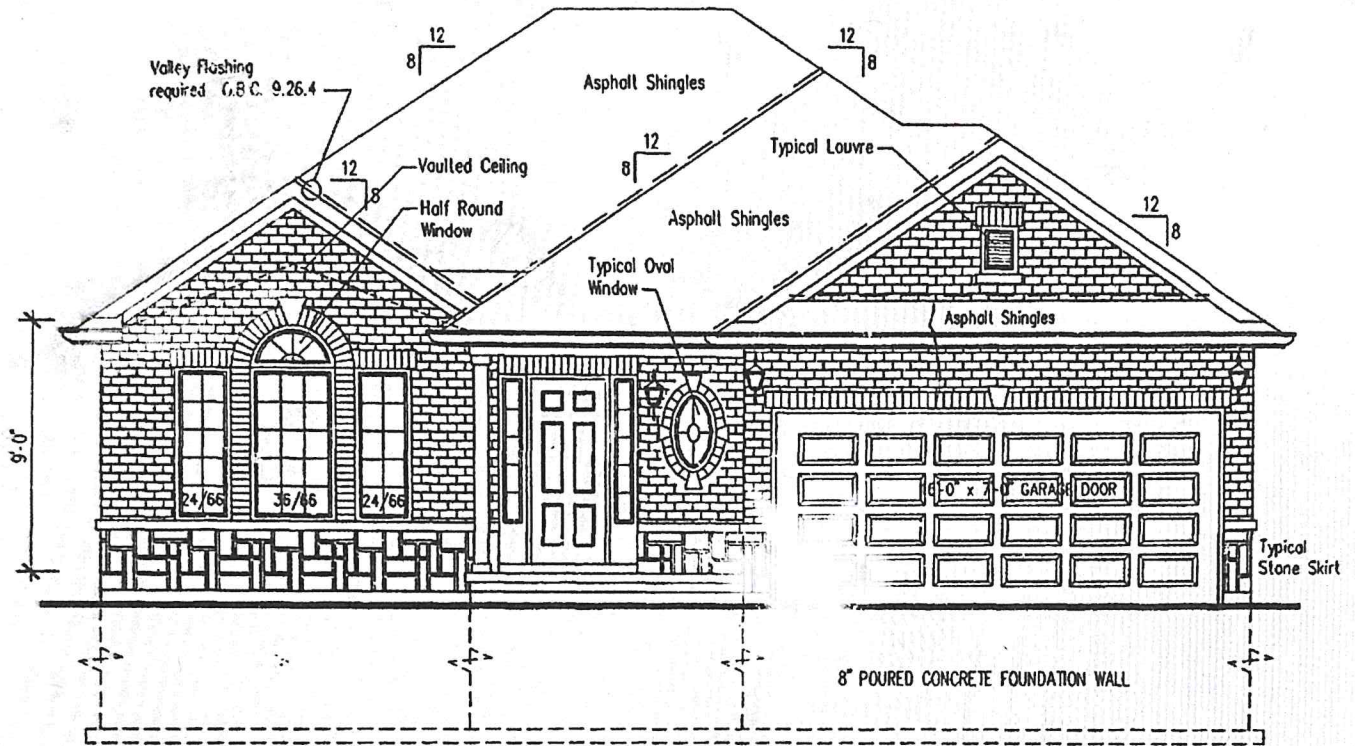

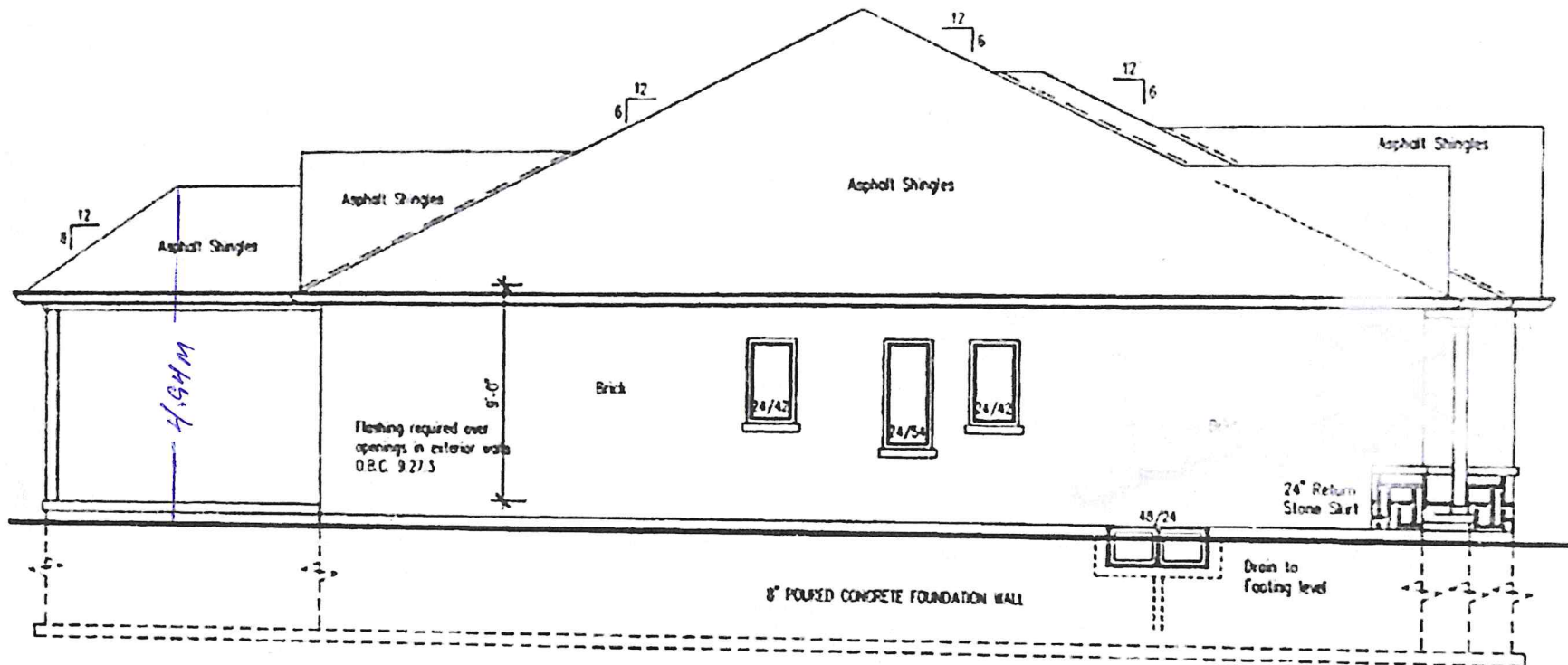

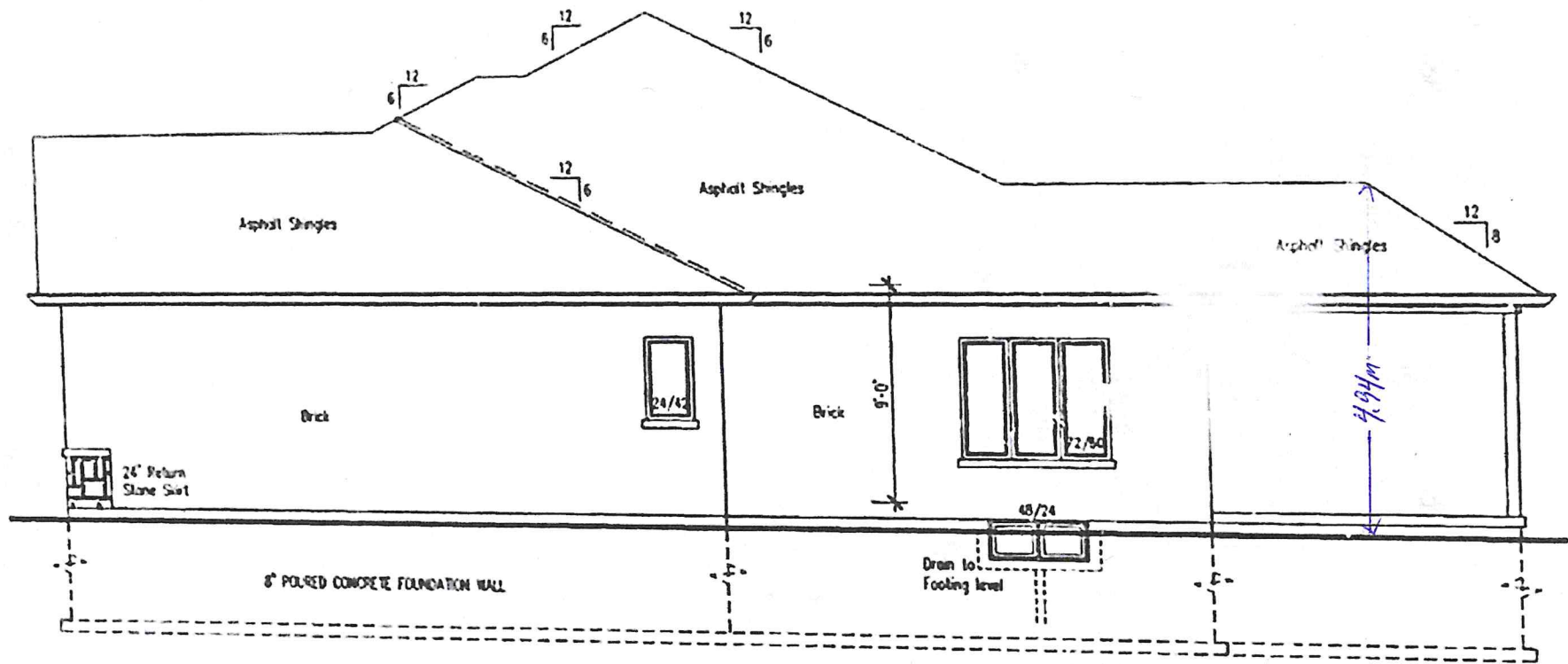
Front Elevation

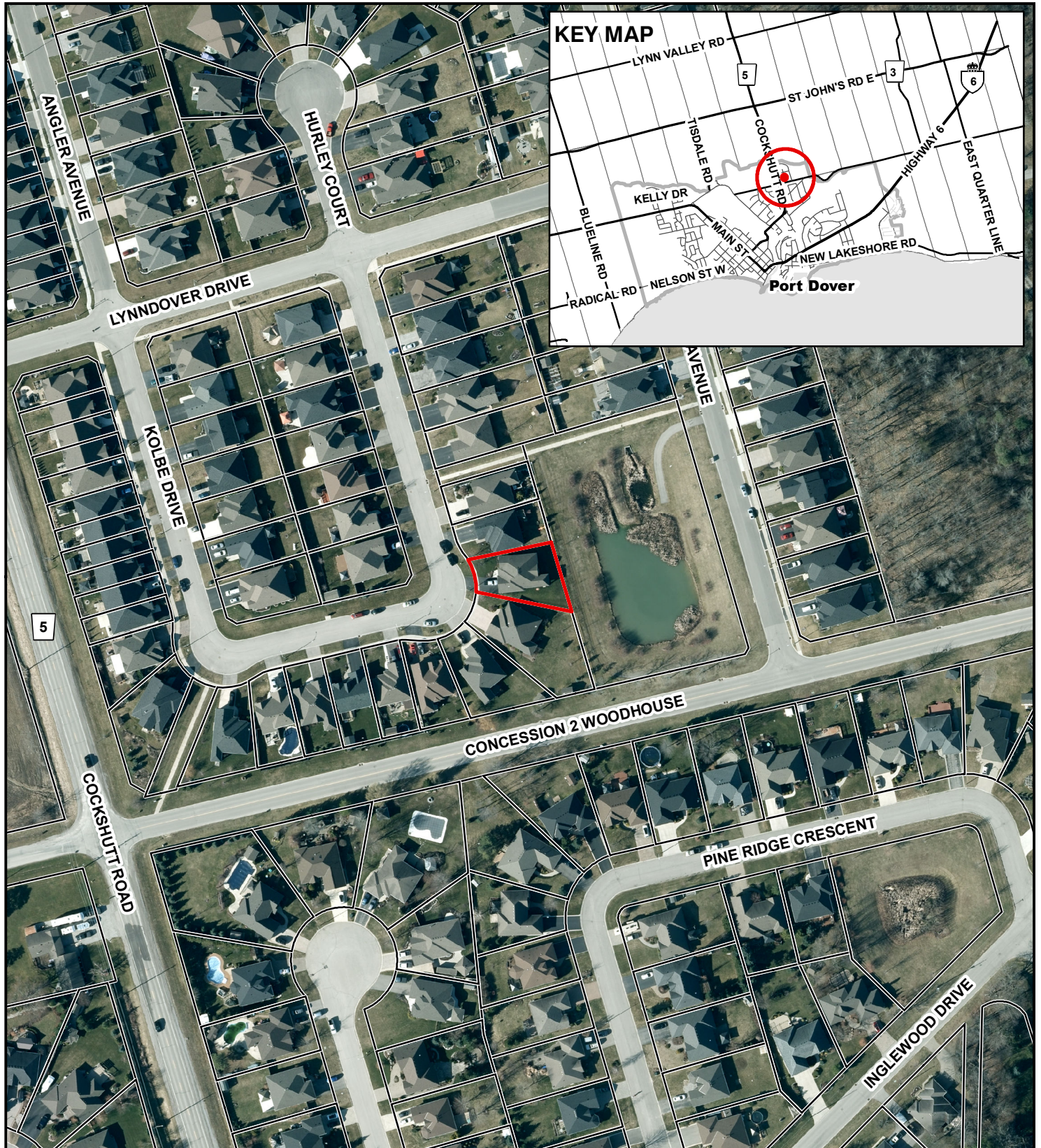

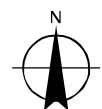

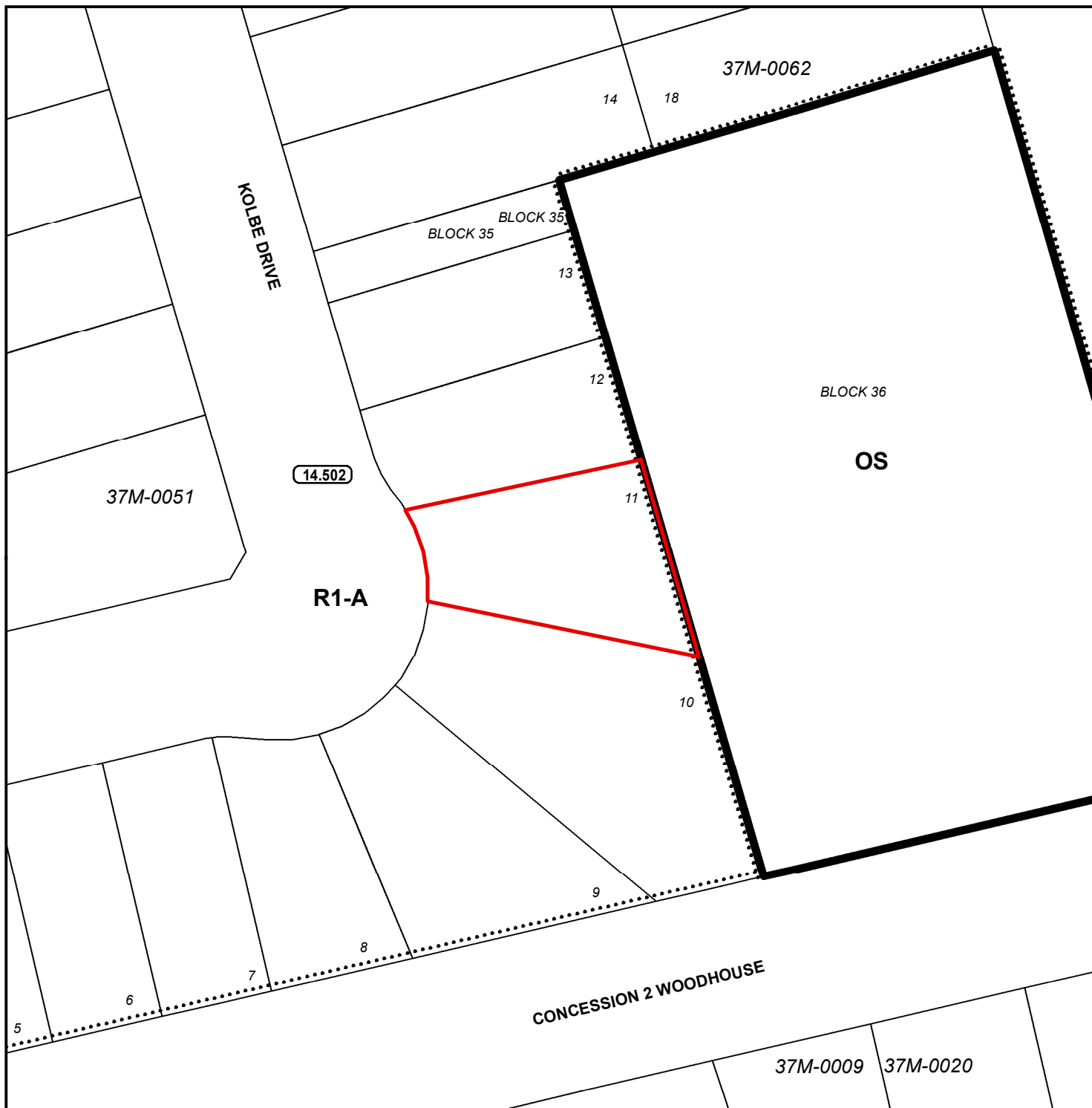

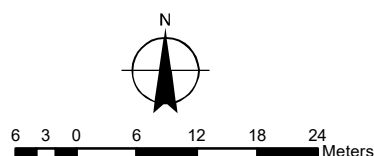

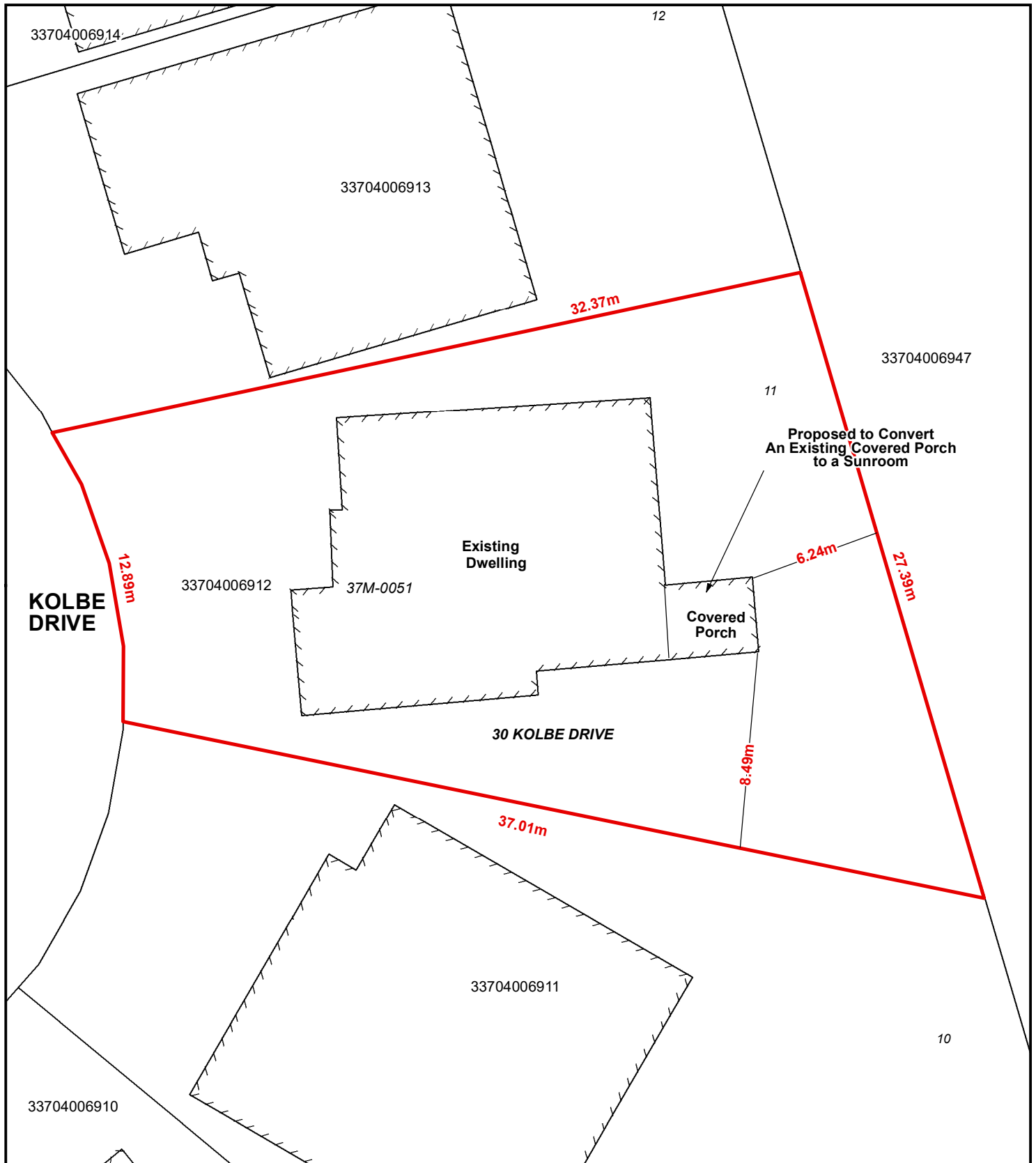

CONCEPTUAL PLAN

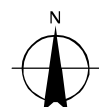

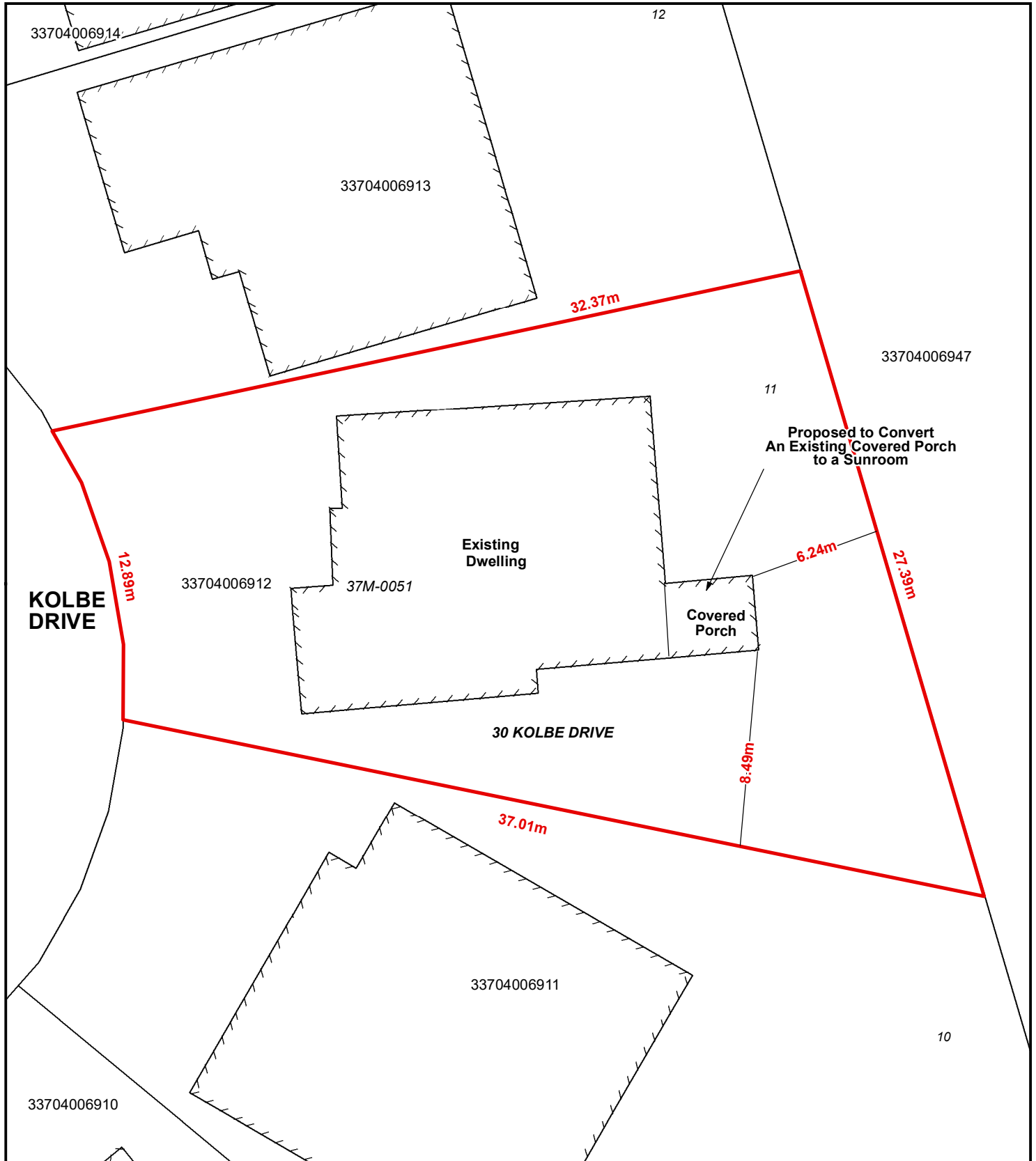

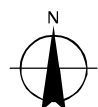
