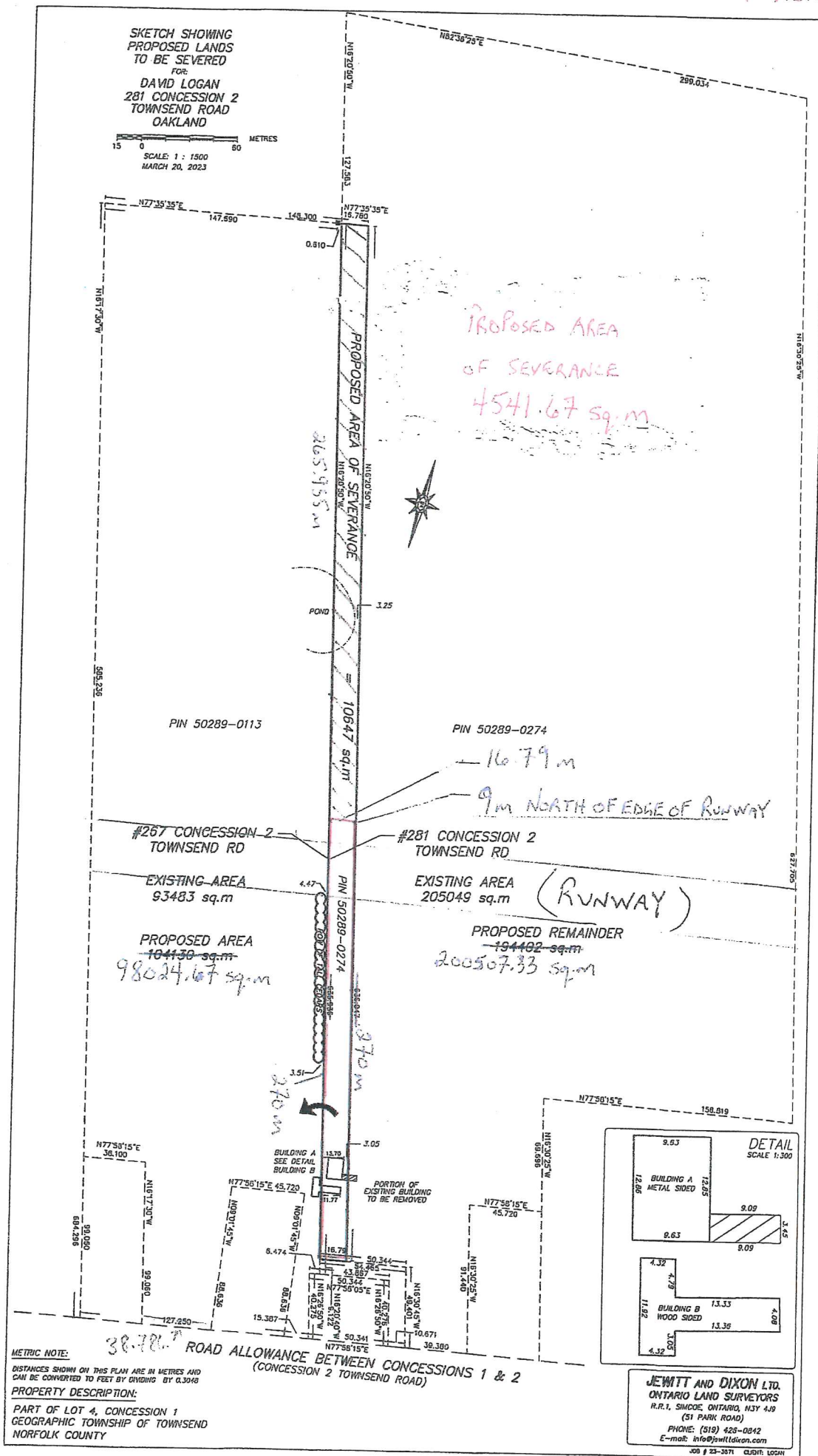

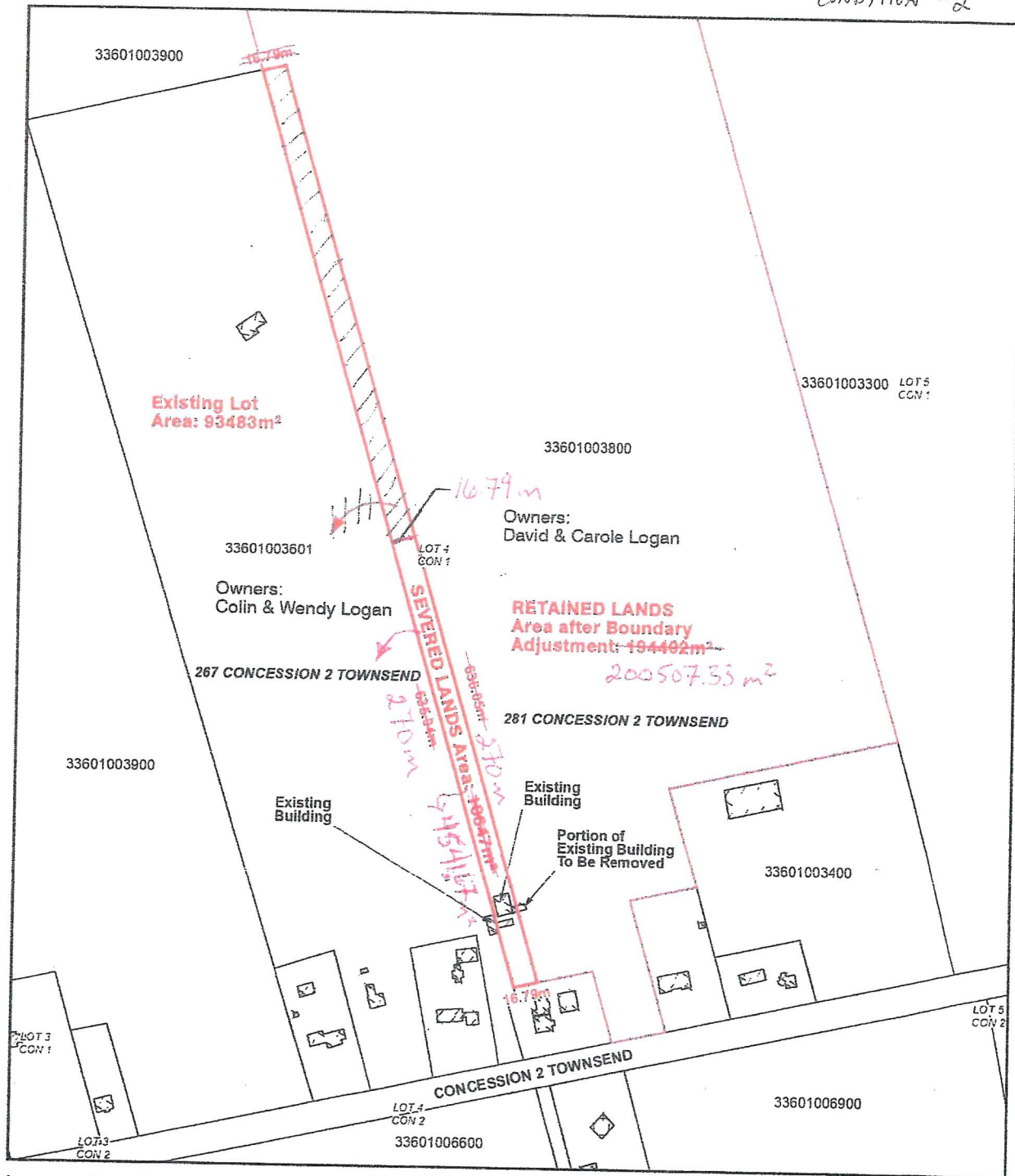

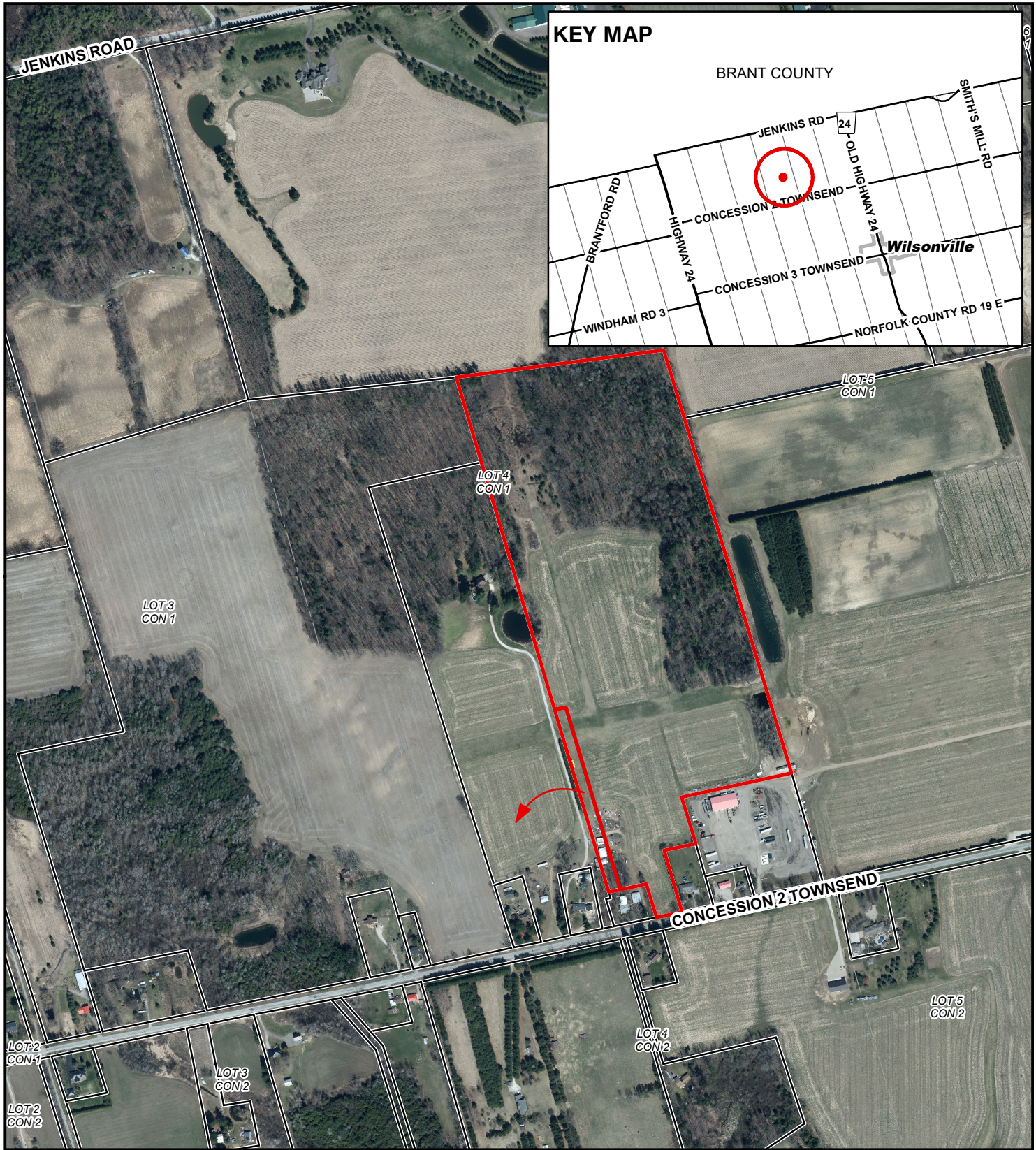

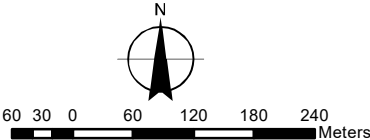

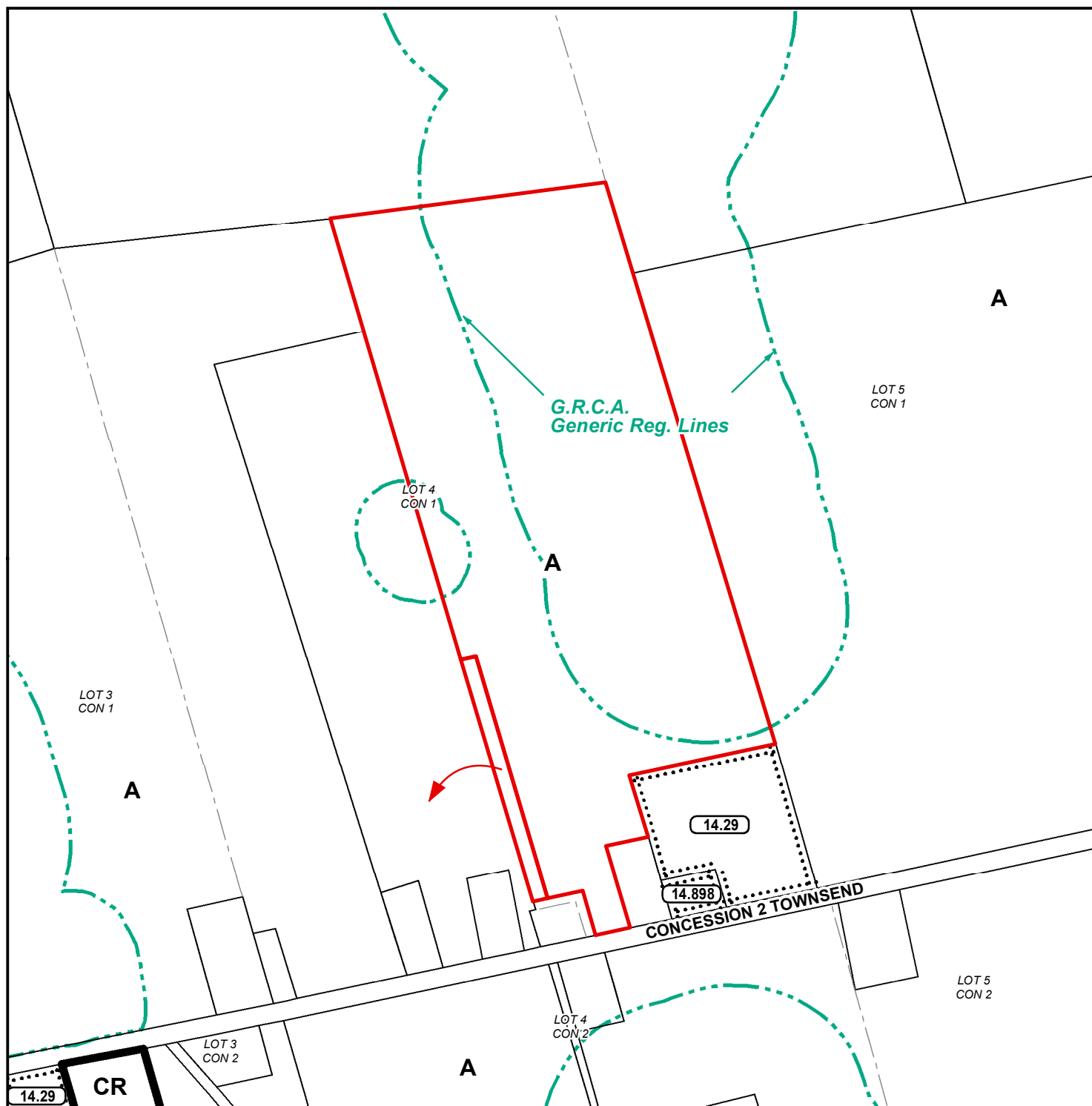

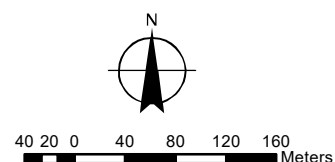

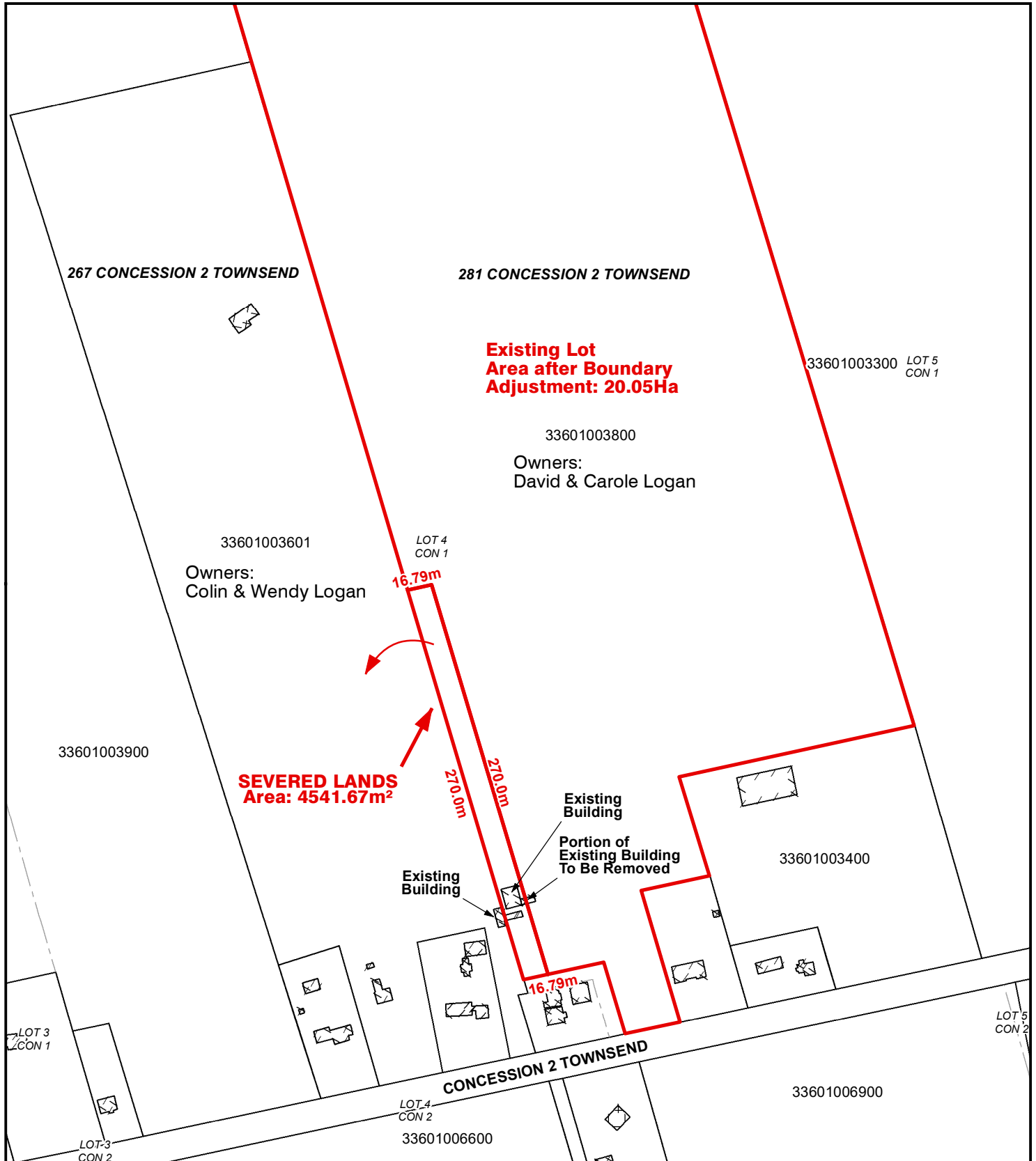

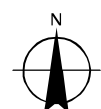
CONCEPTUAL PLAN

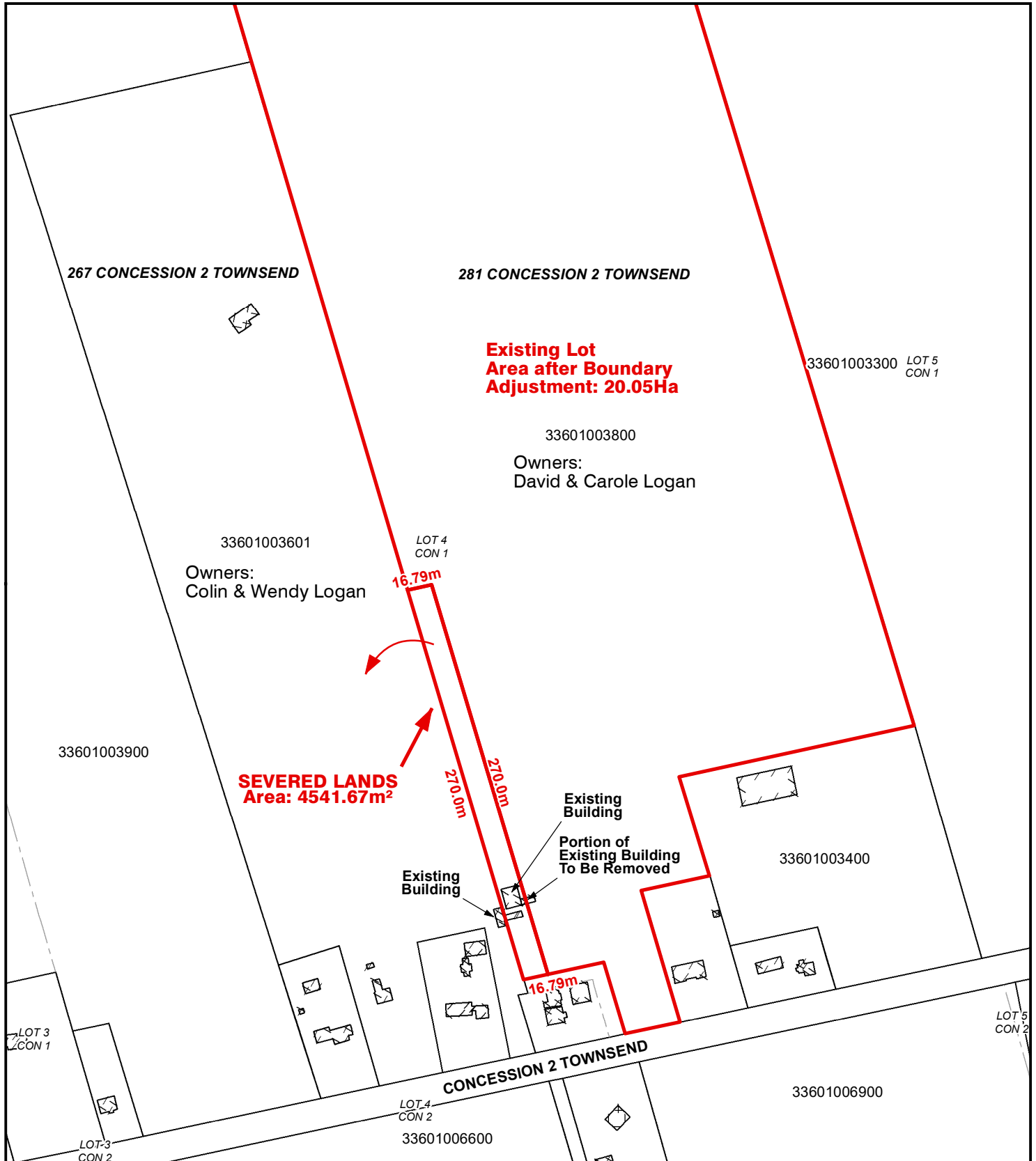

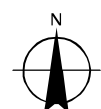
CONCEPTUAL PLAN
