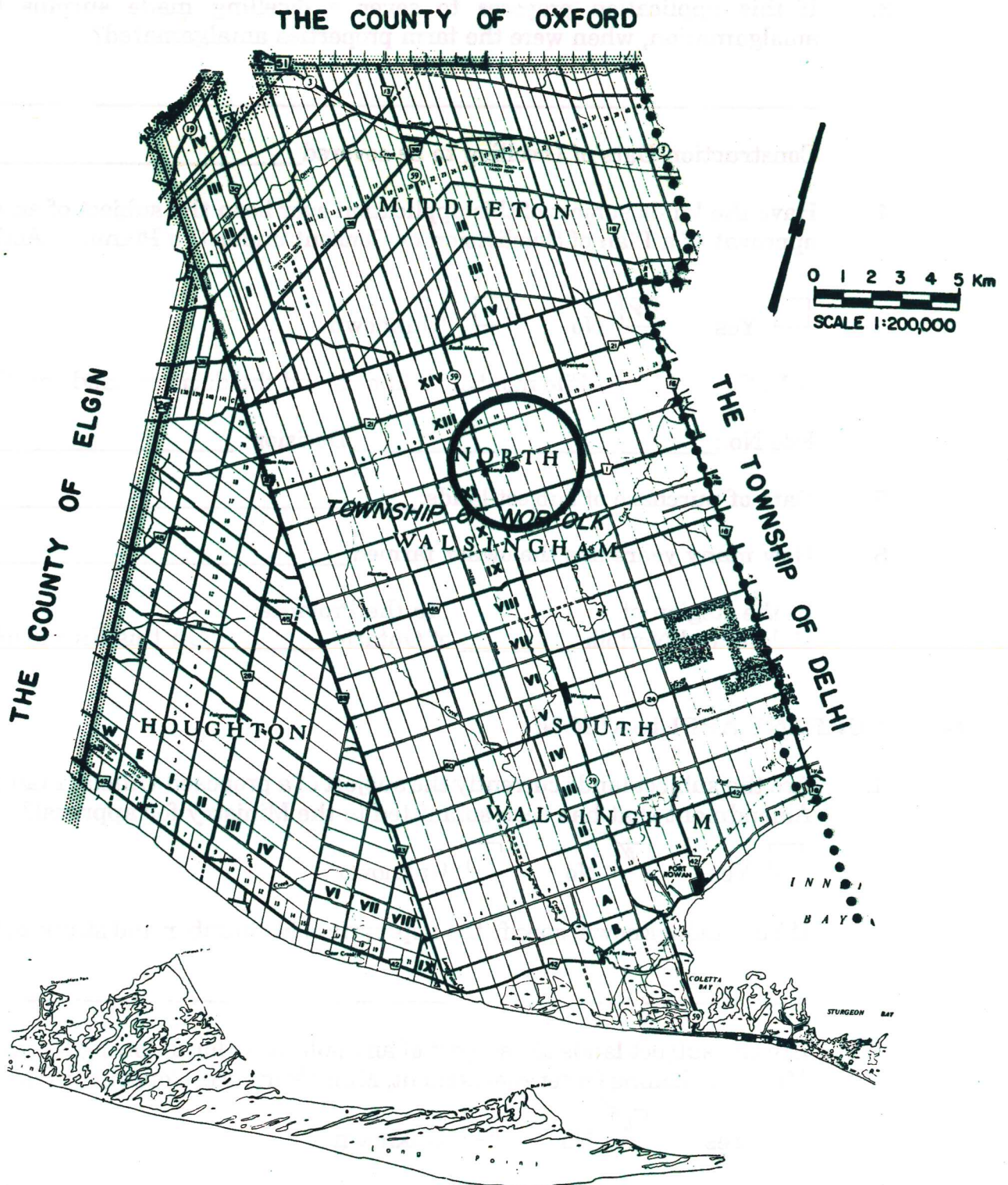

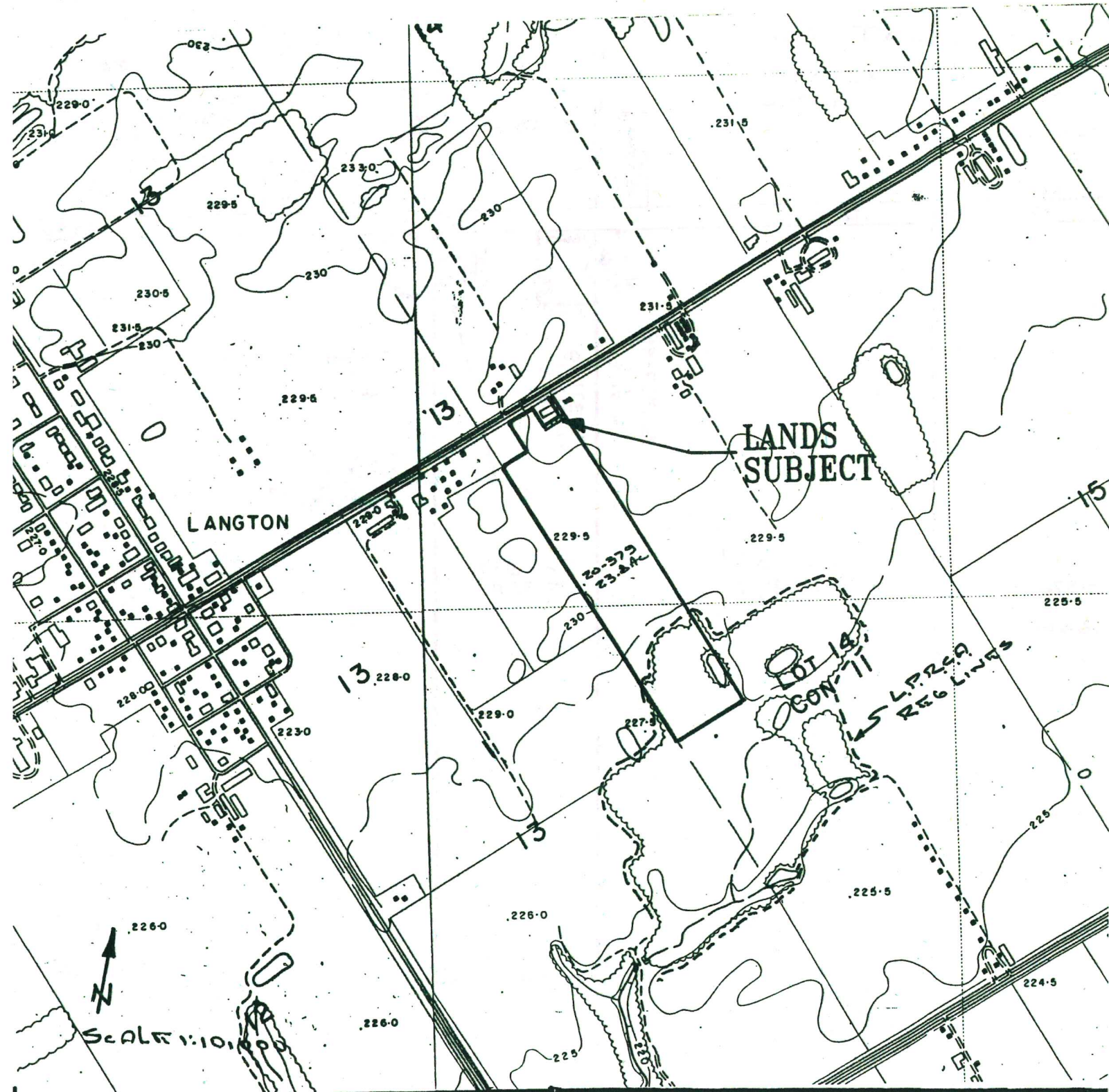

MAP Nº 1 TO FILE NUMBER B-44/55-N



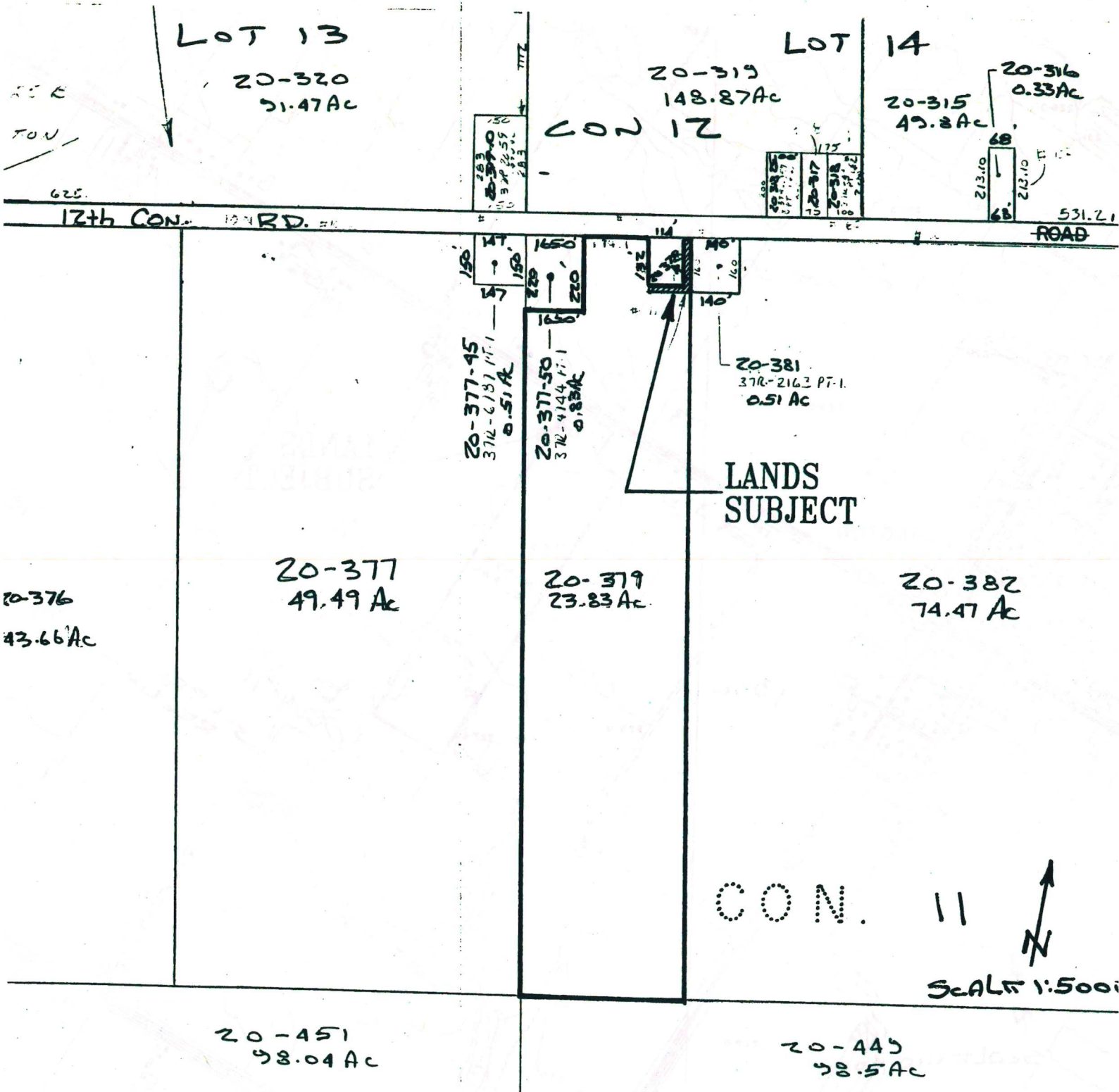
MAP N^o 2 TO FILE NUMBER B-44/55-W

FORMER MUNICIPALITY: N. WALSWORTHAM.

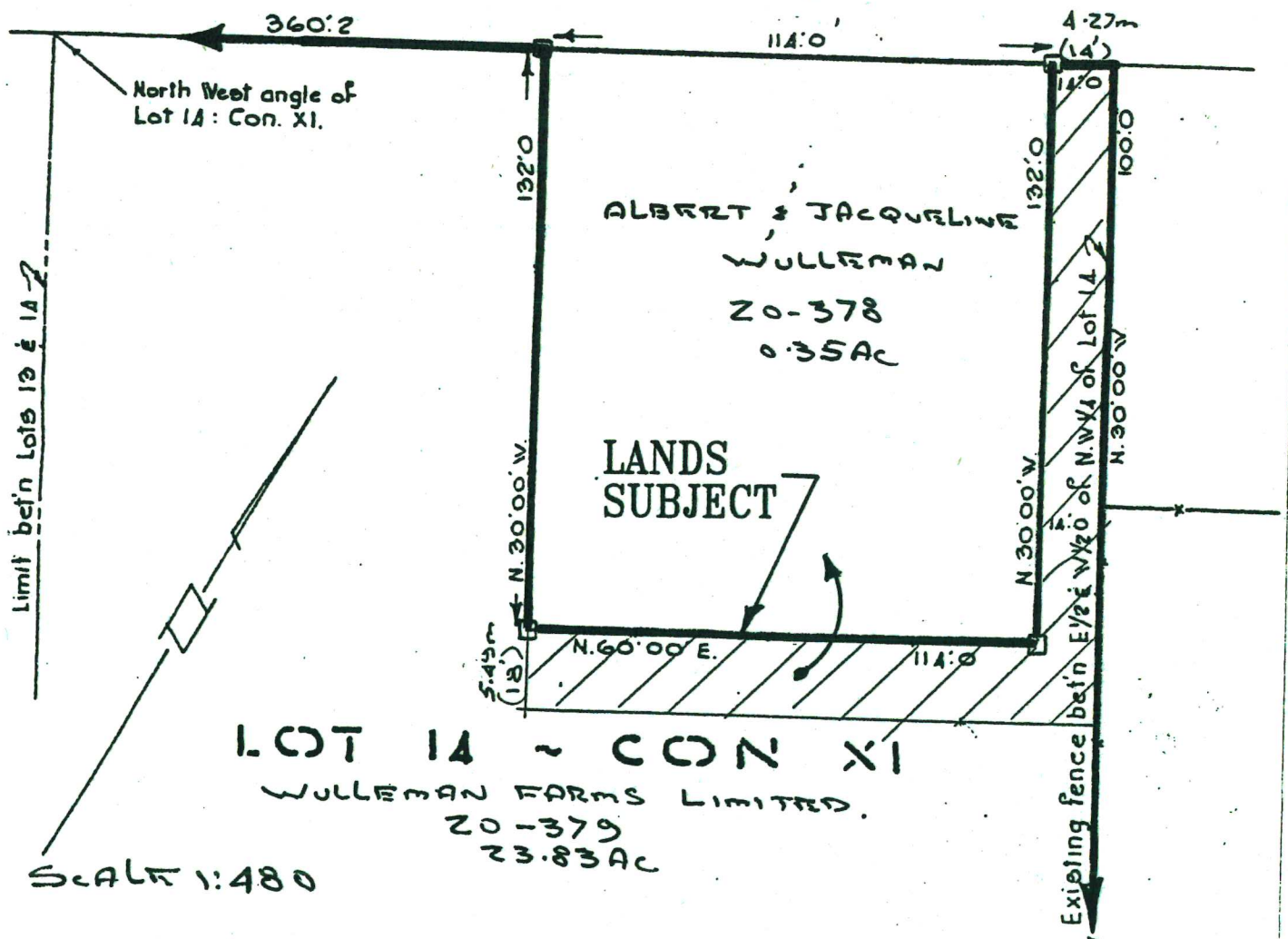


MAP N^o 4 TO FILE NUMBER B-44/59-N
