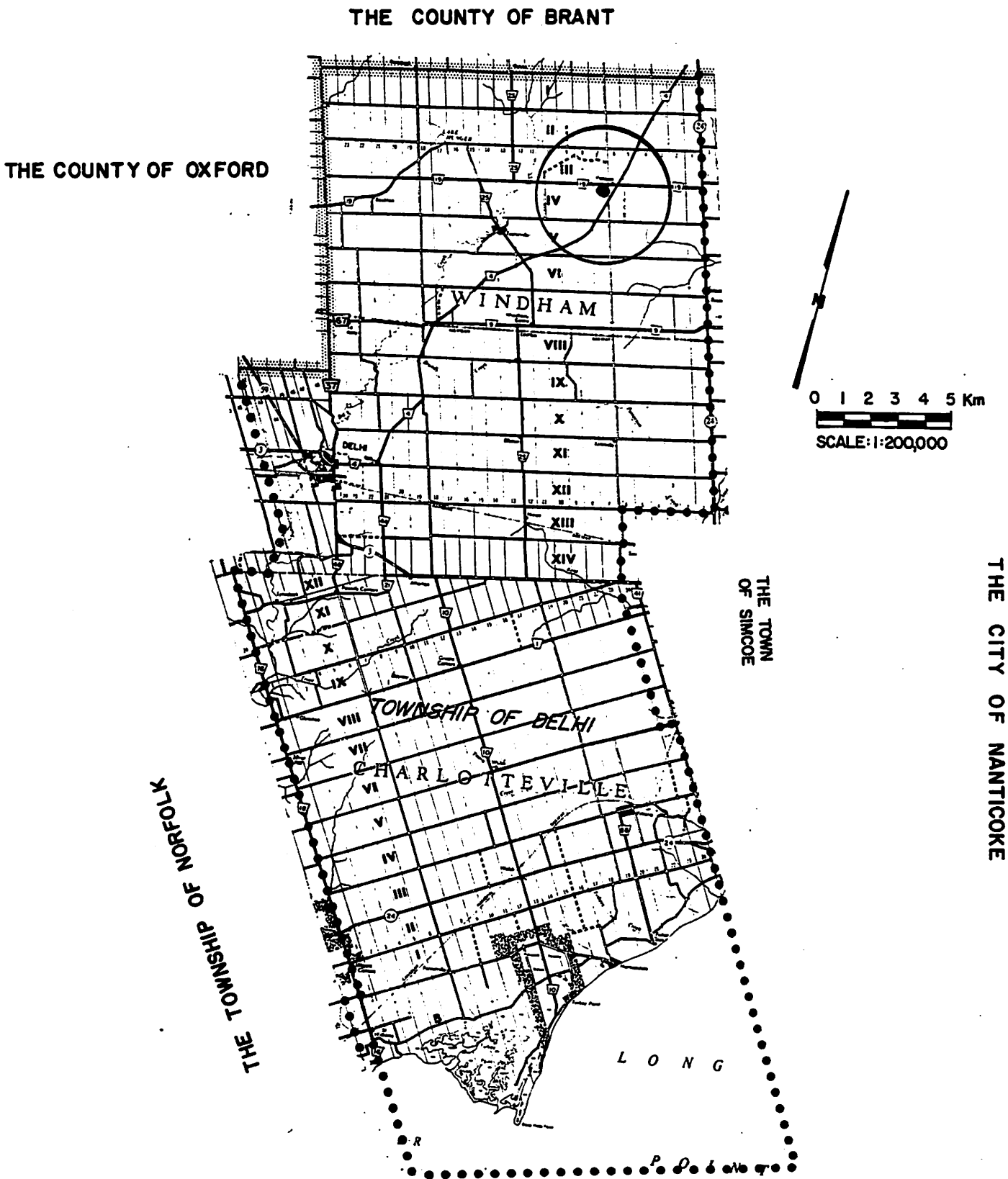

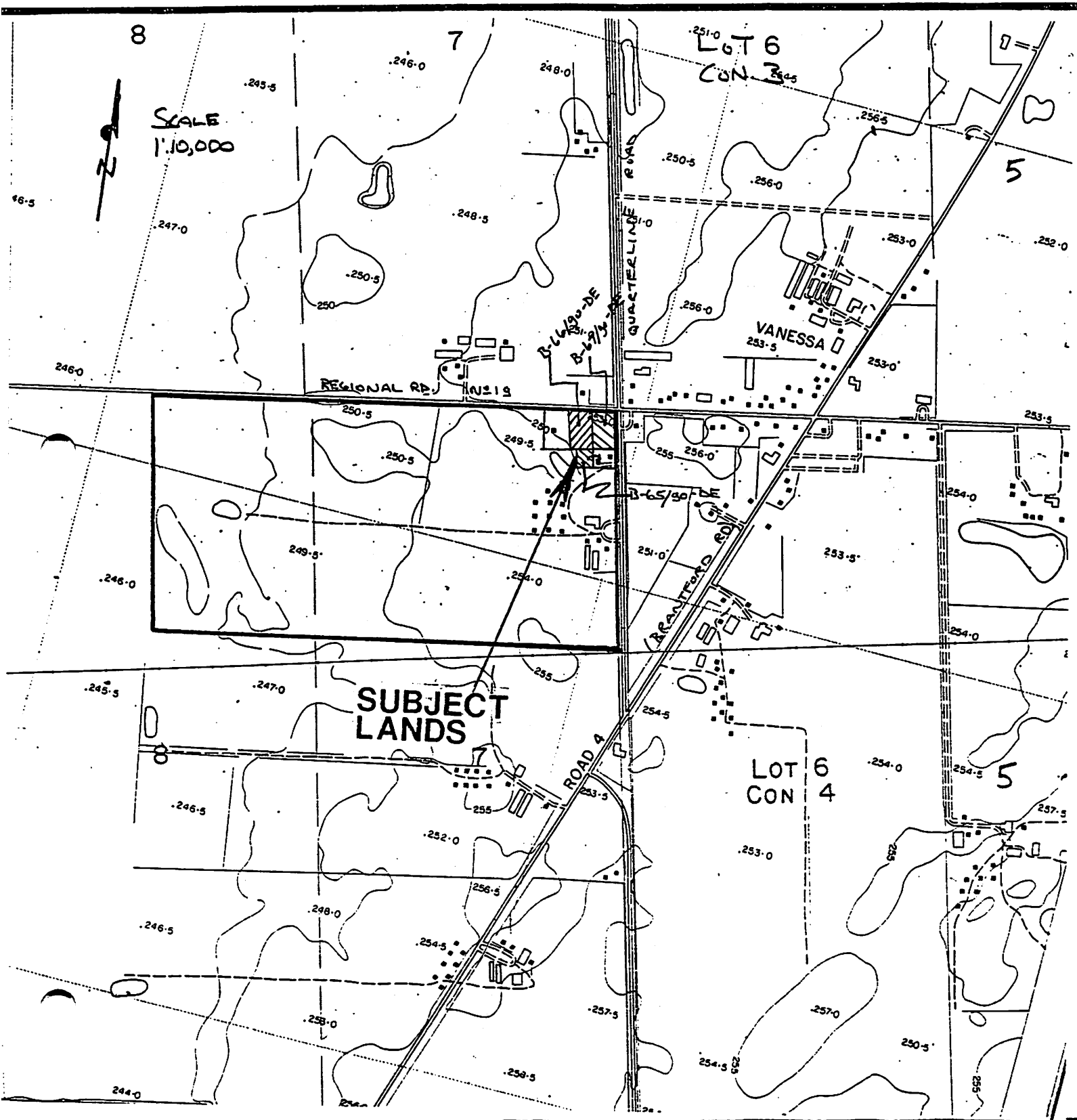

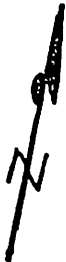
MAP No 3 TO FILE NUMBER B-65 to 67/90-DE
