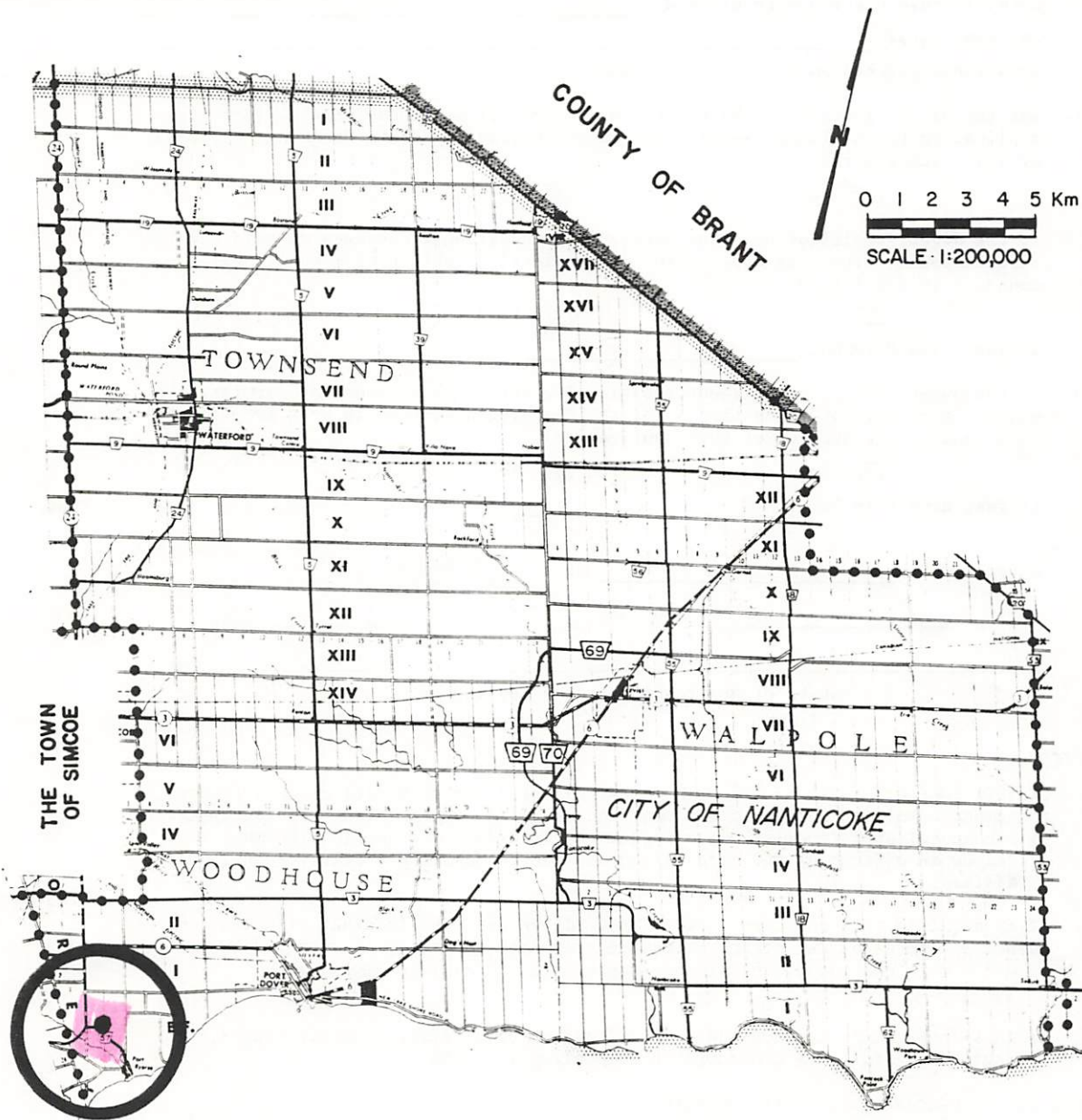

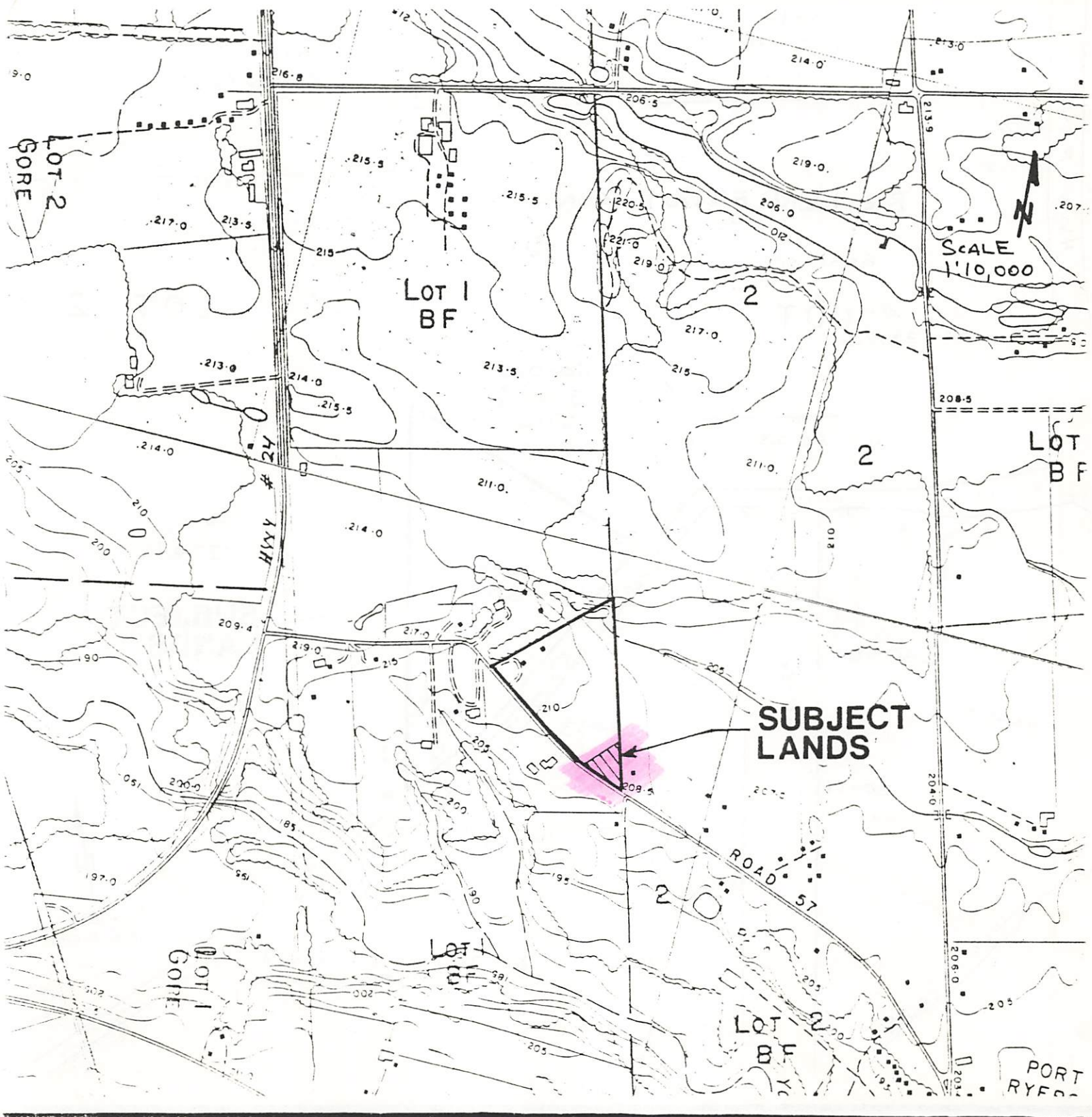
MAP N° 1 TO FILE NUMBER B-115/89-CN
