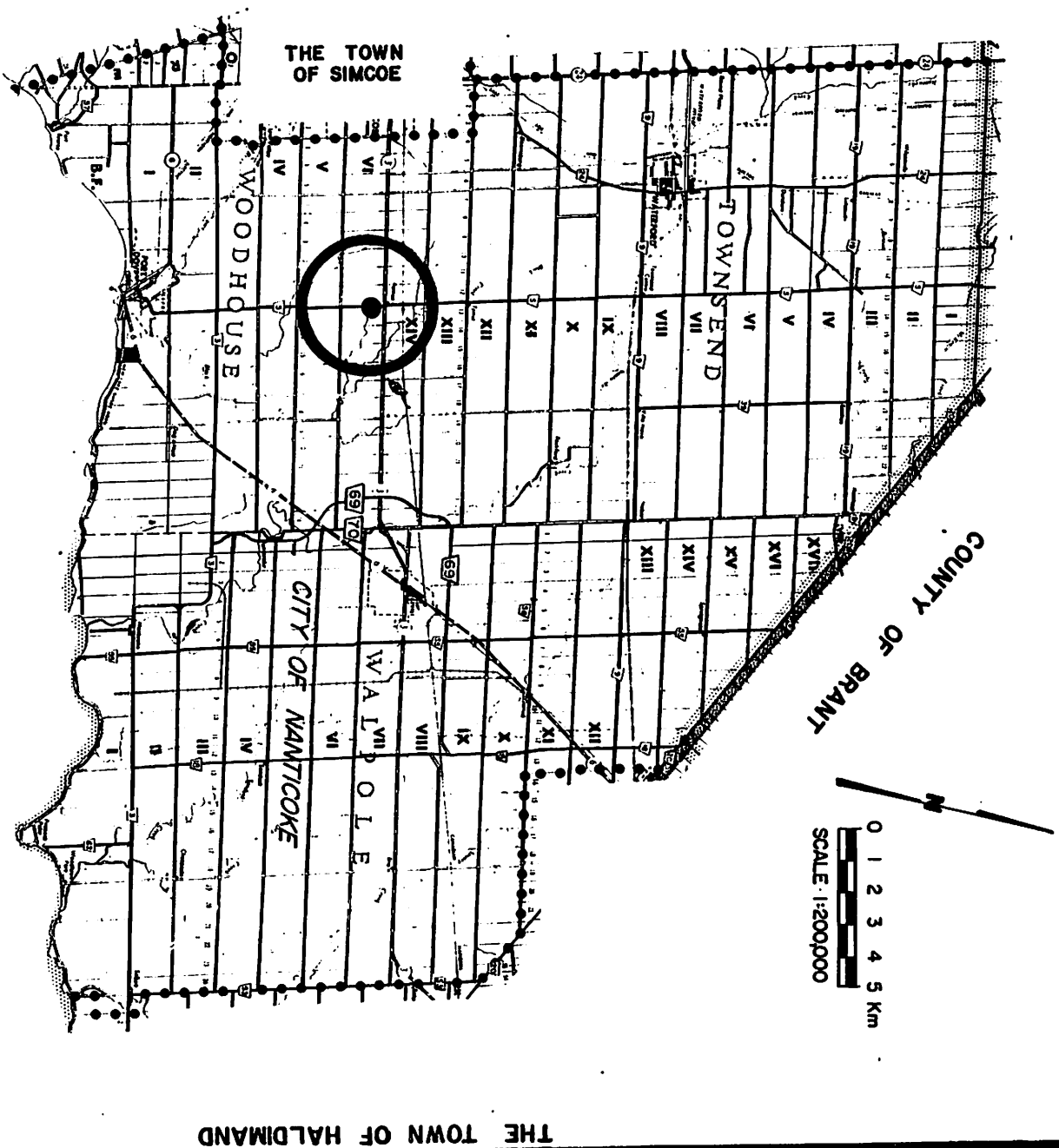

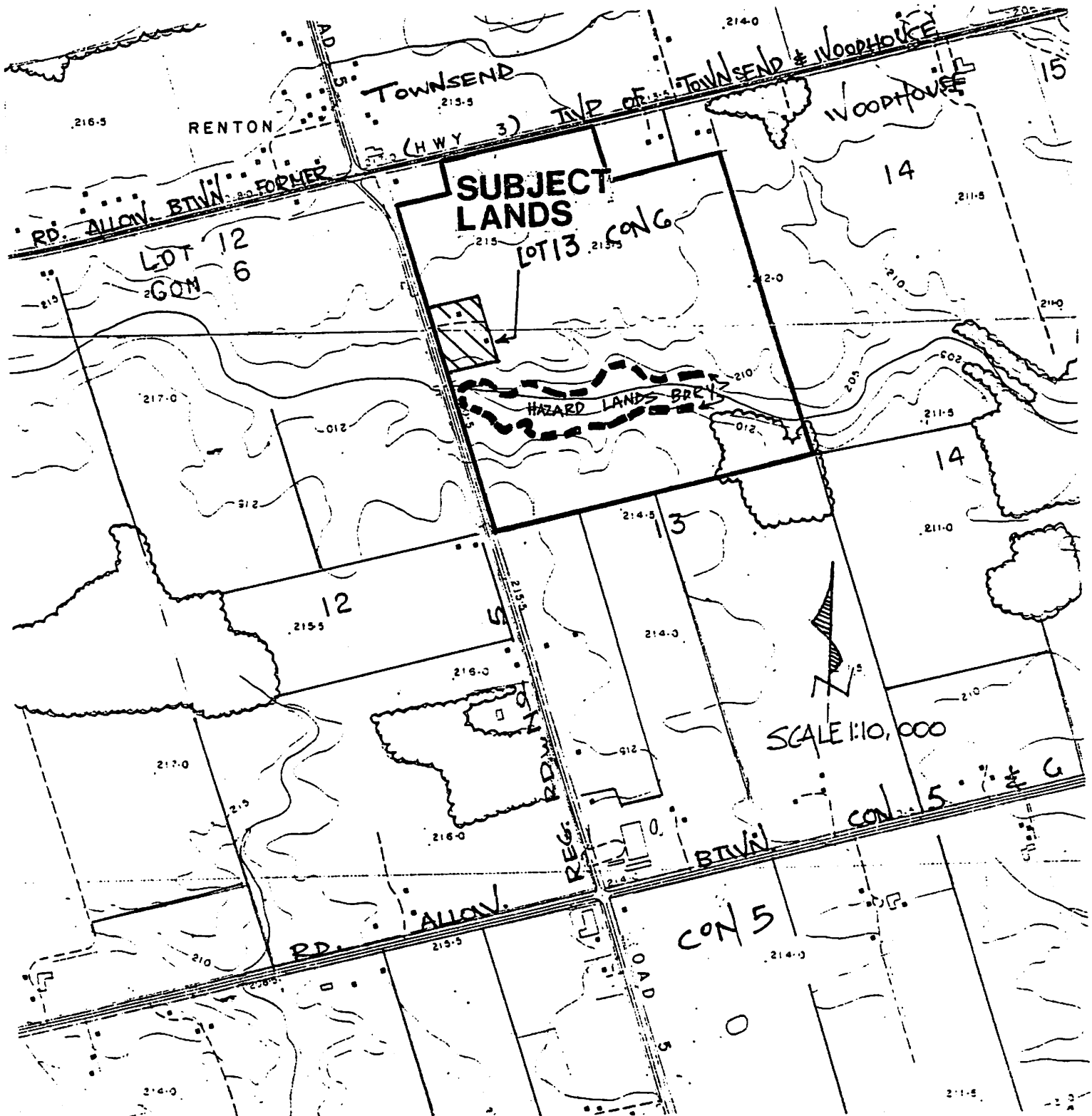
MAP No 1 TO FILE NUMBER B-231/09-CN
