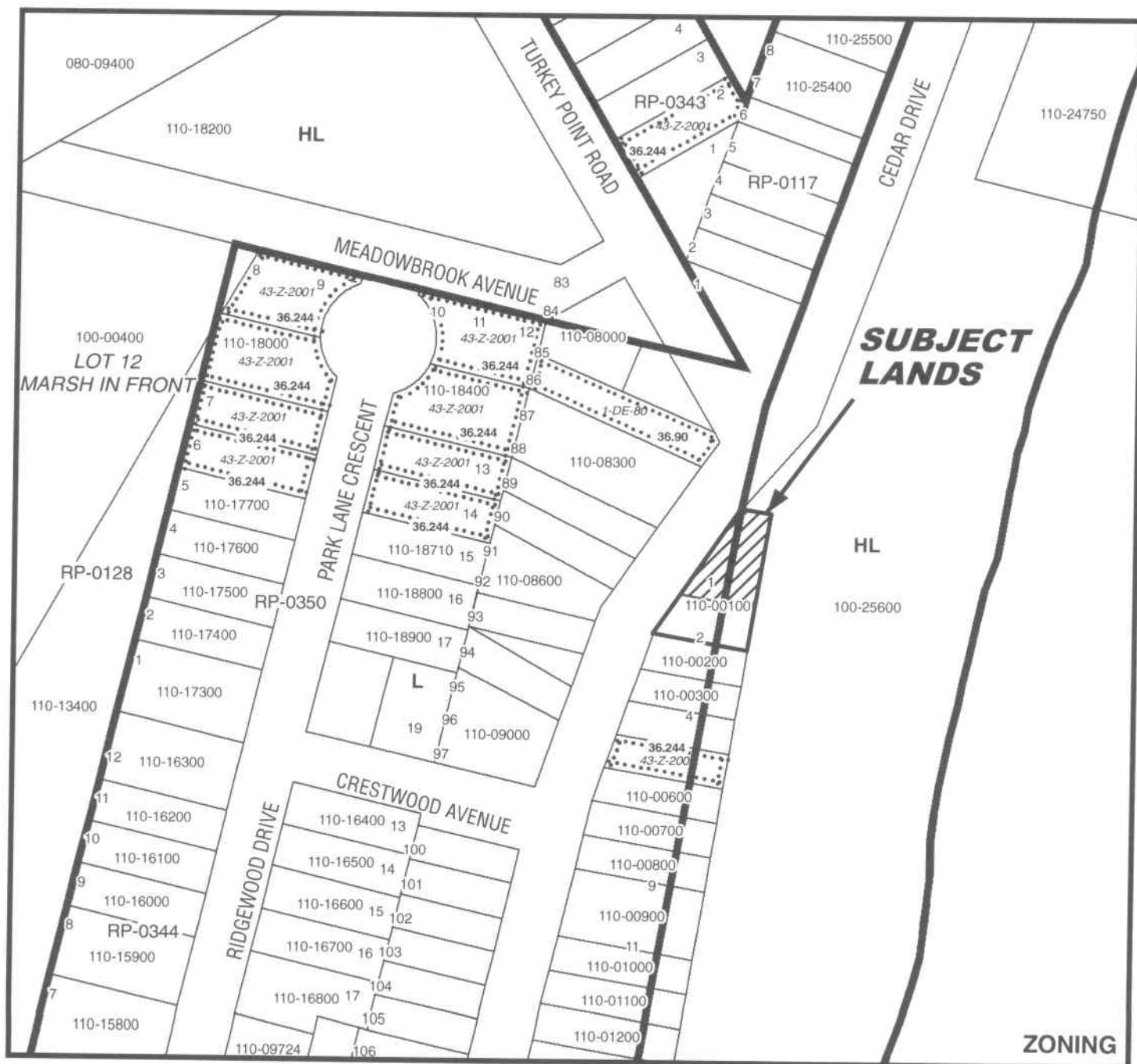

# MAP 2

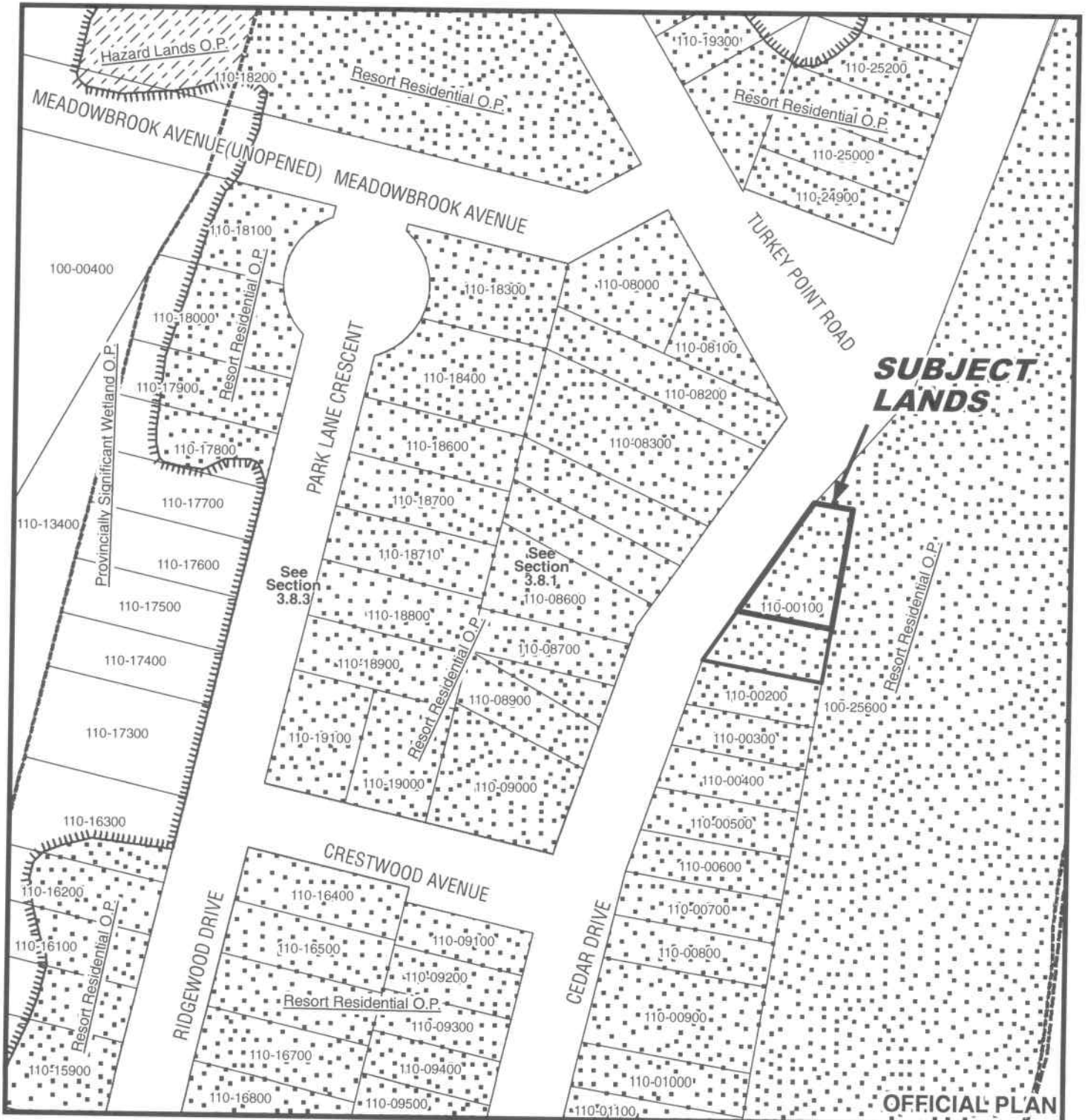

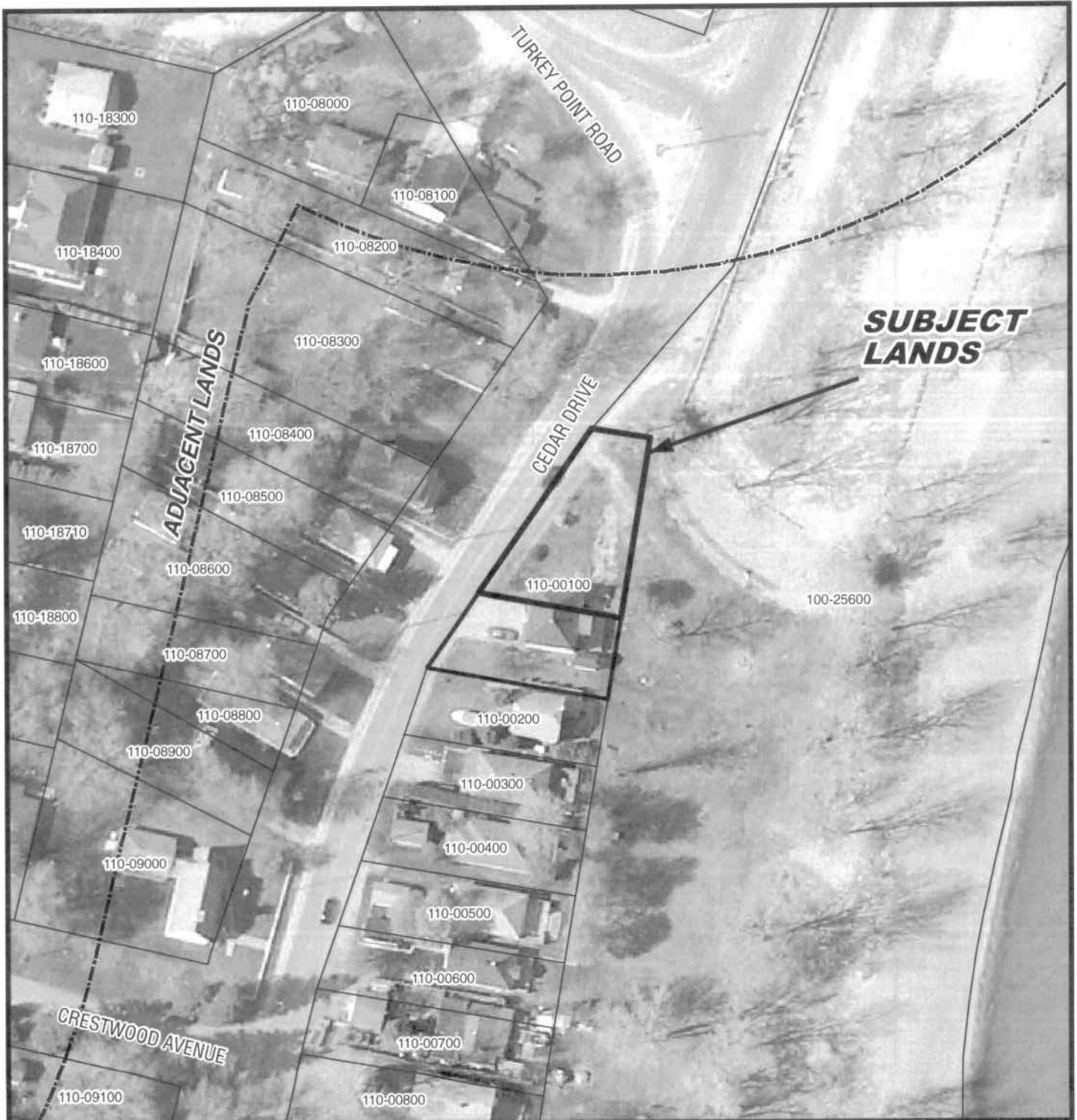
