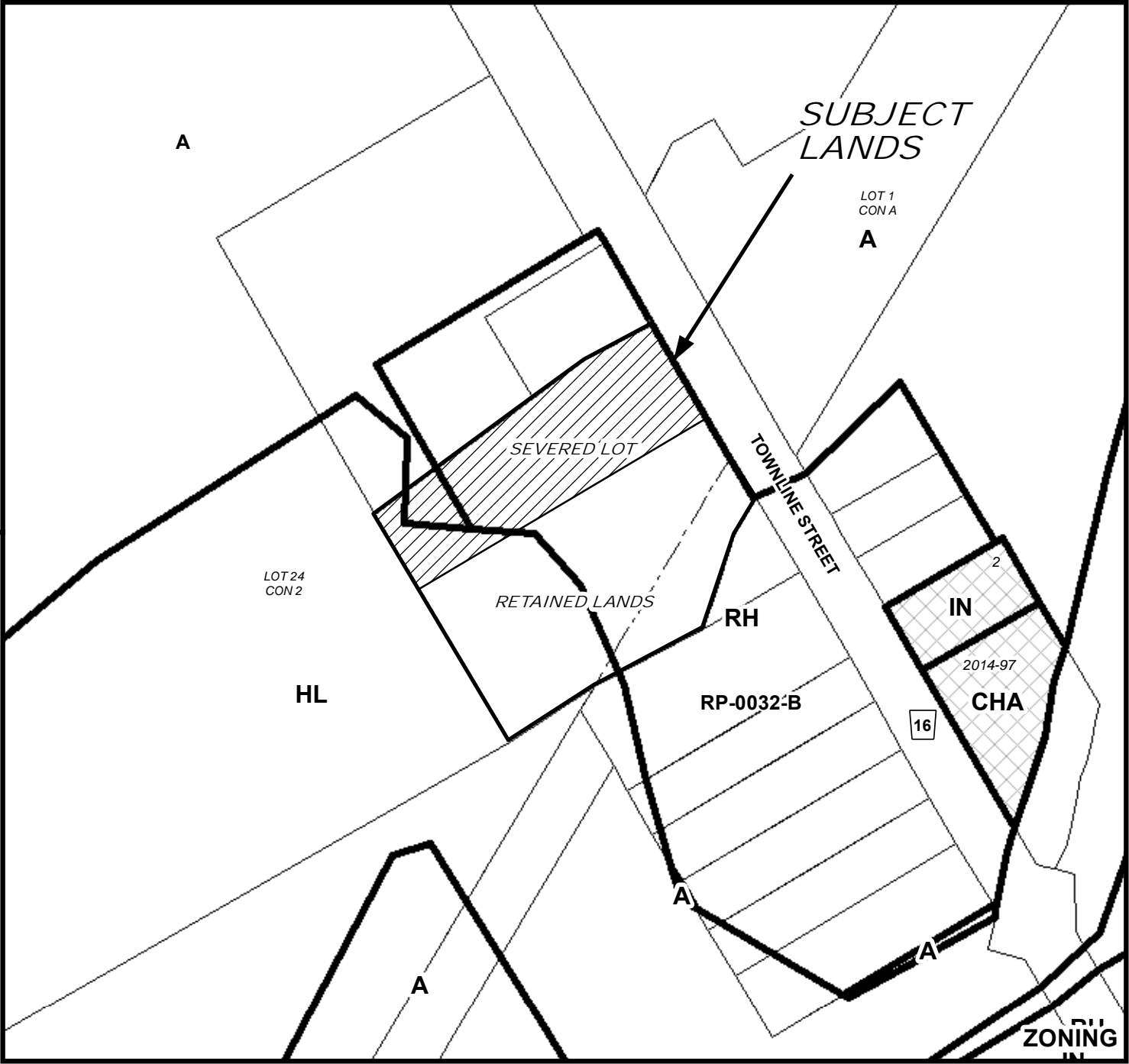

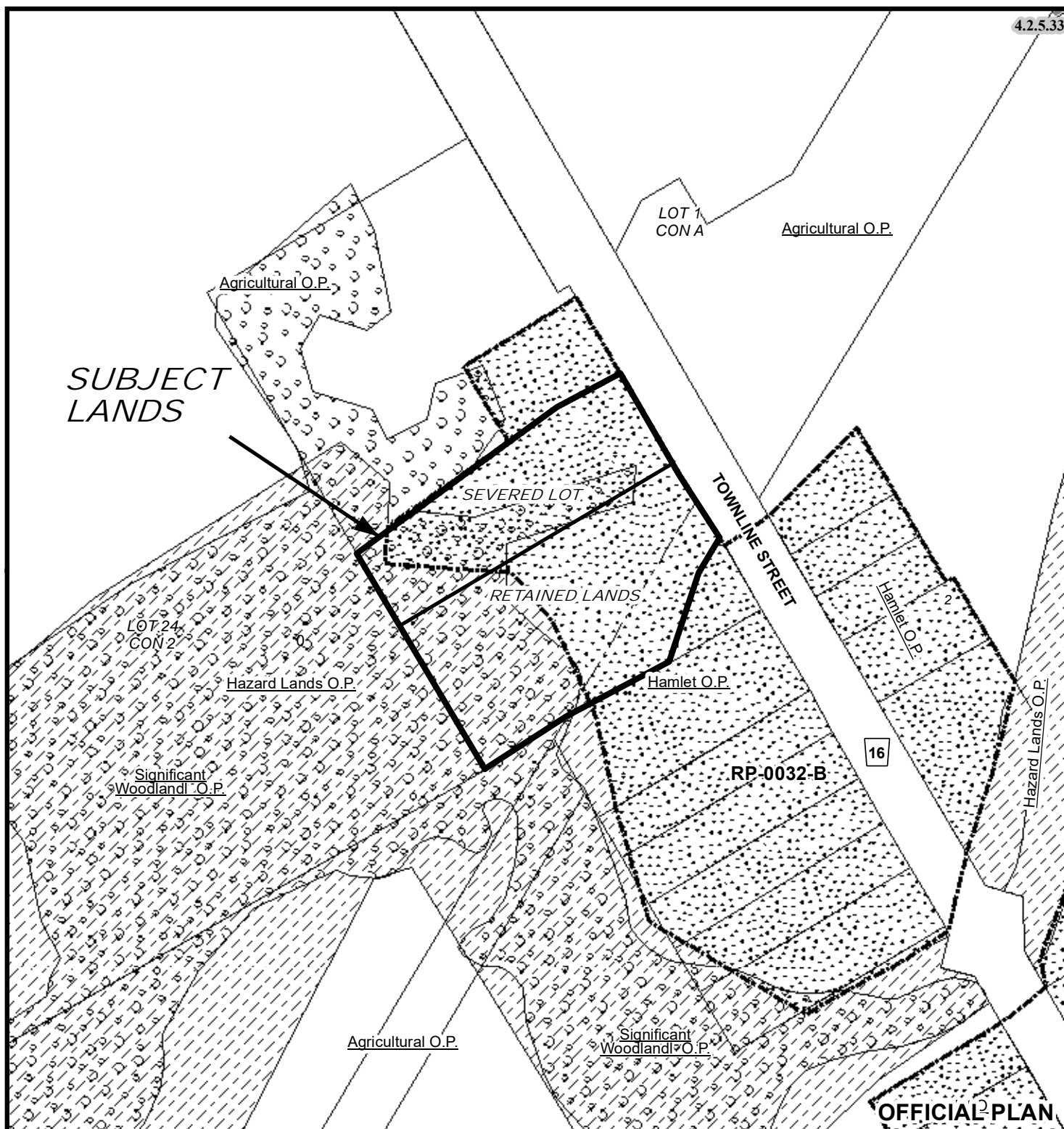

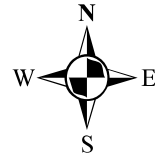




# LOCATION OF LANDS AFFECTED
