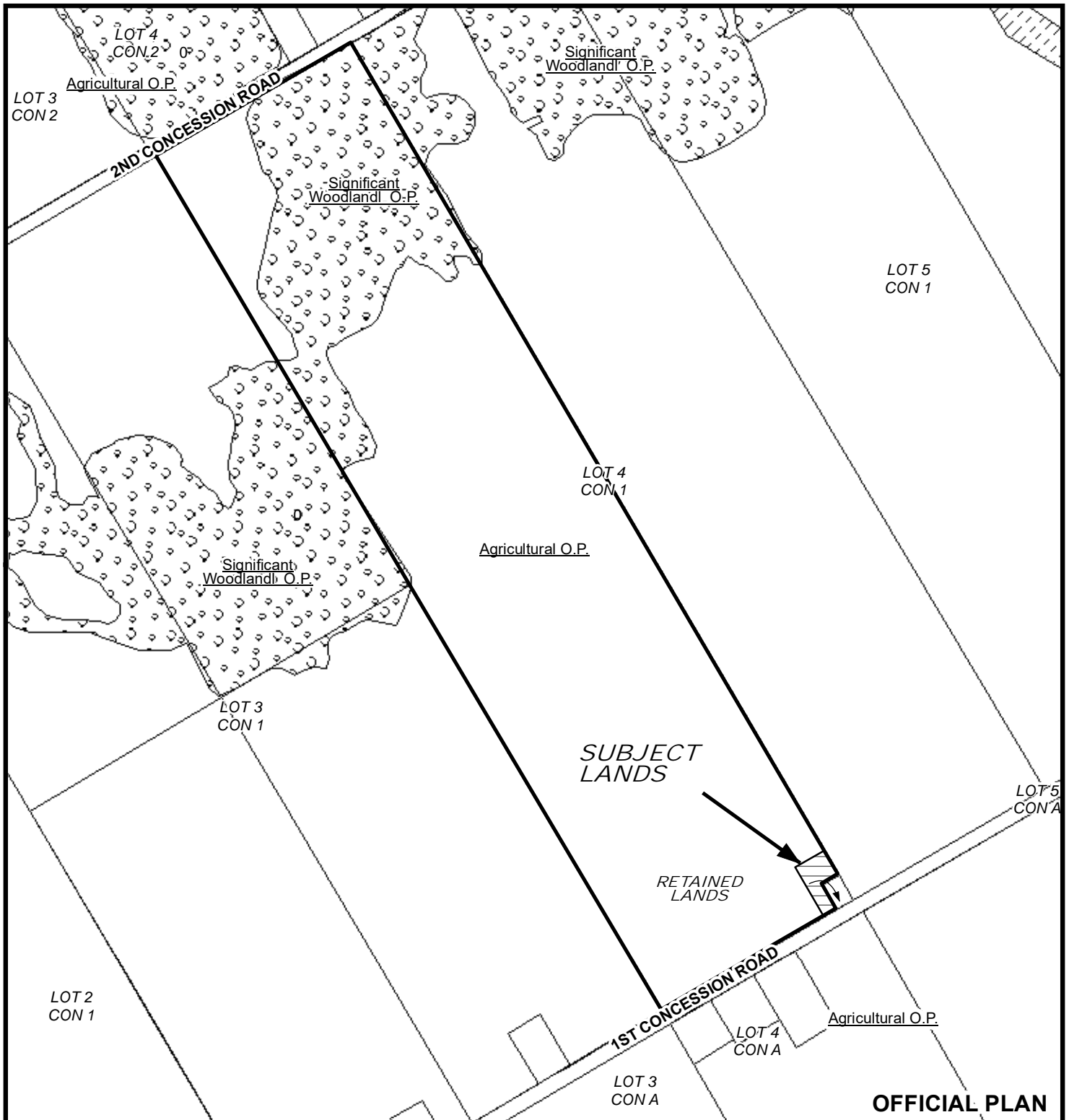

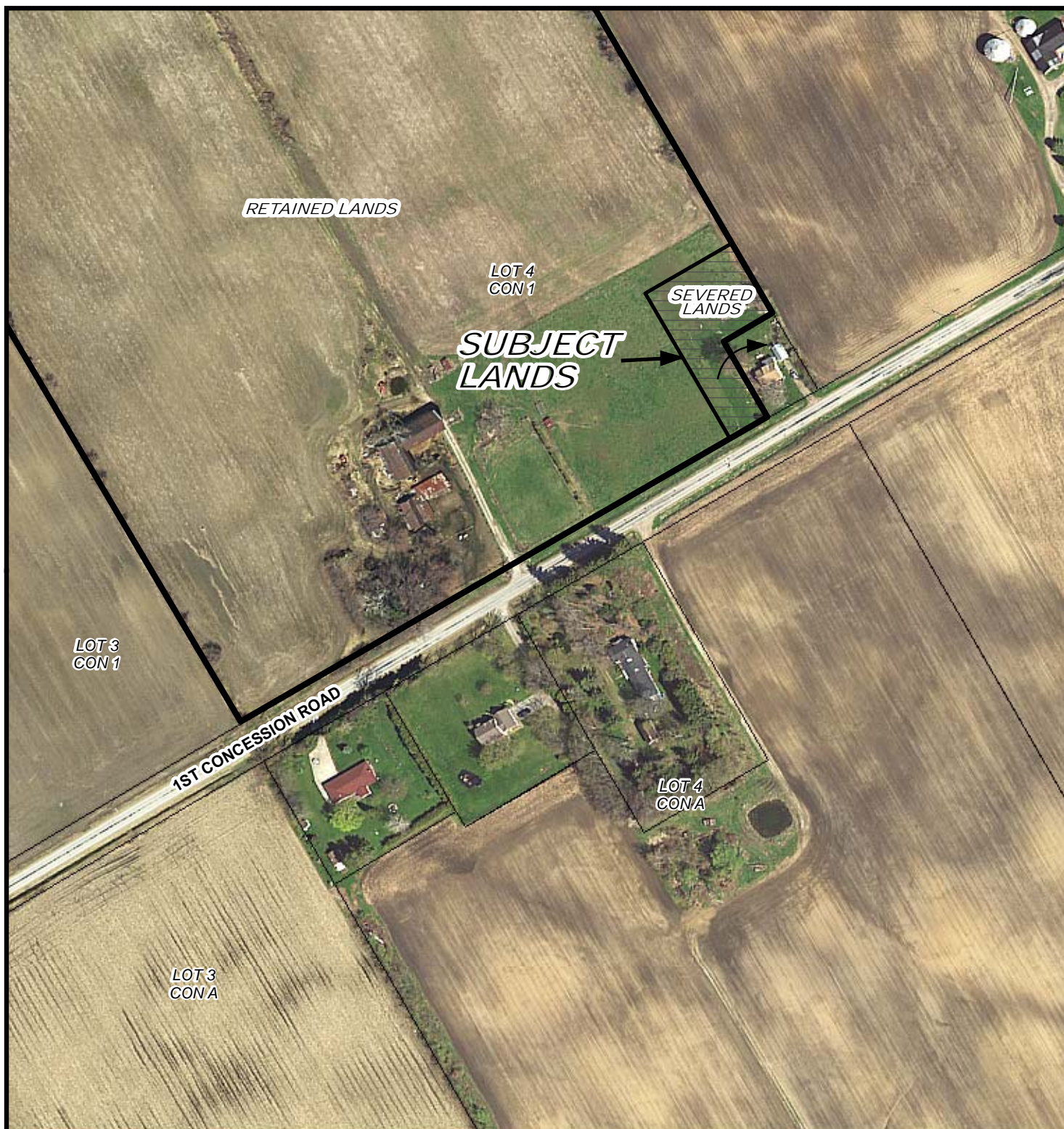
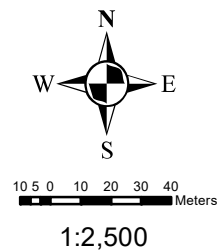
OFFICIAL PLAN

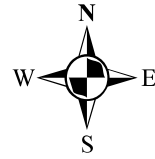

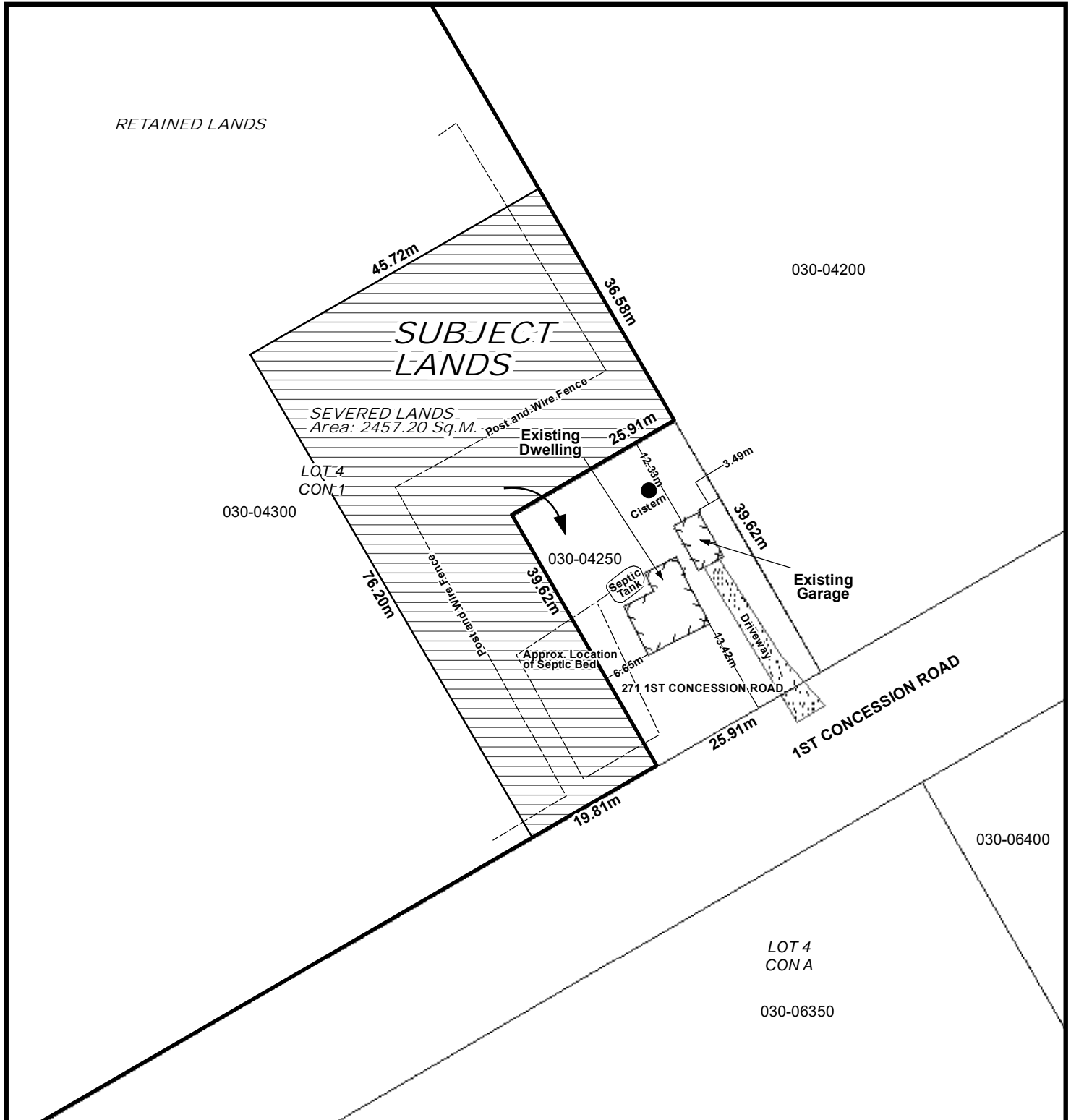

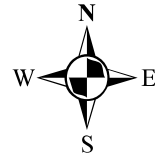




# LOCATION OF LANDS AFFECTED
