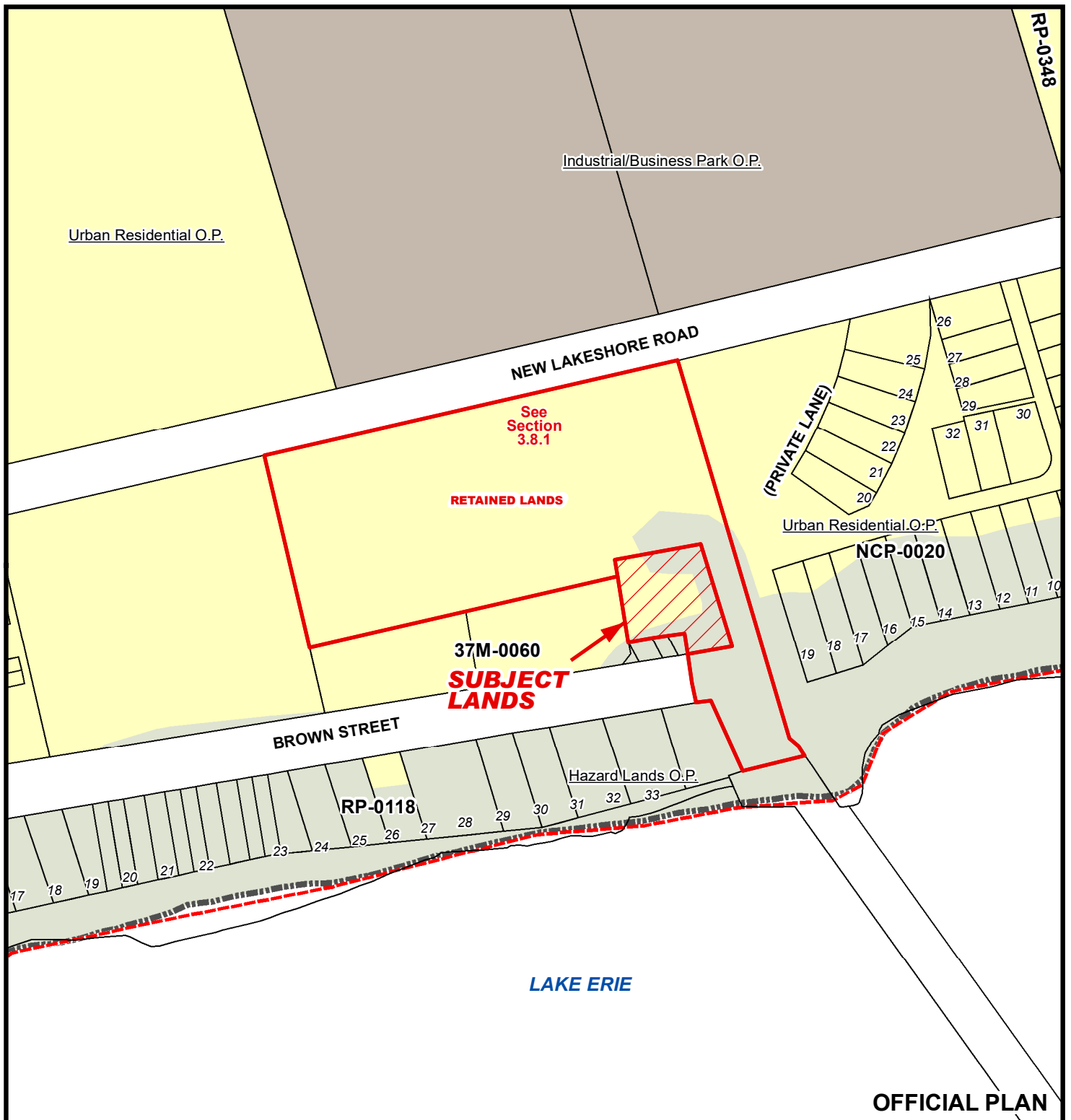
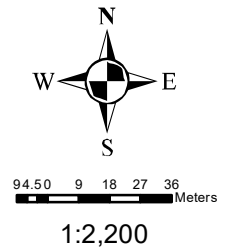
Urban Area of

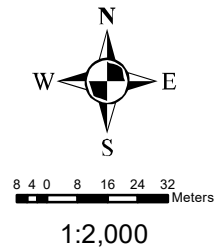

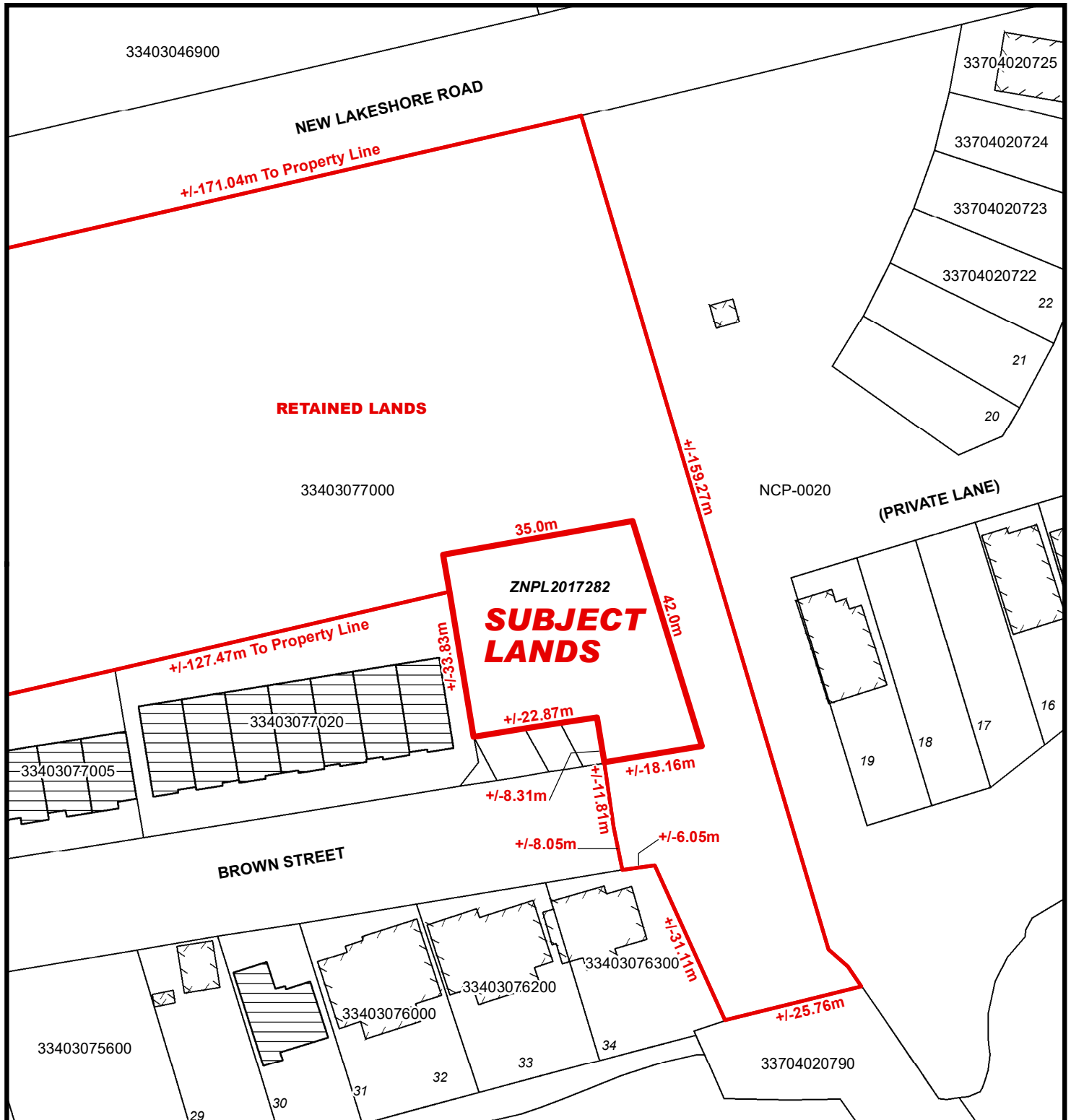
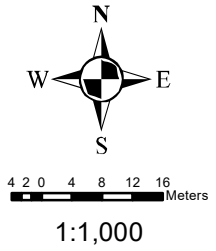
