Urban Area of WATERFORD



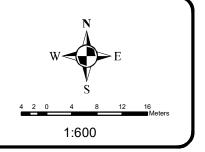


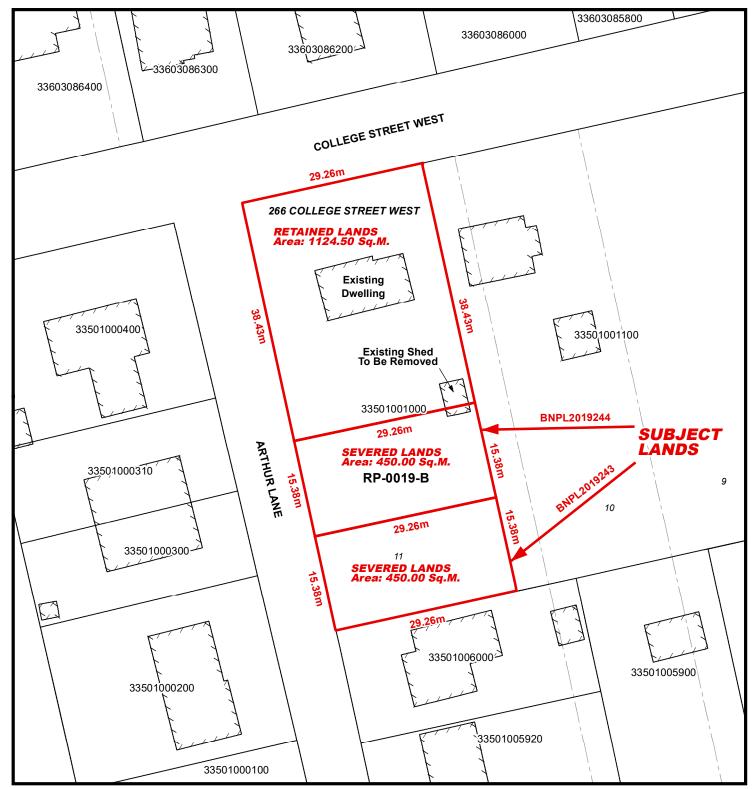
