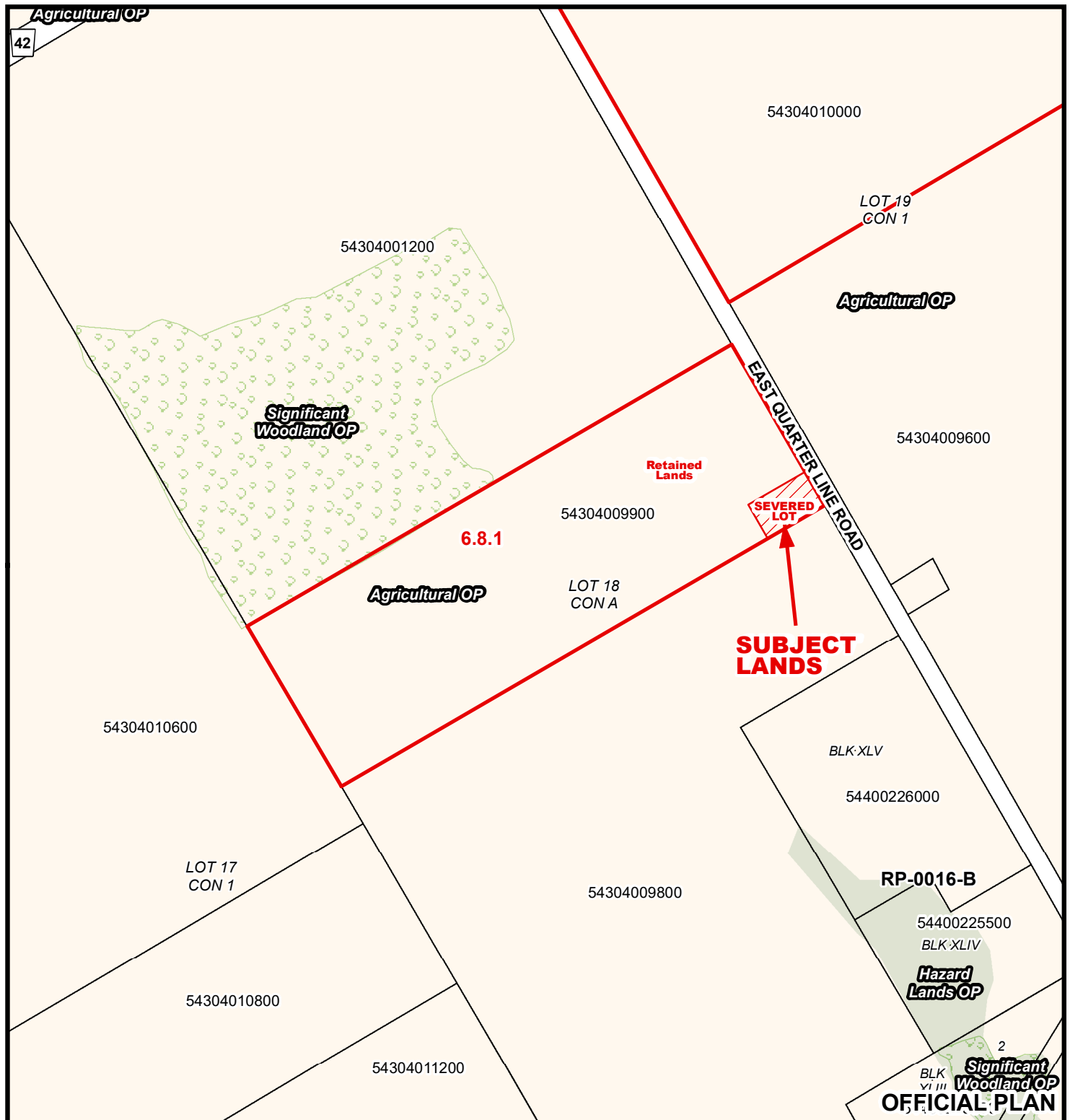
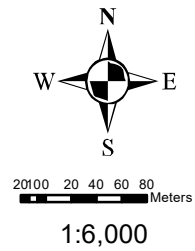
MAP 1

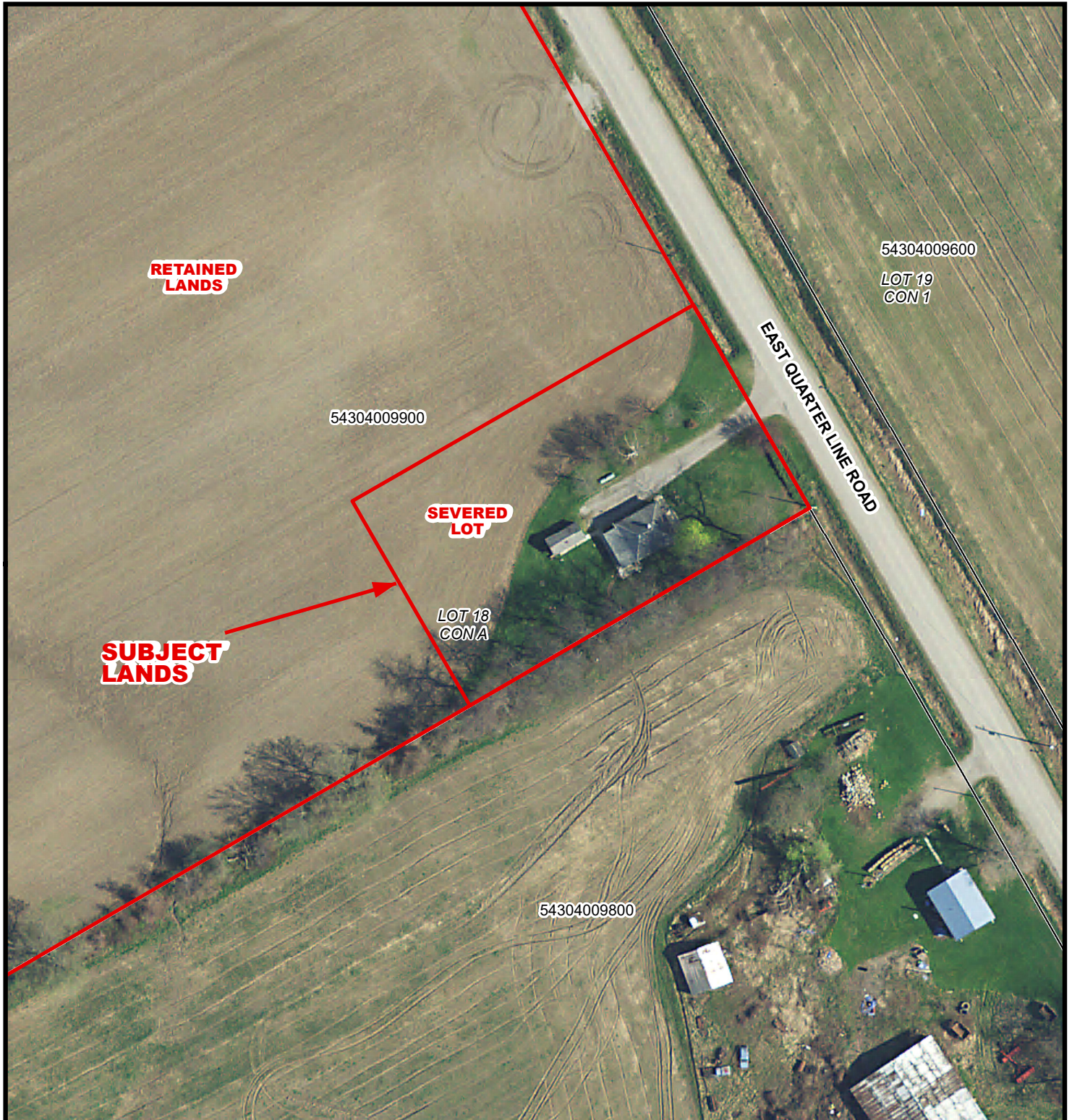
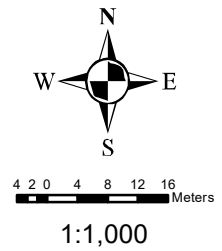

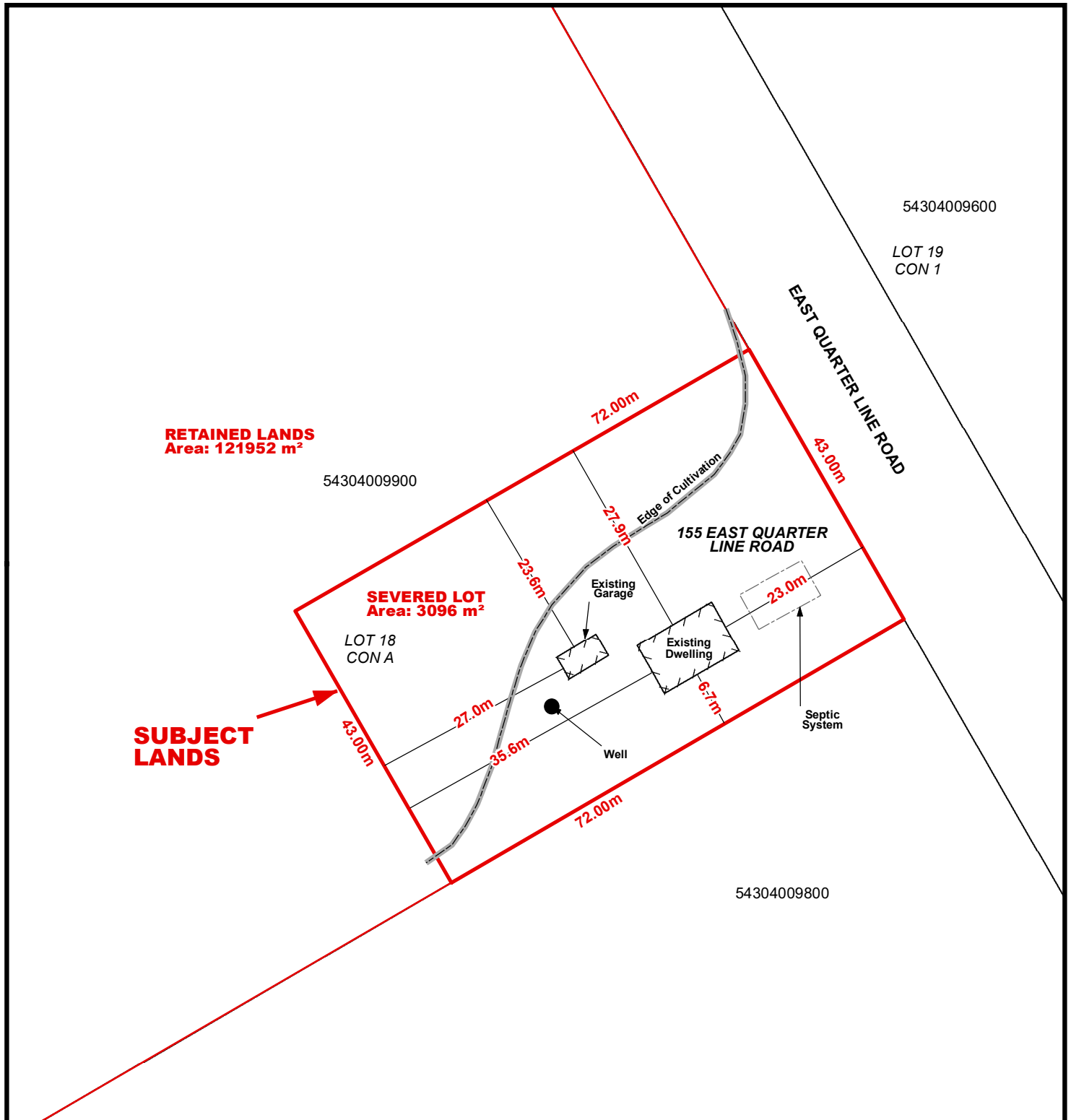
