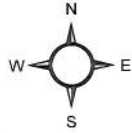

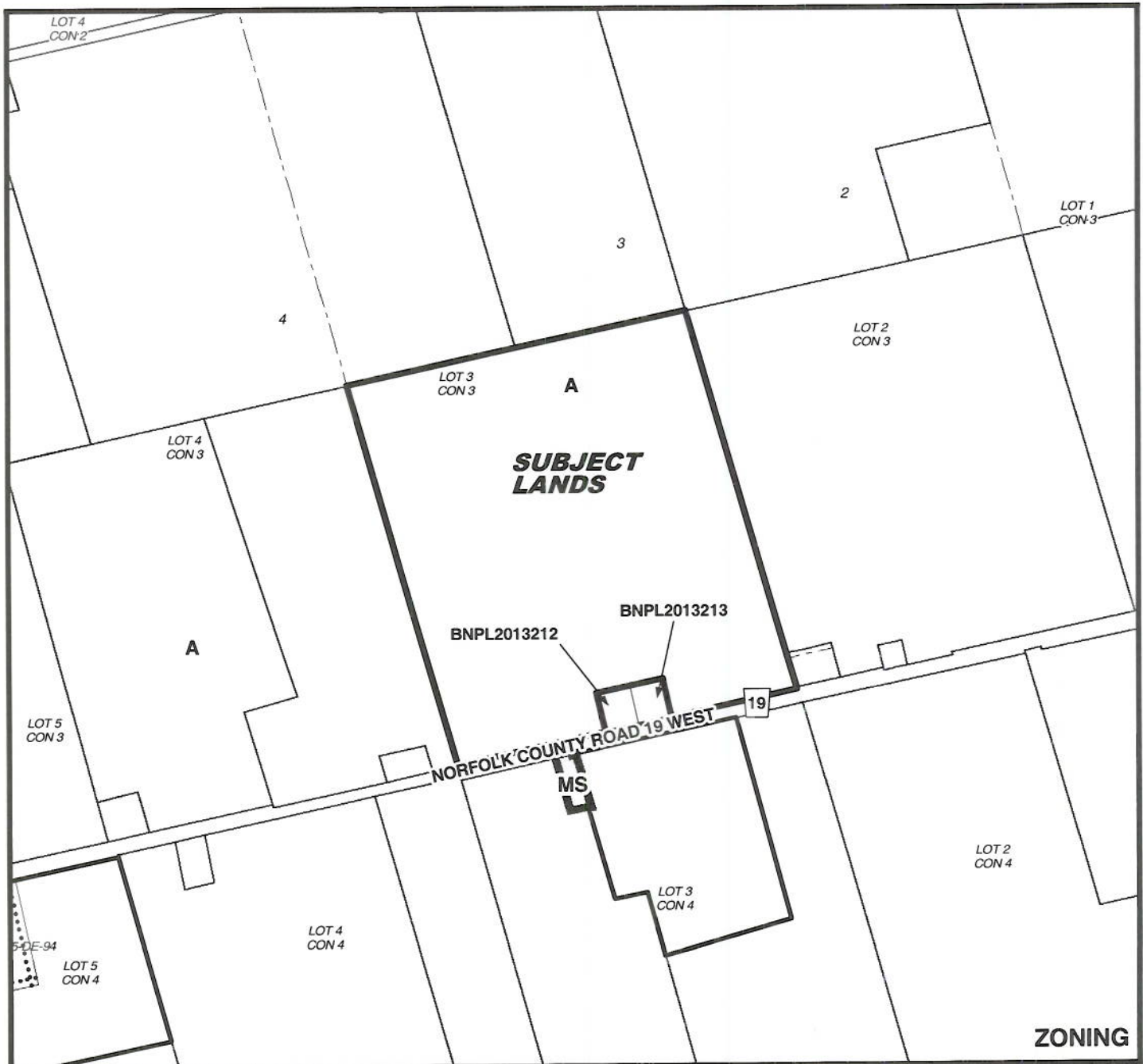

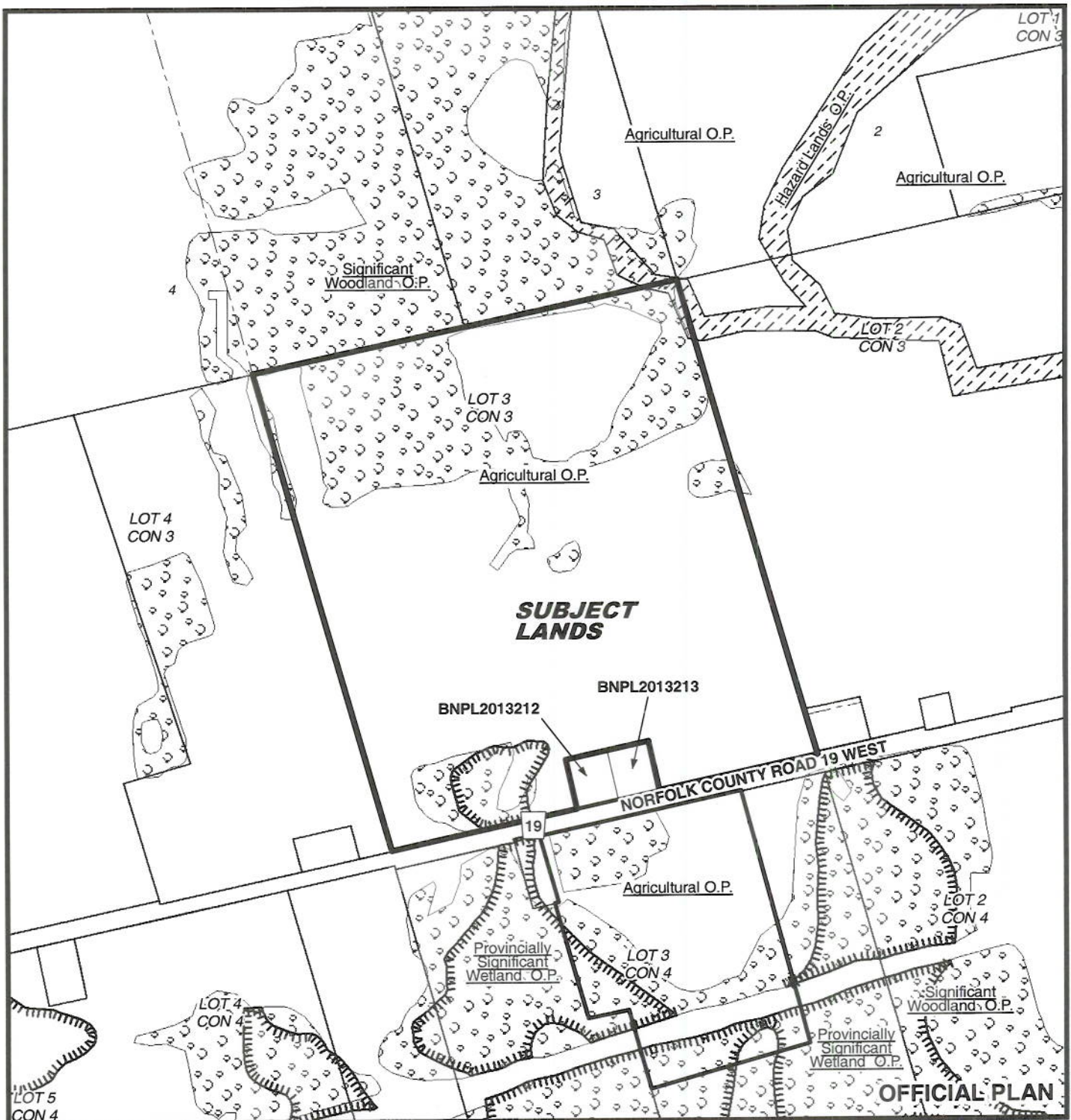

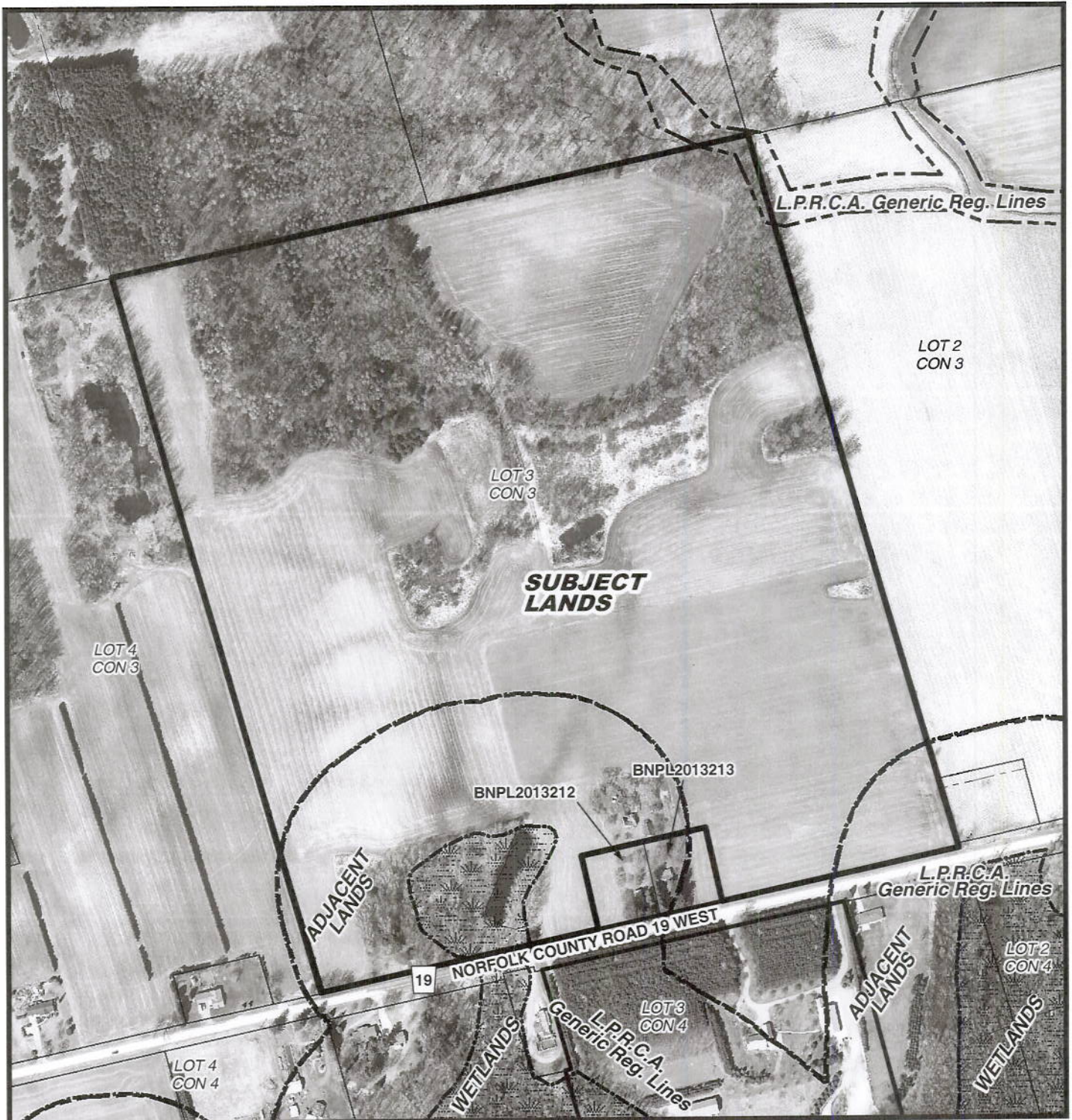
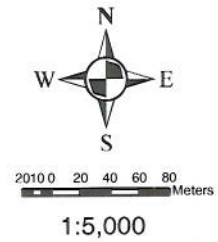
OFFICIAL PLAN
