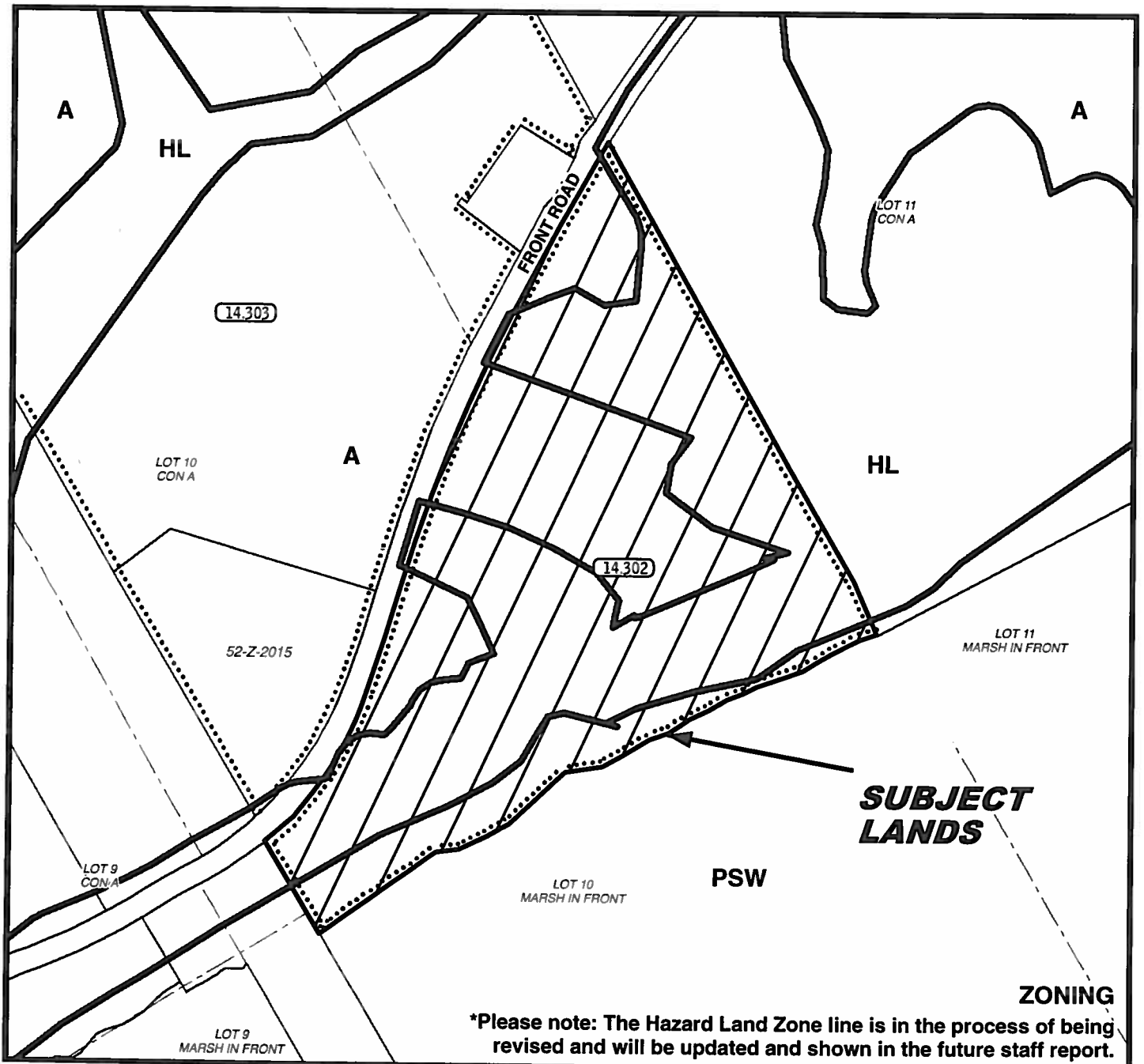
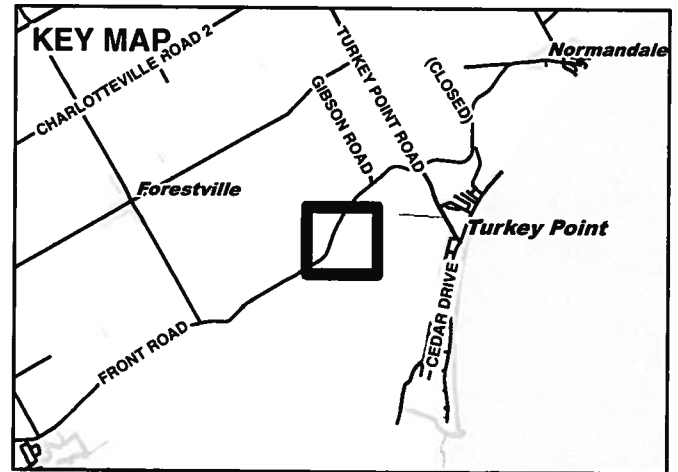
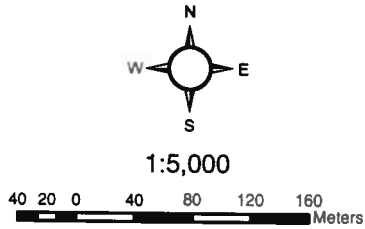

MAP 2

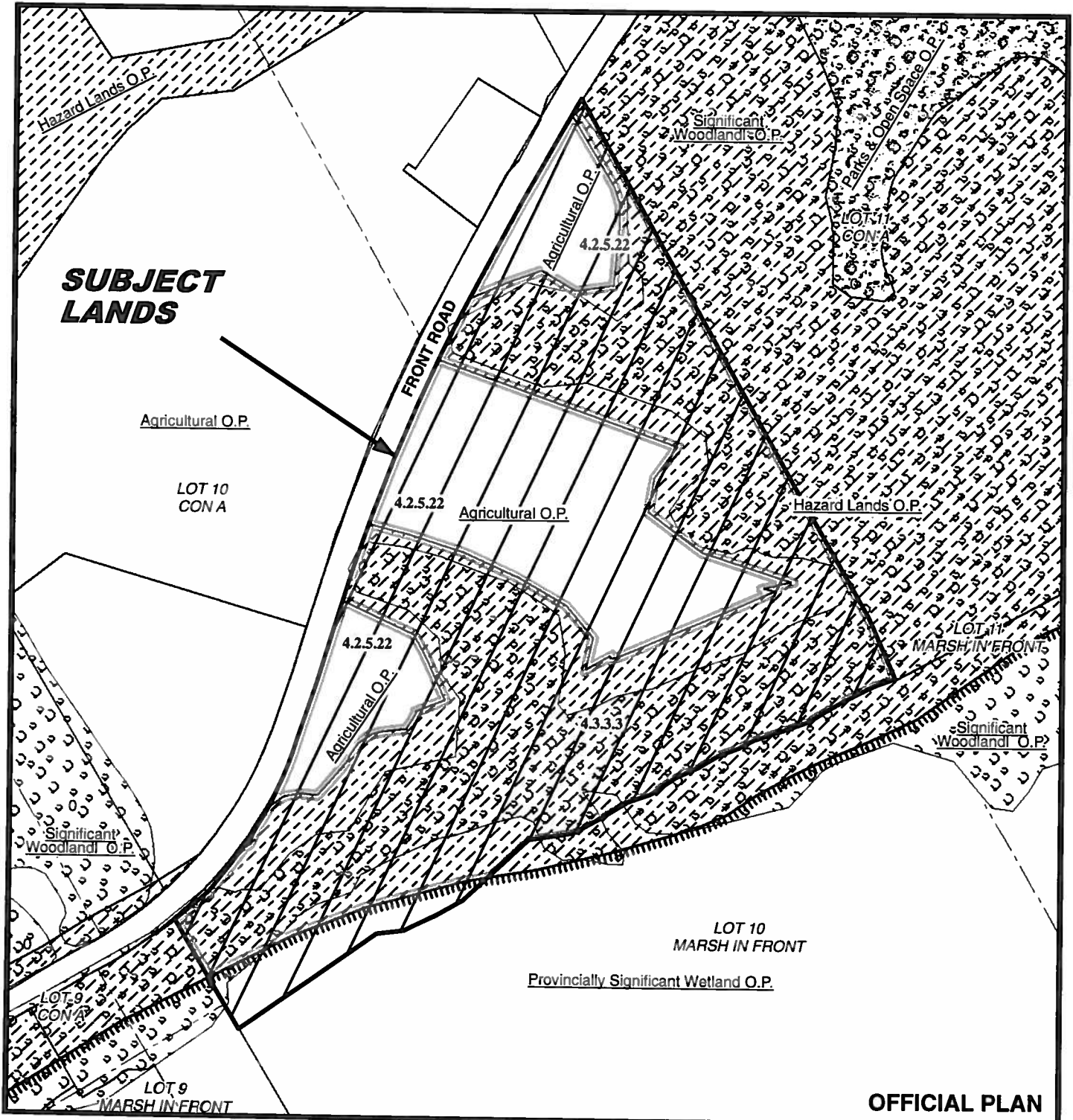

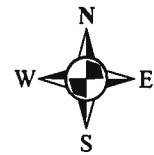

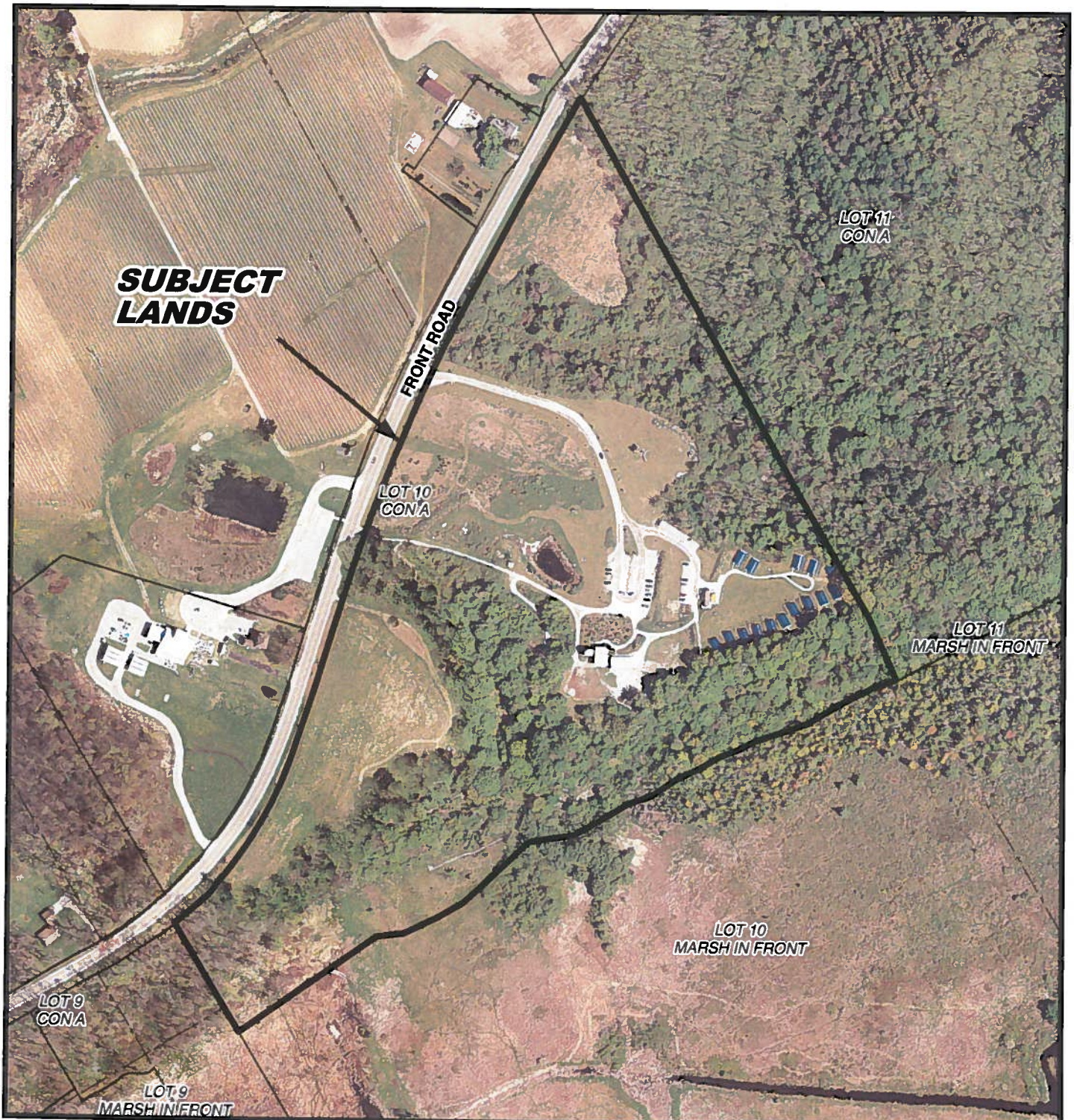

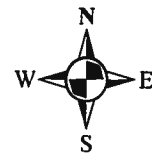
