

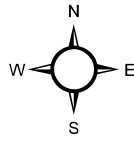

MAP 1

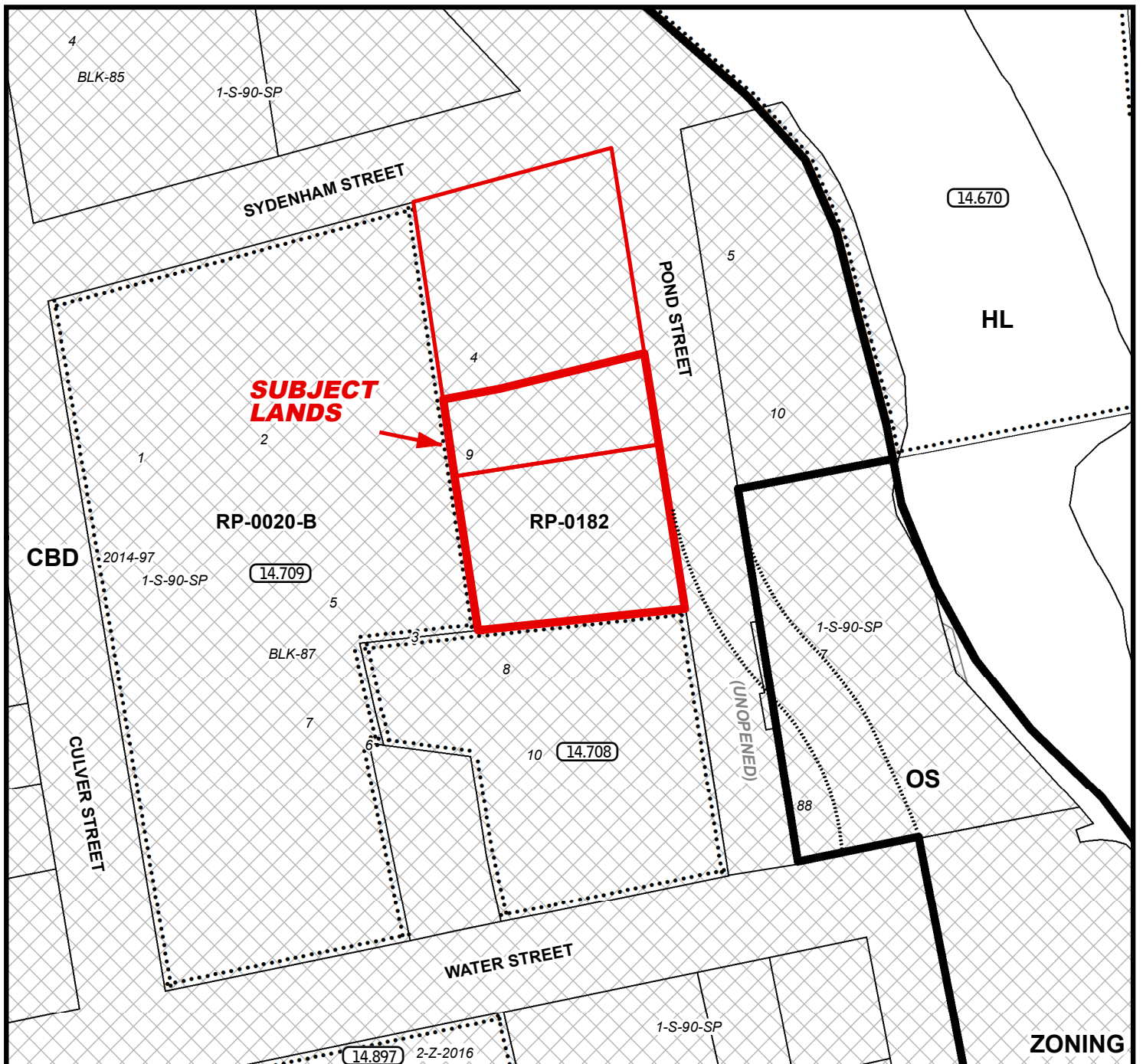
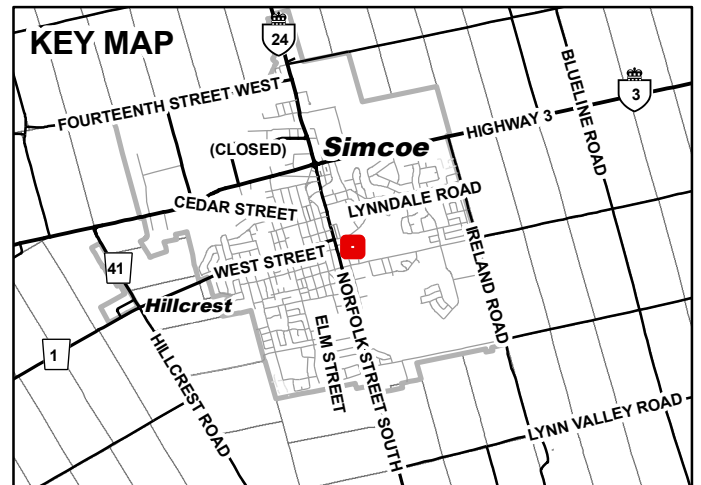

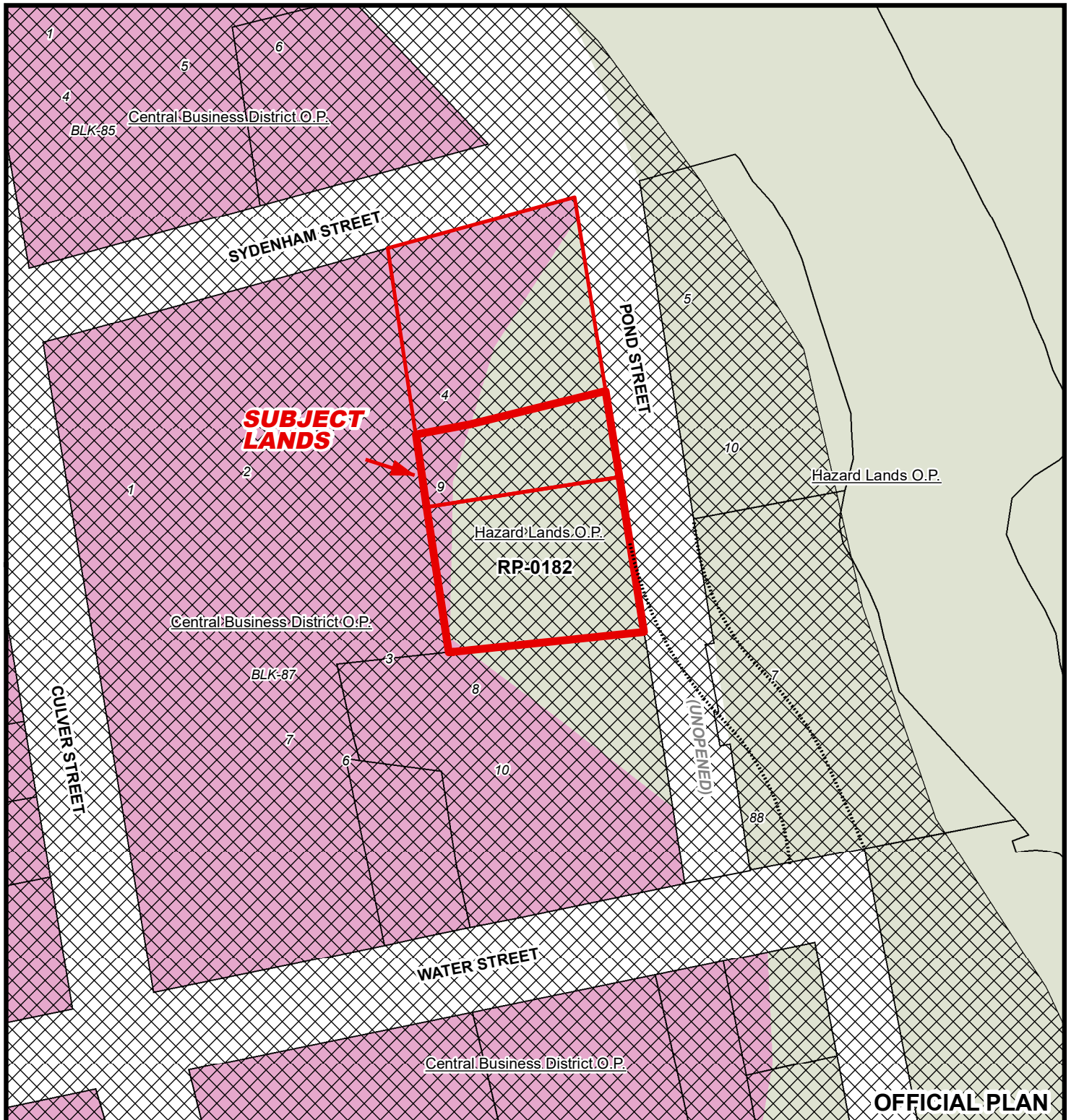

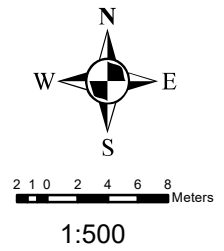
