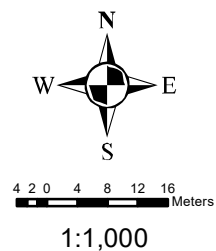

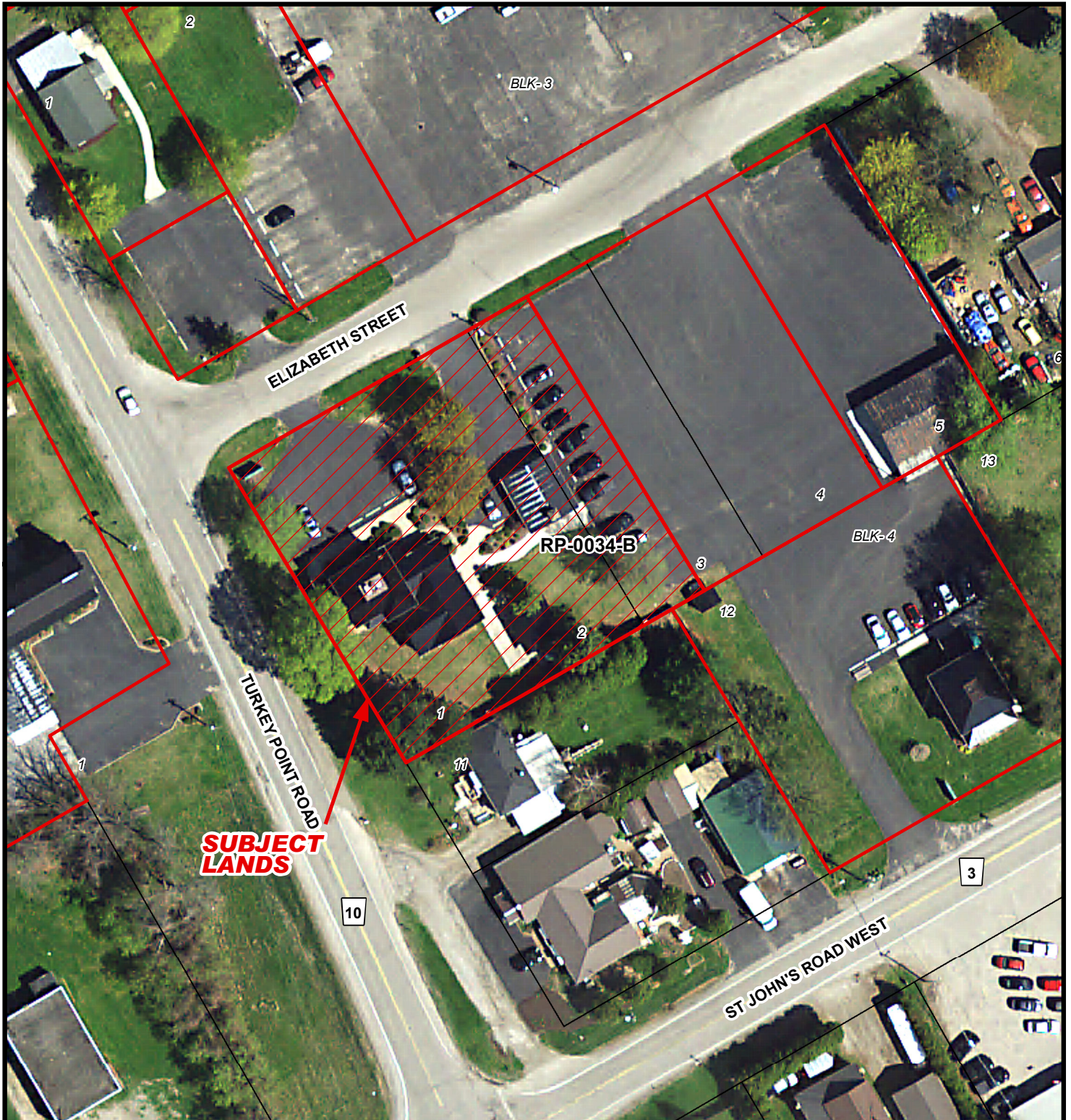
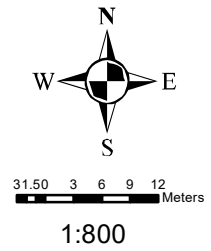
OFFICIAL PLAN
